Amendment To and Extension of Lease Agreement

This Amendment to and Extension of Lease Agreement, made and entered into at Milwaukee, Wisconsin as of this ______day of ________, 2015, by and between Kinder Morgan/Milwaukee Bulk Terminals, Inc., a Wisconsin Corporation, (hereinafter referred to as the "Tenant"), and the City of Milwaukee, a Wisconsin municipal corporation, by and through its Board of Harbor Commissioners (hereinafter collectively referred to as the "City").

Whereas, the City and the Tenant have entered into a Lease Agreement dated November 1, 2013 (hereinafter referred to as the "Lease Agreement") for the lease of approximately 8.610 acres located on the South Harbor Tract including Terminals 4 and 4A, consisting of approximately 104,000 square feet (hereinafter referred to as the "Property") and;

Whereas the Lease Agreement provided for a term of seven (7) years commencing November 1, 2013 and terminating December 31, 2020; and

Whereas the City and Tenant have agreed to extend the term of the Lease Agreement as further specified in this Amendment to and Extension of Lease Agreement.

Now, Therefore, in consideration of the mutual covenants and conditions set forth herein, the City and the Tenant agree to amend the Lease Agreement dated November 1, 2013, as follows:

1. Term.

- A) An initial term ("Initial Term") expiring on December 31, 2023.
- B) An Extension Term ("Extension Term") for a period of five (5) years, commencing on January 1, 2024, and ending on December 31, 2028. The Extension Term shall take effect immediately upon expiration of the Initial Term, unless Tenant shall deliver to the City a written notice of termination of this Amendment to and Extension of Lease Agreement at least six months prior to the expiration date of the Initial Term as specified in subparagraph (a) above.
- C) Except as otherwise provided for in this Amendment to and Extension of Lease Agreement, all other terms and conditions of the Lease Agreement dated November 1, 2013 shall remain unchanged and continue in full force and effect.
