AMENDMENT NO. 1 TO THE OUT-OF-PROGRAM AGREEMENT BETWEEN THE CITY OF MILWAUKEE AND THE HERITAGE LAND COMPANY FOR THE HERITAGE WOODS ADDITION NO. 1 SUBDIVISION

THIS FIRST AMENDMENT, entered into by and between the City of Milwaukee, a municipal corporation, (hereinafter referred to as the "City") and the Heritage Land Company (hereinafter referred to as the "Developer").

<u>WITNESSETH</u>

Whereas, The Developer intends to develop a residential subdivision in the area generally north of West Green Tree Road at North 113th Court in the city of Milwaukee; and

Whereas, The Common Council of the City of Milwaukee has previously approved an Out-of-Program Agreement for the project (File No. 991415 approved January 18, 2000); and

Whereas, This Agreement outlines the design, funding and construction responsibilities of the City and the Developer regarding installation of the subdivisions's public improvements; and

Whereas, The Agreement provides that the Developer shall pay 100% of the public improvement costs; and

Whereas, The Developer has requested that he be allowed to let public improvement construction contracts in conjunction with other contracts he is already managing in the area; and

Whereas, The City's DBE and Resident Hiring provisions would be incorporated into any Developer let contracts; and

Whereas, It is likely that privately let contracts could save money thereby allowing for lower cost lots for development;

Now, Therefore, It is agreed by and between the City and the Developer to amend the Out-of-Program Agreement referenced herein by adding the following paragraph 14:

14. Construction Option

Upon mutual concurrence of Developer and the Commissioner of Public Works, Developer may let and administer construction contracts for the public improvements

covered by this Agreement. In the event the Developer manages the public improvements contracts, City shall perform its normal inspections during the

course

of construction. In addition, Developer agrees to comply with and

administer, on

DBE and	behalf of the City, all applicable City rules and requirements pertaining to
	local resident involvement in the construction contracts. Developer shall not authorize any changes in improvement plans without the prior approval of
the	Commissioner of Public Works. All payments to contractors must be pre
approved	by the Commissioner.
