Dear Mr. Rentas:

This office is in receipt of your claim in the amount of \$2,440.95, relating to damage sustained to your vehicle allegedly by a City snowplow on December 28, 2000 at 931 East Russell Avenue.

The Fleet Accident Report completed as a result of this alleged incident notes that the investigator sent by the fleet division noted the damage on your vehicle is not consistent with plow damage. Additionally, your witness and you, were unable to furnish a truck number or other specific information with regard to the snowplow that allegedly struck your vehicle. Since there is no evidence to support your belief that a City vehicle caused the damage, the City cannot accept liability. Accordingly, we are denying your claim.

I you wish to appeal this decision, you may do so by sending a letter within 21days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
