This office is in receipt of your claim in the amount of \$5,250.00, relating to damage sustained to your building sometime between December 11, 2000 and January 23, 2001 when it was allegedly hit by a City truck during snow removal at 920 North 28th Street.

Our investigation reveals that the Fleet Division has no records relative to the damage to your building allegedly caused by an equipment operator working for or on behalf of the City. Since no operator has reported colliding with your building, and you are unable to provide any information with respect to the equipment identification or license number, we are unable to verify that equipment working for or on behalf of the City was involved. As such, the City cannot accept liability. Accordingly, we are denying your claim for damage to your building. Regarding your claim for damage to your lot, C.I. File No. 01-V-169, since information concerning this claim was confirmed, you will be receiving a separate mailing with a release for that claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
