The police officer was in the vicinity and came right away. They barricaded the hole immediately. The officer said the road was just recently opened after re-paving.


Because of the tremendous impact on my car 1991 Jeep, I had it towed to Braeger on South 27th street, to check out if ther was any other damage (see bill enclosed)
