Dear Messrs. and DeSautel and Arena:

This is to notify you that on October 16, 2001, the City's Utilities and Licenses Committee voted to recommend to the City's Common Council that your Class "B" Tavern and Tavern-related licenses for the premises located at 4177 South Howell Avenue ("Daddios") be renewed with a twenty (20) day suspension. The Committee made such a recommendation based upon the complaints of Susan Prothero, Craig Plain, Eugene Vlies, Shirley Chiaverotti, Agapito Cruz, and Janet, Gerald and Pamela Breitzman.

On October 24, 2001, you were sent a true and correct copy of the Findings of Fact, Conclusions of Law and Recommendations of the Utilities and Licenses Committee with respect to your renewal application for a Class "B" Tavern and Tavern-related licenses. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of November 6, 2001, commencing at 9:30 a.m., in the Common Council chambers, on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of your right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time and place you did appear and were represented by Attorney Andrew M. Arena, Kopp, Arena & Bishop, S.C., 1110 North Old World Third Street, Suite 515, Milwaukee, WI 53203. You had previously forwarded a letter, not objecting to the recommendation, but asking for an opportunity to respond to any complainant who filed written objections or spoke to the Common Council. There was one complainant, Mr. Craig Plain, one of the complainants, who appeared and requested revocation of this Class "B" Tavern license instead of a twenty (20) day suspension.

Following consideration of the report of the Utilities and Licenses Committee and the arguments of Mr. Plain and Mr. Arena, Alderman Pawlinski moved to amend the Committee recommendation from a twenty (20) day suspension to revocation. The Common Council adopted the amendment proffered by Alderman Pawlinski by a vote of twelve (12) Ayes and five (5) Noes. Also by a vote of twelve (12) Ayes and five (5) Noes, the Common Council voted to revoke your Class "B" Tavern and all tavern-related licenses.

You must cease all operations at 4177 South Howell Avenue in the City and County of Milwaukee, Wisconsin ("Daddios"), for which Class "B" Tavern and Tavern-related licenses are required upon service of this notice.
