The neighborhood is again bombarded with problems from Mike and his bar. Because I am away for many weekends at this time I have just a few incidents to report. However I do talk with the neighbors and there are a lot of problems here.

These are the things that I have personally witnessed or dealt with.

4/1 Trash and 2 beer bottles (1 broken) on the corner of 1st and Plainfield 4/11 VERY loud music/2 cars parked on Plainfield both in same direction, going west, motors running. People came from Daddios got into cars and sped away,after lots of yelling. Time 2:00 AM

4/12 Large amount of trash on Plainfield and 1st St.

4/14 Trash in street

4/15 Trash and beer bottles

5/13 12:00 AM Car doors slamming, yelling, in front of my house (woke me)

2:25 Same

3:00 Same

6/15 Friday night and Saturday morning: Over 1 hour of yelling, creaming,

screeching of tires.

2:30 AM All hell broke loose! Parked cars on 1st street with radios blasting, foul language, yelling. Called Mike and he said that he had been outside to check on things. There is no way that he was checking on things. He did not have security that night. I asked.

I called police at 2:30 AM and Mike at 2:45 AM

It was one of the worst nights in a couple of years that I have experienced.

7/6

Awakened by loud music from parked car on first street and a car alarm going off on Plainfield. Called police at 12:30AM There was the car alarm going off for almost 10 minutes, yelling, slamming of car doors, a couple of cars screeching up and down the street (looking for parking places)? and finally on top of all this someone was setting off firecrackers.

I was on hold with the non emergency police # and after about 5-10 min things settled down while I was waiting. I talked to a dispatcher #86 and she informed me that if nothing really bad was happening at that very moment she could not dispatch a car. She suggested calling my alderman and talking to someone at the police dept during the day.

The next morning when my young roommate went out he said there was an empty

12 pack in the street.

7/20 I came home at 12:15 AM. I was being dropped off by a friend on a

motorcycle.

We came down Plainfield from Howell (going west). We tried to turn north on 1st street but could not because of cars and people in the intersections. My friend (a very Christian man asked them to please move. There were some obscenities shouted, one car parked so close to the corner that it actually was sticking into the street. My friend politely explained that they would get a ticket and a young man yelled that he probably only wanted to park the bike there. I explained that I lived several doors north and was being dropped off. I also asked them to please quiet down and that did not end up well. The next morning early, I took my camera out and took pictures of the

trash in the streets. Mike has said in the past that he goes around the block to pick up but of course this is not true.

The people in this area work very hard to maintain their homes and yards and everyone is trying to keep the neighbor safe and clean. As long as Mike DeSautel own Daddios the neighborhood around his bar will go downhill.

Music season has begun again at Dinero's bar, 4177 South Howell Ave. and our nice, quiet, clean neighborhood isn't so nice anymore. It has become what it was before the band season ended in the spring. The bands are so loud they can be heard for a block, the streets become littered with glass and trash left behind by people parking for blocks around the area. There is no parking for neighbors after 9:00 or 10:00 PM.

I know that when I lay my head on my pillow on Friday and Saturday nights I will be awakened at bar closing time by fights, arguments, slamming car doors, screeching tires, and people who choose to hold long and loud conversations in front of my house. When I awaken and ask them to be quiet or leave I'm usually answered by foul language.

Quite a few of my neighbors have seen people urinating in yards or near trees. I saw this on my own street and called police on May 8, 1999, at 12:15 AM.

Most of the people who live near Dineros have lived here many years. We did not buy our houses near this bar, this bar was allowed to operated near us. By allowing this bar to operate in our neighborhood it has brought strangers here who do not respect it, trash, noise, and safety issues. The police department has been called many times but we're not sure if and when they respond.

I speak not only for myself, but for my neighbors in asking you to deny renewal of Dineros' license.

continue to remain open as a liquor licensed establishment.

Through my continued effort to keep you informed of neighborhood events, I am writing my final letter regarding the license renewal of Dinero's, located at 4177 S. Howell Ave.

On Tuesday, April 11, the Common Council unanimously endorsed the Committee's recommendation to strip Dinero's of their live music license. However, Dinero's current license does not expire until May 11, 2000, therefore, the establishment may conduct live music events up to this date. Once the new license is enacted on May 12, Dinero's can remain open as a liquor licensed establishment.

As with all Milwaukee bars and restaurants who do not have live music licenses, Dinero's is eligible to apply for ten permits per year granting them one night of live music. However, approval must be obtained by the local Alderman. At this point I have no intention of approving any of these permits, however, the owner of Dinero's, Mike DeSautel, holds the right to apply for them. If presented with these proposals I plan to evaluate each on a case by case basis and remain extremely cautious about approving any of them in the future.

As Chairman of the Utilities and Licenses Committee, which hears and recommends license requests to the Common Council, I will not even schedule a hearing on this issue.

I have called you many times regarding Daddio's, the loud music, litter around his property,

and the bad habits of his customers. This goes on and on and on every weekend. There was

a time he had security on the corner of Plainfield and First Street. Security, as we understood,

was to keep Mike's customers from parking in front of our houses - First Street to the north

from Plainfield. One weekend the traffic was so bad my husband went to the Security person

and was told that he had no directives to keep the cars off our street.

It is bad enough that

we have to put up with this every weekend but now we have the loud music on Tuesday and

Thursday nights also. Last night the music was cranked up at 12:30 AM. We could hear it

even with our air conditioning on.

Just for example-: April 7th, April 14th and April 21 I have marked on the calendar as nights

that were impossible to sleep - usually from 11 PM until 2:45 AM. The music is unbearably

loud and the noise from the patrons is impossible to sleep with. There was the most obnoxious

language being used and there were guys peeing on our neighbors lawns.

May 4th there were cars parked in front of our house. At 1:30 AM these woman were holding a conversation across the street from each other which woke us up. $\,\mathrm{I}$

called out to them to please go away. At 2:00 AM there were a bunch of women getting in

their cars using the worst possible language. At 3:30 there were still some women leaving.

Now, I ask you, what time is that bar suppose to be closed???

On May5th - we had another incident with lots of traffic parked up and down our street.

The music was terribly loud. When we finally did go to sleep a horn woke us up. It was

a truck parked in front of our house - I turned on our porch light so the truck moved up

the street two houses. My husband went out to get the license plate number then he

shined a flashlight in the cab and the couple were having sex. I know that truck belonged

to people from Daddio's because they parked here along with all the other vehicles at the

I haven't kept track of all the dates or the specific things that have happened but none of

this is fair to the residents of this street. Mike told me we should have done some research

before buying this house almost 2 years ago. Well - I think he should have done some

research into the kind of business he should put in this neighborhood. Even though what

his patrons do is off of his property he is still the one selling them the liquor that makes them

such bad people. I have spent many sleepless nights thinking of ways to have a better life

here in this house. Maybe we should go to a motel every weekend and send Mike the bill.

Maybe we should get a lawyer and sue him. Maybe we should just give up and sell this

house. We can't even keep our windows open at night because of all of the above. We tried

so hard to make this a beautiful house and yard so that it would be an asset to the neighborhood.

This house was failing apart when we bought it - the yard was junk. It is so pretty now we really

Most of these people leaving Mike's bar are intoxicated - but they still get in their cars, qun

their engines, drive away and hopefully don't kill someone. We lived at 4525 South 5th Street for over 30 years. Now we are at 4156 South First. This was always a good neighborhood but Daddio's is really running it down. See you Monday at the library. Janet Breitzman

Dear Mr. Schrimpf:

We want you to know a little bit about our background. We previously lived at 4525 South 5th Street for 29 years. We have raised two children. Our son Chuck is a full time Senior Master Sargent in the Air National Guard 128th Refueling. Our daughter Pamela is a 4th grade teacher at the Bruce Guadalupe Community School.

May of 1992 my husband retired from his job as a truck driver. In 1994 we decided to sell our home so that we could travel full time. We sold our home, bought an RV and spent fives years traveling. During that time we spent much time volunteering in State Parks in Texas and Wisconsin. Spring of 1999 we decided to once again settle down. We looked at apartments, condos and houses. In late summer of 1999 we saw the house at 4156 South First Street. The house was in very bad shape but since this was almost in our old neighborhood and we were familiar with Howell Avenue, Firstar Bank, Library, Sentry Store, Hardware Store, Avenue Liquor Store and what once was Blue Jay Bowling we thought it would be fun to do some remodeling we put in an offer of \$70,000.00.

We became owners of the house on September 1, 1999. We put on a new roof, new siding, cleaned up the front and back of the house. We had a new piece of sidewalk put in for the mailman. We built a small retaining wall along our driveway. We recoated the driveway and painted the garage. We planted flowers and grass seed. We put all new windows in the house. This house that once was poor, ugly, left to ruin is now a house of beauty. All the neighbors thank us for the improvements to their neighborhood. The inside isn't quite finished but it is coming along. It is a house that shows it is loved. We've all put in many, many hours working on this house including our son and grandchildren. As to this date we have put approximately \$40,000.00 into our house above and beyond what we paid for it. We had hoped to finish out our lives here.

From the time we moved into the house there has been trouble with Mr. Desautel's bar. There has been loud music, much traffic, screaming and hollering by the patrons of the bar screeching tires as they come and go, urinating on the lawns, fights, girls screaming, drunks leaving in their cars (trying to drive) and litter. Mr. Desautel said many times that he would correct the problems (and did so for maybe a week or two at a time) but then it would go right back to the same old problems. Late October 2000 Mr. Desautel and his attorney came around to talk individually with the neighbors. At that time I was still feeling like we should give him the benefit of the doubt – give him a chance. I don't like to see people lose their livelihood. We were offered \$25.00 per week to not complain. We did not accept this offer. He (Mr. Desautel) then suggested that we should have checked out the neighborhood more thoroughly before we bought this house. Mr. Desautel also stated that he was NOT responsible for his customers once they left his

establishment. He further stated that the street in front of our house is public property and we could not keep his customers from parking there.

In March of 2000 I had a mild heart attack. I cannot handle all this trouble at night — I need my sleep in order to keep myself healthy. The angina problem I have seems to intensify with each incident concerning Daddio's. We have decided that if nothing can be done about Daddio's we will then sell this house — finished or not. We will take the loss and somewhere outside of the city of Milwaukee. We would find a quiet place where Jerry and I can live out the rest of our lives in peace away from the city.

I feel that Mr. DeSautel should have checked out this neighborhood before he bought his business. He told everyone he was going to have a restaurant with a jazz band or something to that effect. He never told the neighbors that he was going to have the kind of business he has. I understand the bowling alley was no problem - - Now we have problems every Thursday, Friday and Saturday sometimes even Wednesday nights. The problems all start around 11 PM and go on to 2:30-3:00 AM. The dates I have on the complaint are not the only dates of problems but just a few that I actually wrote down. If I had kept better tract of things I would have a notebook full of complaints.

Dear neighbors & Business's:

Late last fall I contacted the neighbors in the area concerning my license. At that time I had the opportunity to speak to several residents of the neighborhood. I was left with a feeling of encouragement that some people believe I should be able to have live music at Daddios. I would like to thank those of you for supporting us, and taking your time to stop by and give us your extra support. For those of you who would like the live music back may attend the hearing, it will be held very soon. We will offer rides to and from this hearing.

I attended the neighborhood block party in September 2000 where I had an opportunity to meet some of you. I have been a resident of the 13th District for 33 years, and to this day I live in the 13th District. I Went to Burdick grade school and Bay View high School until I graduated in 1981. I bowled in leagues at Blue Jay lanes in the 70's 80's and 90's. At that time bowling was huge. Now it's down over 50% in the past ten years. Blue Jay lanes was a very busy place and very loud, with no parking lot whatsoever. The patrons parked anywhere they could within a 4-block radius. In the last ten years Blue Jay purchased the lot where a house was once located on the Southwest corner of Howell and Plainfield. In May 1996 I purchased the bowling center and operated it for 3 seasons. Since bowling was so depressed, I had to make a big business decision and change the whole building into what it is today, an entertainment facility with a small restaurant. People really do appreciate this newly improved \$500,000 building, restored inside and out, Along with our nice landscaping.

We understand that some people may try to abuse the neighborhood. That's why we working hard and have contracted with the Metropolitan Public Safety agency. Their duties are to keep any nuisance out of our neighborhood. In the past couple of weeks there have been some troubled kids running around the neighborhood spraying graffiti on our sign and making some loud noise late at night. Our security chased them away. I believe, and some of our neighbors agree, that we have been trying real hard to keep our neighborhood safe and clean. January 2001, I joined a committee on the Howell Avenue Business Association. You may see me picking up liter around the neighborhood quite often.

Since Howell Avenue is our main thoroughfare, we need to keep it clean. My intention is to stay at this location for years to come, since I lived here all my life. The only time I get answers is through Sarah, who is a very nice and sincere assistant. If this is such a big concern, then I think the Alderman should work things out. All I hear from a certain person is some negative things about me and how I do not show any concern about this neighborhood. I have improved my establishment a great deal.

Everyday I personally go through the neighborhood and pick up garbage whether it's mine or not. We would like our neighbors to join us for an open door neighborhood meeting on Sunday March 18th 2001 @ 2:00pm to discuss any of your concerns and get your input in keeping our facility safe and neighborhood friendly. If you can't make it, please call the Aldermen's office and let them know what a nice job we are doing. 414-286-2221. Please make sure you write the date you called for future reference.

We would like our full License back, so we may have two or three events a month (Live music) at a smaller scale. The meeting shall be to discuss the neighborhoods feeling regarding this request. My staff and I have been very well educated this past year, on who and what goes on in this neighborhood, the letter that was sent out to everyone was not meant to be on a negative note about the Alderman. It's was to show people that my establishment was not a very big concern of his since there have not been any problems in our neighborhood. The Alderman can't spend his whole career on my establishment. And that certain person knows whom that person is that is calling the Police department for under age drinking when that person does not patronize my establishment. I believe this person is just out to close us down. I have had a cabaret license for five years and when the bowling alley was here there was a dance floor with DJ's. The people that you phurased the house from were regular customers of ours and still are. The person that invited me to the "block party" in September 2000 told me that's how he got the permit to do so. I knew nothing about a double birthday party and why would the City of Milwaukee give anyone a permit for a double birthday? I even offered to donate a half-barrel to this "block party". I know you did not ask me to snow blow but that's the king of person I really am. I have been a very successful businessman for 10 years and have a lot of good influence in the business community. I have donated my time and effort and money to Special Olympics, Children's hospital and lots more! I have business relations with CEO's of many fortune 500 companies including GE medial systems. If you would just give me the opportunity to talk with you rather than turning your head ever time you see me, you may fine out that I'm not the bad person and operator you make me out to be. Please note I called the Alderman's office and offered my service to anyone in the 13th district that needed to be shoveled out during the bad winter storms. Dear Alderman Pawlinski,

I would like to thank you for your prompt response to the e-mail that my husband, Kevin Wetrich, sent to you yesterday. While my husband expressed much of what our family has experienced as a result of the events that began at Daddio's this past weekend, I feel compelled to add my own thoughts.

As I write this e-mail, I am sitting on the couch in my living room at 121 W Plainfield Avenue. Had I been sitting on this spot in the early hours of Sunday, September 30, I would have had loaded guns pointed at people approximately 20 feet behind me. This is very disturbing considering that there would have been only the glass of windows separating me from any potential bullets that missed their targets. Fortunately my family and I were all sleeping soundly as the events of that morning transpired, thus keeping us from the direct line of fire. Unfortunately, I cannot find comfort in the fact that we were able to sleep through all that occurred. I now feel as though I have to be on alert to protect my children throughout the night. This heightened state of awareness prevents me from getting the quality of rest to which I am entitled.

In the hours that have passed since my neighbors informed me of the events that disrupted our neighborhood on Sunday morning, I have evaluated my feelings in terms of the roles that I fulfill as mother, homeowner, and educator. As a mother, I am deeply concerned for the safety of my sons, aged 2 1/2 years and 3 months. The mere thought of loaded guns within such close proximity of my sons fills me with a fear that is equaled by none that I have ever experienced. It is indescribable.

As an educator, I have spent most of my career working with inner-city children in Houston, Texas and at Phillis Wheatley Elementary in Milwaukee. Many of my former students, simply because of where they live, have grown up with violence as a part of their everyday lives. I will never forget the look on my students' faces after a night of sleeping on the floor out of fear that bullets would find their way into their homes. Because I know the effect that this type of environment has on children, I will not allow my children to live in such an environment. If Daddio's continues to be a catalyst for violence in my neighborhood, I will voice my feelings as a homeowner by leaving the first home my husband and I have owned.

I appreciate all that you have done to ensure the safety of my neighbors and my family. My husband and I will support those efforts by attending any hearing that is set to determine the fate of Daddio's.
