#### **OPTION 1**

All companies participating as exhibitors in the 2002 Leasing Mall are entitled to free Leasing Mall staff badges as part of the space rental fee based on the following formula:

- ©One (1) free badge for every 100 square feet of leased space rounding to the nearest hundred [i.e., a company leasing 680 square feet would be allowed seven (7) free Leasing Mall staff badges]. A minimum of four (4) free badges will be provided even if less than 400 square feet of space is leased.
- Allocation of Leasing Mall staff badges will be based upon the amount of square feet your company occupied in the 2001 Leasing Mall. Where differences occur between square footage occupied and amount actually assigned, badge entitlement will be adjusted accordingly.



#### Hotel Preference

Reservation requests will only be accepted on the attached Hotel Reservation Form and must be in writing. If you prefer, you may make your reservation via the internet at www.icsc.org. Saturday arrivals are limited in Las Vegas. You must be registered for the 2002 ICSC Spring Convention to secure a room at a discounted rate.

#### Deadline

Hotel reservation requests must be received by DePrez Travel Bureau, Inc. in writing no later than April 12, 2002. If you have not done so by this date, your request will be processed on an availability basis.

#### Deposits

All reservation requests must be accompanied by a valid credit card (card must expire after May 2002) or a check in the amount of \$220 (per room). 
