AMENDMENT TO CHARTER SCHOOL CONTRACT BETWEEN THE CITY OF MILWAUKEE AND CENTRAL CITY CYBERSCHOOL OF MILWAUKEE, INC.

WHEREAS, The City of Milwaukee, acting by its Common Council ("City") and Central City Cyberschool of Milwaukee, Inc. ("Charter School") entered into a 5-year Charter School Contract on March 30, 1999; and

WHEREAS, The Charter School Contract provides that Charter School shall serve pupils in grades 1 through 8; and

WHEREAS, The Charter School has requested that the Charter School Contract be amended to allow Charter School to also serve pupils in grade K-5; and

WHEREAS, The Charter School Review Committee ("CSRC") on March 26, 2002 voted to recommend that the Charter School Contract be amended to allow Charter School to serve pupils in K-5; and

WHEREAS, The Common Council on May 14, 2002 approved the recommendation of the CSRC and directed the appropriate city officials to execute an amendment to the Charter School Contract between City and Charter School to incorporate the recommendation of the CSRC; and

THEREFORE, The 5-year Charter School Contract between the City and Charter School that was entered into on March 30, 1999 is hereby amended to state as follows:

Notwithstanding any other provision in this Charter School Contract, Charter School shall be permitted to provide educational services to pupils in grades K-5 through $8^{\rm th}$ grade.
