ACCIDENT STATEMENT ON ACCIDENT OF NOVEMBER 5, 1999

SGT. GAETHKE: THE FOLLOWING IS A STATEMENT PER YOUR REQUEST.

AT ABOUT 11:45 PM I WAS LEAVING THE SOUTH PARKING LOT AT POTAWATOMI CASINO AND AS I TURNED RIGHT IN THE RIGHT LANE HEADING EAST ON PITTSBURG I CAME FACE TO FACE WITH A SEMI-TRUCK STANDING IN MY LANE OF TRAFFIC FACING WEST. I COULD NOT SEE THE SEMI FROM THE STOP SIGN BECAUSE THE CONTRUCTION TRAILERS ARE PARKED TO CLOSE TO THE CURB OF THE STREET AND THE STOP SIGN IS STANDING FURTHER BACK THEN THE TRAILERS.

I STOPPED MY CAR ABOUT 3 TO 5 FEET IN FRONT OF THE SEMI CAB AND MOVE TO THE LEFT TRYING TO SEE IF I COULD GO AROUND THE TRUCK. I COULD NOT BECAUSE THERE WAS ANOTHER SEMI TRUCK PARKED BEHIND THE ONE BLOCKING TRAFFIC IN MY LANE ALSO FACING WEST. THERE WAS ALSO THE CASINO GREEN EMPLOYEE TRANSPORT VAN PARKED IN THE RIGHT LANE AND THERE WAS NO ROOM FOR ME TO GET THROUGH. I LOOKED LEFT AND THERE WAS A SEMI STANDING AT THE PECK MEAT PACKING GATE AT THE END OF THE STREET READY TO DEPART FACING EAST. SO I DECIDED TO BACK MY CAR OUT OF THE WAY AND GO BACK INTO THE LOW. I COULD NOT GO EAST BECAUSE IT IS A DEAD END STREET AND THE ENTRANCE TO PECK IS AT THAT END. AS I WAS BACKING UP I WAS HIT BY THE FIRST SEMI IN THE RIGHT FRONT FENDER AND PUSHED SOME 15 FEET SIDEWAYS BACK TO MY ORIGINAL STARTING POINT; THE ENTRANCE OF THE PARKING LOT.

AFTER I WAS STRUCK THE CASINO EMPLOYEE TRANSPORT VAN PASSED US DRIVING IN THE RIGHT LANE HEADING EAST. CAROL HOWE WAS IN THE VAN AND SHE SAW THE SEMI'S PARKED IN THE LEFT LANE FACING WEST BEFORE AND AFTER THE ACCIDENT.

THE SEMI TRUCKS WERE ILLEGALLY PARKED AS THERE ARE NO PARKING SIGNS ON BOTH SIDES FO THE STREET (S.S. 346.54 (a) STATES VEHICLES MUST BE PARKED PARALLEL TO EDGE OF STREET HEADED IN THE DIRECTION OF TRAFFIC ON THE RIGHT SIDE OF THE STREET. ONCE THE SEMO STARTED MOVING HE WAS DRIVING INATTENTIVELY BECAUSE HE DID NOT SEE MY VEHICLE IN FRONT OF HIS AND HE WAS OPERATING HIS TRUCK TO THE LEFT OF THE CENTER ROADWAY: (CENTER IS CLEAR BECAUSE OF THE CONCRETE SEAM, S.S. 346.05).

Chief Jones:

I need help in regards to an accident which happened on November 4, 1999 and I am the victim.

The enclosed diagram represents where vehicles were and where contact was made. The officer on the scene must have misundertood. The situation according to the original repot and diagram looks like I was at fault. This error is costing me a lot of Money for medical bills, the car rental, and the deductible. I am on a limited income.

I came to a stop at the stop sign leaving the parking lot. Due to the construction trailers parked, I could not see the Semi's parked to the right. I made my right hand turn to go East on Pittsburg and came face to face with a semi standing in my lane of traffic. I was going to go around them, but there was a Potawatomi transport van parked blocking the other side of the road way. All I could do was back up. As I started backing up looking out the rear of my vehicle, I felt a jolt. The semi had struck my vehicle and was pushing me. The semi that struck my vehicle (along with 2 other semi's) were standing on Pittsburg street illegally parked on the wrong side of the street where NO PARKING signs are posted.. (S.S. 346.54 (a) states vehicle must be parked parallel to edge of street headed in the direction of traffic on the right side of the street). Once he started moving he was driving inattentively because he didn't see my vehicle in front of his and he was operating his vehicle to the left of the center of the roadway: (Center is clear because of the concrete seam, S.S. 346.05).

The supplement made by the officer is still not clear. Too, I've enclosed 3 witness letters and a picture of the area.

Please have someone contact me regarding this matter. I appreciate your concern.
