Dear Ms. Kelly-Kidd:

This office is in receipt of your claim in the amount of \$3,355.59, relating to damages sustained to your vehicle on January 31, 2002 when a City of Milwaukee plow vehicle allegedly struck said vehicle at 2370 North Grant Boulevard.

The Fleet Accident Report that was completed as a result of this incident noted, the snow plow drivers assigned to this route on the date and time in question deny striking your vehicle. Since you are unable to provide a truck number the City is unable to investigate this claim further. Therefore, in the absence of proof to the contrary, the City must take credence in the testimony of the plow driver and not accept liability. Accordingly, we are denying your claim.
