2	CHAIRMAN PAWLINSKI: I'm passing the
3	gavel. And I will move for reconsideration of
4	the matter to hold, the matter for Peggy Mata,
5	Agent for "Cancun." Alderman.
6	VICE-CHAIRMAN HERRON: There's a motion
7	for reconsideration. Is there any objection to
8	that motion? Hearing none, so ordered. We are
9	now on the matter of "Cancun." Let's see if we
10	can find that in our books. I know it's in here,
11	but it's going to be quite challenging to find.
12	While we're doing that, why don't we
13	swear in the applicant and the Alderman.
14	MR. SCHRIMPF: Do you sol Do you
15	both solemnly swear that the testimony you are
16	about to give shall be the truth, the whole
17	truth, and nothing but the truth, so help you
18	God?
19	ALDERMAN PAWLINSKI: I do.
20	THE APPLICANT: I do.
21	VICE-CHAIRMAN HERRON: And, this is
22	going to take me one second to find this, if you
23	don't mind. And you are Peggy Mata?
24	THE APPLICANT: Yes.
25	VICE-CHAIRMAN HERRON: All right.

1	Well, we're start with and you Did you
2	receive the notice that this meeting was going to
3	be held and that your license may be denied due
4	to police report, neighborhood objections, to the
5	licensing of this premises, loitering after
6	closing hours, loud and rowdy patrons, booming
7	and loud car stereos, and loud music from inside
8	the premises. Did you receive that notice?
9	THE APPLICANT: No, I didn't. That's
10	why I'm late. They must have misplaced the
11	letter or something.
12	VICE-CHAIRMAN HERRON: Mr. Schrimpf?
13	THE APPLICANT: Because, you know,
14	that's why I'm late, because I didn't know I had
15	this meeting today, and I had an appointment.
16	MR. SCHRIMPF: Mr. Chairman, therefore,
17	I have some questions for the applicant.
18	VICE-CHAIRMAN HERRON: Go ahead.
19	MR. SCHRIMPF: Okay. Thank you. Ms.
20	Mata, do you currently reside at I'm sorry.
21	Yes. Do you currently reside at 1602 South 53rd
22	Street?
23	THE APPLICANT: No, I moved in May.
24	May 1st.
25	MR. SCHRIMPF: Pardon me?

21	MR. SCHRIMPF: And that is 3334 South
22	27th Street?

24	MR. SCHRIMPF: Milwaukee, Wisconsin?
25	THE APPLICANT: Yes.

00005 1 MR. SCHRIMPF: Mr. Chairman, I have a 2 couple of questions for Mr. Copeland. 3 VICE-CHAIRMAN HERRON: Go ahead, Mr. 4 Schrimpf. 5 MR. SCHRIMPF: When was notice of this 6 hearing sent out? 7 MR. COPELAND: May 15th, 2002. MR. SCHRIMPF: And it was sent to what 8 9 address, sir? 10 MR. COPELAND: 1602 South 53rd Street, 11 Milwaukee - - Excuse me - - West Milwaukee, 12 Wisconsin 53214. 13 MR. SCHRIMPF: And was that the last 14 known address that the License Division had on 15 file for Ms. Peggy A. Mata? MR. COPELAND: Yes, it was. MR. SCHRIMPF: And was any application 16 17 18 or any notification submitted to the License 19 Division of a change of address? 20 MR. COPELAND: It was not. MR. SCHRIMPF: Okay. Mr. Chairman, 21 22 under the circumstances I believe that the - -23 Oh. Was the notice returned to the License 24 Division by the United States Postal Service? 25 MR. COPELAND: It was not.

00006 1 MR. SCHRIMPF: Ms. Mata, I have a 2 question for you. Did you have an arrangement 3 with the United States Postal Service to forward 4 your mail to your new mailing address? 5 THE APPLICANT: I haven't done that. 6 MR. SCHRIMPF: Mr. Chairman, under the 7 circumstances, it appears to me that there is an 8 ordinance that requires that all changes of 9 addresses be submitted to the License Division. 10 Obviously, I think by the witness' own testimony 11 she indicated that she did not comply with that 12 particular requirement of the ordinances. 13 Therefore, although this is - - this is a 14 situation where she did not get the notice, I 15 don't believe the notice is the fault of the - -16 of the City of Milwaukee or the License Division 17 or the committee. 18 VICE-CHAIRMAN HERRON: Just a quick - -19 When does this license expire? 20 ALDERMAN PAWLINSKI: June 19th. 21 VICE-CHAIRMAN HERRON: June 19th. And 22 will there be any other opportunities to hear 23 this matter before June 19th? 24 MR. SCHRIMPF: Mr. Copeland seems to be 25 indicating no. Is that correct?

2	ALDERMAN PAWLINSKI: Mr. Chairman, may
3	I ask a question of the applicant? I'll address
4	it to the committee. The question I would ask
5	is, if she did not receive notice of the meeting,

22	expires before we'd have a chance to have another
23	hearing. You understand by proceeding with this
24	hearing without counsel you could lose your
25	license or have it suspended. Are you I

1	assume you're ready to proceed with the hearing?
2	THE APPLICANT: Yes.
3	VICE-CHAIRMAN HERRON: Okay. Do you
4	have a question, Alderwoman Cameron?
5	ALDERWOMAN CAMERON: Just
6	clarification. It was stated that Rosa called
7	her.
8	ALDERMAN PAWLINSKI: No, it's not you.
9	ALDERWOMAN CAMERON: I just wanted to
10	make that clear.
11	ALDERMAN PAWLINSKI: I know that.

21	Rosa called you and told you to come.

23	restaurant. They called called us and told
24	me I had a meeting.
25	VICE-CHAIRMAN HERRON: I assume we're

4	VICE-CHAIRMAN HERRON: Okay. Health
5	department.
6	HEALTH DEPARTMENT: No objections.

8	services?
9	NEIGHBORHOOD SERVICES: No objections.
10	VICE-CHAIRMAN HERRON: There is a
11	police report, officer. Sergeant Hogan.
12	SERGEANT HOGAN: The following
13	incidents occurred within the last licensing
14	period.
15	On December 14th, 2001 shortly after
16	two a.m. officers responded to a fight at the
17	premises. Responding officers were told by the
18	security officer that there was no one injured
19	and no fight. Later that morning officers
20	investigated an armed robbery complaint at St.
21	Luke's Hospital. This security officer was at
22	the hospital at that time. The officers
23	interviewed three victims, all of whom were under
24	the age of 21 years. All were attacked in the
25	parking lot of the Cancun Restaurant. The

1	security guard was at the hospital comforting one
2	of the victims. Investigation could not
3	determine if the victims were patrons of the
4	tavern or the restaurant. Officers could
5	determine Correction could not determine
6	if food was being served until nine p.m. or 11
7	p.m., due to a lack of cooperation. One
8	additional criminal complaint was filed at the
9	Sixth District regarding a car window which was
10	smashed by a beer bottle in the parking lot of
11	the restaurant during this fight. Two days after
12	this incident, a sub suspect was arrested
13	regarding the above incident.
14	On December 16th, 2001 at about 2:25
15	a.m. a detective was doing follow-up work on the
16	premises and observed two women involved in a
17	fight on the parking lot, called for some help,
18	and both these women were taken into custody.
19	On March the 15th, 2002 at about 1:30
20	a.m. officers responded to the premises regarding
21	a fight. Officers were met by the bouncer who
22	related that a fight occurred outside the bar.
23	Upon entering the premises officers observed a
24	substantial amount of broken glass, as well as
25	blood on the floor and chairs that were in

00011 1 several locations, they were strewn about. 2 Further investigation revealed that shots were 3 fired outside the tavern. Both Peggy and Pedro 4 Mata were on the scene at the time. A citation 5 was issued for disorderly premises. That is 6 pending in municipal court. 7 On March the 18th of 2001 at 2:17 a.m. 8 officers responded to the premises regarding 9 shots fired in the parking lot. Officers 10 observed a fight upon their arrival, in the 11 parking lot, between two patrons. Investigation 12 revealed that no shots had been fired at this 13 time. Both people involved in the fight were 14 issued citations. 15 Two other notes. One is that the 16 applicant still has an outstanding warrant with 17 the West Allis Police Department for contributing 18 to the delinquency of a child. And the other is 19 that based upon her statement and lack of notice, 20 that she will be getting a citation for failing 21 to notify the City Clerk of her change of 22 address. 23 MR. SCHRIMPF: Mr. Chairman, I have one 24 question of Ms. Mata. 25 VICE-CHAIRMAN HERRON: Yes, Mr.

20	have been satisfied. What has been What is
21	the rule on
22	MR. SCHRIMPF: The The
23	committee consider
24	VICE-CHAIRMAN HERRON: in this
25	instance.

SCHRIMPF: The committee has to 1 2 consider the matter before the expiration of the 3 license in such a fashion so that the committee 4 hearing and the Common Council proceedings can 5 all be completed prior to the expiration of the 6 license. 7 VICE-CHAIRMAN HERRON: Alderman Bohl, 8 do you have a question about, I assume, something 9 about - - about the process before we open this 10 matter up. 11 ALDERMAN BOHL: About the police 12 report, Mr. Chairman. The question - - The 13 question I have is we were given an addendum 14 police report with six items, and item number six has a incident date of 3/18/2001. That seems to be a duplicate of item number two, and I just 15 16 17 wanted to clarify whether or not that alleged 18 event here occurred in 2001 or 2002. If it was 19 2001, I believe it would be something that would 20 not be in the present license year. 21 SERGEANT HOGAN: This dies appears to 22 be a duplicate. 23 MR. SCHRIMPF: Mr. Chairman, now I'm confused. So it's March - - The incident of 24 25 March 18th is 2001, not 2002.

1	SERGEANT HOGAN: Correct.
2	MR. SCHRIMPF: All right. Mr.
3	Chairman, I would ask that the entire police
4	report be received into the record of the
5	proceeding.
6	VICE-CHAIRMAN HERRON: Alderwoman Cam
7	Alderwoman Cameron will move to make the
8	entire police report part of the record. Any
9	objections?
10	All right. Why don't we start with the
11	alderman of the area, Alderman Pawlinski.
12	ALDERMAN PAWLINSKI: Thank you, Mr.
13	Chairman. A couple of comments. If you recall
14	last year, although the committee has changed
15	over a little bit since last year, last year this
16	matter was before the committee because there
17	were some incidents in the police report, and we
18	brought them before the committee, did not
19	suspend the license. In fact, I, as chairman,
20	didn't even ask for a suspension, but we did
21	notify her on the record that she needed to take
22	a greater care, managerial care of what was going
23	on at the establishment. And we basically, for
24	about five minutes, lectured her on the
25	importance of watching what happens at the

establishment. You have a restaurant, and at night the restaurant changes over to more of a nightclub atmosphere, where they have a large parking lot. And clearly, some of the incidents that have been reported to you in the police report bear out in my opinion that she has not taken the advice of this committee to heart. Now, having said that, prior to last

Now, having said that, prior to last 9 year's public hearing I met with - - met with Ms. 10 Mata in my office with my legislative assistant 11 and informed her of my desire to see improvement 12 at that location. And we outlined a number of 13 parameters for her to follow. And I even wrote 14 her a follow-up letter, suggest - - suggesting to 15 her in writing, and reiterating some of the 16 things we discussed in person. And she came 17 before the committee, and I felt it was important 18 to even warn her one more time. So that was 19 three. One verbal - - one verbal, face-to-face, 20 one written, and one verbal with this whole 21 committee present.

I'm bothered by the fact that she did not take that - - that advice to heart. I'm bothered by the fact that last year at the public hearing she showed up a half hour late. Today

00016 1 she was 45 minutes late. To me, it demonstrates 2 a pattern of non - - of not being concerned or 3 not being truly attuned to the importance of what 4 goes on at that establishment and the importance 5 of maintaining her - - her livelihood and what 6 this committee can or cannot do. 7 Now, having said that, I do receive 8 phone calls from neighbors in the area about what 9 goes on at night, about the loud music, the 10 booming car stereos, the loitering, the 11 littering, the yelling between cars after hours. 12 I receive phone calls at home and I receive them 13 in my office, including E-mails. I'm bothered by 14 the police report. Clearly there doesn't seem any lack of - - of effort - - There seems to be a 15 16 lack of effort here to fully comply and cooperate 17 with the standards in the neighborhood, with my 18 office, and with what are basically the 19 parameters of having a liquor license in this 20 community. 21 Now, I think we ought to do one of two 22 things, the committee ought to do one of two 23 things. Either suspend the license for between

15 to 20 days or take away the - - the

tavern/dance application portion. I would prefer

So that's what I would ask for, Mr. Chairman, based on the police report and based on the fact that I have
7	documented evidence that there's been no effort
8	on Ms. Mata's part to cooperate with with me,
9	and we need to take some form of action.
10	Otherwise, I believe someone will get hurt.
11	VICE-CHAIRMAN HERRON: Is there anyone
12	here from the neighborhood to testify on this
13	matter? All right. Alderwoman Cameron has a
14	question, and then we'll go on and hear from Ms.
15	Mata.
16	ALDERWOMAN CAMERON: Okay. First of
17	all, I wanted to know what procedures, because
18	our normal procedures are that we wouldn't deal
19	with a an application that has a warrant on
20	it. So what Even if we do this
21	ALDERMAN BOHL: Mr. Chairman.
22	MR. SCHRIMPF: No. No.
23	ALDERWOMAN CAMERON: There is a warrant
24	in West Allis.
25	VICE-CHAIRMAN HERRON: She's asked a

00018 question of - -1 2 ALDERWOMAN CAMERON: And I'm just 3 asking - -4 VICE-CHAIRMAN HERRON: - - Attorney 5 Schrimpf. So, Attorney Schrimpf, you want to 6 respond to that. 7 MR. SCHRIMPF: Okay. First of all - -8 First of all, I - - I would note that the warrant 9 is in West Allis. 10 ALDERWOMAN CAMERON: Yes. 11 MR. SCHRIMPF: No. 22 ALDERWOMAN CAMERON: - - actions in 23 West Allis? 24 MR. SCHRIMPF: No. No. 25 ALDERWOMAN CAMERON: Okay.

00019 1 MR. SCHRIMPF: Because the actions in 2 West Allis - -ALDERWOMAN CAMERON: Um-hnh. 3 4 MR. SCHRIMPF: - - may or may not have 5 any bearing to this, and you don't know when the 6 action in West Allis is going to be concluded. 7 VICE-CHAIRMAN HERRON: So would you say 8 that the licensee's ability to operate a business 9 supersedes the warrant - -10 MR. SCHRIMPF: Yes. 11 VICE-CHAIRMAN HERRON: - - issue. 12 Okay. All right. With that we'll hear from you, 13 Ms. Mata. 14 THE APPLICANT: With the warrant, I 15 took care of that already. I went and made 16 arrangements to start payment. 17 VICE-CHAIRMAN HERRON: Do you want to 18 take - -19 THE APPLICANT: Okay. I said the 20 warrant, I already took care of that. 21 VICE-CHAIRMAN HERRON: Do you want to 22 take a moment and address the issues in the 23 police report as well as the issues laid out by 24 the alderman of the area? 25 THE APPLICANT: Okay. As far as the

00020 1 incidents, yes, they did happen. I did get more 2 security. Not everybody did their job the way 3 they were supposed to. Some of them didn't go 4 out there like they should have. I got rid of 5 some of those people. But some of the people, 6 lately there hasn't been any incidents. But we've been really strict on - - I mean, we were strict on as far as carding, but some of these 7 8 9 people have fake IDs, you know, they - -10 What I'm really looking for here, I 11 mean, I'm getting tired of this, too. I mean, 12 it's - - I never had any problems when I just had 13 a restaurant, which was fine with me. And me and 14 my husband we're thinking of - - if we could just 15 have like private parties, you know, when there's 16 like - - where they - - Nobody can just come in. 17 I mean, they have their own people, whoever they

18 invite, and that would be about it, and we would 19 close the restaurant early. If we could just 20 serve liquor for the restaurant. 21 VICE-CHAIRMAN HERRON: The alderman has 22 recommended that you, I believe, give up your tavern/dance license and go with just a tavern 23 24 license. Is that right, Alderman? 25

ALDERMAN PAWLINSKI: Well, I want to

1	make sure that I'm clear, is that I think any
2	entertainment at that location where people are
3	drawn there to dance is detrimental to the
4	health, safety and welfare in the neighborhood.
5	So when you talk about that aspect of it, I would
6	say that's that's a tavern/dance license, as
7	well as, I want some clarification where it says
8	phonograph/jukebox premise. Does that allow
9	patrons to dance to jukebox?
10	MR. COPELAND: No.
11	ALDERMAN PAWLINSKI: Okay. So So
12	the tavern/dance license is most prevalent in my
13	opinion that is the cause and the impetus of the
14	problems.
15	VICE-CHAIRMAN HERRON: Hold on. One
16	second. I assume that what you're saying is if
17	you could keep your liquor license, get rid of
18	the tavern/dance, that you wouldn't have a
19	problem with that? Is that correct?
20	THE APPLICANT: I wouldn't have a
21	problem with that. I would just like, like
22	there's
23	VICE-CHAIRMAN HERRON: There are
24	You know, there are there are the
25	opportunities for you to call the alderman on

1	special occasions and get a special permit to
2	have special parties, and I believe you can get
3	up to 12 of those a year. Is that correct?
4	ALDERWOMAN CAMERON: Ten.
5	MR. COPELAND: Ten.
6	VICE-CHAIRMAN HERRON: Ten a year.
7	Would that be satisfactory for you?
8	THE APPLICANT: Well, right now we have
9	a lot of parties booked there, like family
10	reunion things, Baptisms, I mean.
11	VICE-CHAIRMAN HERRON: Tell you what.
12	What I'll do is why don't we hold this matter
13	Why don't the two of you get together?
14	ALDERMAN PAWLINSKI: I don't
15	Alderman, I don't want to hold it. I'm sorry. I
16	don't want to hold it.
17	VICE-CHAIRMAN HERRON: No, a minute for
18	you two to talk about the issue.
19	ALDERMAN PAWLINSKI: I don't want I
20	don't want to talk I don't want I
21	honestly don't want to. I have tried and tried,
22	in my opinion, to work this cooperatively. And
23	as far as I'm concerned, I mean, there's nothing
24	more to talk about. I I'm sorry. I'm
25	willing to consider it, willing to consider the

2	be bullheaded about it, but quite frankly, my
3	patience has worn out. It just is.

22	residents to come up and testify and that Mr.
23	Chairman, yourself, has said if residents don't
24	come up to testify, then we are kind of left
25	short-handed. I'm only going by your words. And

10	practice that you have set up that right now in
11	our file we do not have enough to grant the
12	request that you requested.

22	front of the committee, and you said you would

25	VICE-CHAIRMAN HERRON: Alderman Bohl,

14	would go with that. But I just have so many
15	parties booked that I would hate to let so many
16	people down. Like I said, I would make them
17	private parties. I wouldn't just let anybody
18	walk in, just whoever they invite. And really, I
19	mean, all this happens when you see other people
20	they they see someone they don't like,
21	and it just ends up happening outside, before you
22	get out there
23	VICE-CHAIRMAN HERRON: Well, to be
24	quite honest with you, Mrs. Mata, you haven't
25	done a very effective job at telling the

23	let a lot of people in like We know who the
24	troublemakers are. We just They're not
25	allowed in there. And we are trying.

00028 1 VICE-CHAIRMAN HERRON: Is there 2 anything else you want to add before this matter 3 goes into committee? 4 THE APPLICANT: I would like one more 5 chance, if I can get it. 6 ALDERWOMAN CAMERON: Mr. Chairman, 7 before you go into committee. VICE-CHAIRMAN HERRON: Alderwoman 8 9 Cameron. 10 ALDERWOMAN CAMERON: Would - - Why - -11 I think what you're trying to say, or am I wrong 12 or right, are you saying since these incidents 13 happened have you beefed up your security? 14 THE APPLICANT: More security and 15 there's a lot of people we don't let in there 16 that used to come in. 17 ALDERWOMAN CAMERON: Are you - - Are 18 you doing, for example, the people that you used 19 to let in, you don't let in anymore. Do - - Are 20 you having someone at the door to check, card, 21 you know, card your residents that - -22 THE APPLICANT: Oh, yeah. 23 ALDERWOMAN CAMERON: - - I mean, your 24 customers. 25 THE APPLICANT: Yes, they do.

2	security person at the door when they come in?
3	THE APPLICANT: I have three security
4	people out there.

6	did some set some security message in place

9	ALDERWOMAN CAMERON: That's what, you
10	know, we want to hear, what are you doing to

16	then. I mean, like I said, we've got more
17	security, and they're really strict at the door,
18	and they know who to let in and who not to let

22	it. I don't want to lose my license. You know,
23	people can't respect my place.
24	VICE-CHAIRMAN HERRON: All right.

14	before us is the tavern portion, not the
15	tavern/dance portion. That was not noticed.
16	ALDERMAN BOHL: Mr. Chair.
17	VICE-CHAIRMAN HERRON: Which means we
18	won't be able to I don't
19	ALDERMAN BOHL: Point of clarification.
20	VICE-CHAIRMAN HERRON: And
21	assume – – Let me just make sure I'm correct
22	here. I assume then that we can't take any
23	action on that license.
24	MR. SCHRIMPF: That is correct.
25	VICE-CHAIRMAN HERRON: And the only

00032 1 action that we would be able to discuss is the 2 tavern license, which we've already been around 3 the - - Go ahead, Alderman Bohl. 4 ALDERMAN BOHL: Point of clarification 5 here. 15	Come on. It's common sense. We're all grown-
16	ups. We all know that it's a tavern and the
17	tavern/dance tied into the same application.
18	MR. SCHRIMPF: That is true, Mr.
19	Chairman, and in all due respect to the chairman,
20	the point of the matter is if you're going to
21	deal with a license, you have to give notice.
22	VICE-CHAIRMAN HERRON: I think that you
23	know, clearly we know that based on another case
24	that's coming before us relatively soon, and the
25	same issue arose where we dealt with a licensee.

00034 1 We gave them - - We asked them if they were ready 2 to hear some issues that they had not been 3 noticed on. They then went to court, got an 4 injunction, and - - and whatever we did was 5 overturned anyway. So - -ALDERMAN PAWLINSKI: Well, can I just 6 7 make one more point, Mr. Chairman. I promise to 8 make it the last point. 9 VICE-CHAIRMAN HERRON: Sure. Go ahead, 10 Alderman. 11 ALDERMAN PAWLINSKI: If you look at the 12 police report, every incident takes place after 13 midnight. You know, there's an old saying that 14 says, "Nothing good ever happens after one a.m." 15 2:17 a.m., 2:05 a.m., 2:25 a.m., and two - - 1:31 16 a.m. and 2:17 a.m. Trust me. This is not when 17 people are there having dinner. Okay. This is 18 there when people are engaging in dancing, and 19 they have too much to drink, and then they go out 20 in the parking lot and they smash bottles and 21 create disturbances in my neighborhood. 22 VICE-CHAIRMAN HERRON: Unfortunately, 23 and we, as the committee, certainly understand 24 your concern about this establishment, as well as 25 the concern about the neighbors who have called

00035 1	you, sent you E-mails. Unfortunately, we are
2	guided by law on instances like this. And our
3	ability to deal with this is limited. I think we
4	do have the ability to deal with the tavern
5	portion of the license, however, I don't
6	personally think that would have any impact on
7	her ability to operate considering that she would
8	still have her tavern/dance license. I will take
9	motions from the committee now on her tavern
10	on her tavern license. If there is a motion, I
11	will take it. I, again, apologize to the
12	alderman of the area as well as the neighbors.
13	Unfortunately, this is a instance where our hands
14	are tied. Alderman Bohl, do you have a motion?
15	ALDERMAN BOHL: Thank you, Mr.
16	Chairman. I will let you know that my motion

19	here, but I believe that based on the police
20	record, based on the concerns that have been

22	here over the last 15 months, that we have a
23	clear situation of a "lacks managerial style". I
24	think that we see these situations time and time
25	again where we have an applicant, who after

00036 1 problems occur, comes up and they want to do all 2 of a sudden, try to erase the problems that 3 occurred. I - - I think that it's too little, 4 too late in many respects. I'm not going to move 5 to deny the license here. I don't think that we 6 have a sufficient basis for that. However, I - -7 I think that in many respects that the 8 applicant's attempts to do this is half-hearted. 9 And I - - And I say that based on the track 10 record that we've had before. 11 I think that some of these incidents 12 here are extremely serious. Clearly there has 13 been nothing that has been necessarily earth-14 shattering. However, there have been a number of 15 fights. There have been some allegations of 16 gunshots. I think we have a powder keg that's 17 before us. And, you know, why is it that time 18 and time again we must wait as a body before 19 somebody is dead or bleeding on the streets, 20 before we say that this is a problem that - -21 that has gone too far. I - - I, you know, if - -22 if the applicant wants to go to an older crowd, I 23 would certainly encourage her to do so. However, 24 I think that at this point I would say that we 25 need to send a very stern message, not a soft

2	stern message. We have several incidents in the
3	last year. There has been four fights, five
4	fights here in the last year and a half. I would
5	move at this point for a renewal of the license
6	with a 35 day suspension.
7	VICE-CHAIRMAN HERRON: Alderman Bohl
8	moves for a renewal with 35 day suspension. Is
9	there any additional comments on this?
10	Alderwoman Cameron, do you have a
11	comment?
12	ALDERWOMAN CAMERON: Yes, I do.
13	VICE-CHAIRMAN HERRON: Go ahead.
14	ALDERWOMAN CAMERON: I think that I
15	the 35 days is kind of harsh. I would go for
16	more of a 20 day suspension, Mr. Chairman, and I
17	know that the relationship with the applicant and
18	the alderperson, I really think that they should
19	try to work out and have some community meetings
20	so they can iron out their differences. And I
21	really do believe they do have some difference.
22	And I really do believe that she needs to hear
23	from her own ears about the neighbors and what
24	their concerns are about her business and how
25	they fear for their safety. That hasn't

3	things that the aldermans of the district or the
4	representative of that district need to conduct

9	because even if we just go towards 30 30
10	instead of 35 days, at least a month suspension
11	even, you know
12	VICE-CHAIRMAN HERRON: Just Just
13	for the committee's information, and members of
14	the audience, even with the 35 day suspension of
15	her tavern license, it won't result in her being
16	closed, because she will always have her
17	tavern/dance license just as a point of
18	clarification.
19	MR. SCHRIMPF: Well, no, no, no. If
20	the tavern isn't operating, she's not going to be
21	holding dances. She'll be able to run the
22	restaurant, but she won't be able to serve
23	alcohol.
24	VICE-CHAIRMAN HERRON: All right. Is
25	there any further comment on that? I just want

1	to make a comment. It seems, Ms. Mata, that
2	you've escaped on a technicality. No different
3	than someone who has committed a crime but gets
4	off because of a technicality. That does not
5	mean that it wasn't done or that we don't take it
6	seriously. It means that in this body we operate

8	you would begin to conduct your tavern and your
9	facility under those same rules. I certainly
10	won't forget this instance for what happens in

15	necessary to have a safe place.

that there's no technicality, that you can get
off on. Any other questions? Comments? In that
case, there's a motion for a 35 day suspension.
Is there any objection to that motion? Hearing
none, so ordered.

2	MR. SCHRIMPF: Ms. Mata, the committee
3	is going to be doing findings of fact and
4	conclusions of law, recommending renewal of your

•	findings of fact, as well as, appear before the

14	of the building. Do you have any questions?
15	THE APPLICANT: Yes, what do I do with
16	the parties that I have, like Now, I have a
17	50 year anniversary party. What do I tell them?
18	No, liquor
19	MR. SCHRIMPF: Ma'am, that's one of the
20	reasons I suspect why it's very important to keep
21	good management and control of your tavern,
22	precisely to avoid problems like that. The
23	Statute indicates that your license expires one
24	year from the date of grant by the Common
25	Council. And every tavern owner, every liquor
