Please let me start by saying that I live in Milwaukee and I also live and work in Madison. This past Christmas/Holiday break I spent approx. three to four weeks in Milwaukee. During this time, my car was illegally towed by the City of Milwaukee. This action by the City left me without basic necessities, books and above all transportation. I visit my family in Milwaukee frequently so having a car is important to my life. I am now left without a car, makeup and books. I need my car to go to work and to travel to Iowa to see my college-age daughter and my family in Milwaukee. I also need my car to go to church. My daughter will graduate in three weeks and I will have to rent a car and U-Haul due to this situation. Not having a car has impacted my life to the extent my health has been affected. (I would bring prepared food from Milwaukee each week). My family has used the car for seven years. The car was in good condition and very reliable. So, my car and its contents were important to me.

Complaint: On February 1, 2002, at approximately 2:00 p.m. I parked on the 5600 block of Vliet to go into a beauty shop. I have parked in this location several times over the years and I have NEVER received a parking ticket in that location. It was snowing very hard that day. When I tried to start my car, I could not. I figured it was the neutral safety switch, so I walked home to get my son to help me start the car. I really cannot explain the logistics behind the neutral safety switch, but my son is able to have the car running within minutes. (The neutral safety switch is a problem with this particular model). So, I walked the six or seven blocks to 54th and Garfield, which is where I live when I am in Milwaukee. My son was not at home at the time, so I had to wait until he arrived, which was late that night.

The next day, I walked to that location around 11:00 to check on my car to see if it would start. I could not even open the car door due to all the snow. I attempted to dust the snow off the windows and car but it was a real chore, so I went home to get help from relatives. My son was working so he was unable to help me until that evening. When I returned that evening with my son, my car was gone!

Notice of Towed Vehicle Received: I went to the Vliet District Police station and the officer suggested that I call the City Tow desk. I discovered that my car had been towed to the city tow lot. I complained to the tow lot people what had taken place. I called several times to find out why my car was towed. No one there could give me an immediate answer. I received a Notice of

Towed Vehicle on 02/04/02. On 2/14/02, I received a notice of past due parking violation, which incidentally was my first notice of a violation connected to the tow. The citation issued on 02/02/02 states that the violation that caused the tow to occur was due to "parking in emergency". (Attached)

Written Request for Appointment: I am complaining about the City officials who refused my written request for a hearing since 02/16/02. Through numerous phone calls from Madison, tow desk personnel were more than aware of my frustration with the handling of this matter. On 02/16/02, I tried to retrieve my car, however, the person who loaned me their credit card was not present, and therefore the tow clerk could not process the transaction. It was at this time that I signed a statement on the "Complaint and Investigation Form". (Attached) The City had notice on 02/16/02.

Personal Property Destroyed Without a Hearing: I received a letter from the office of the city attorney on 03/25/02 stating that my car was "recycled" on 02/20/02 after I wrote the letter. This is actually a misstatement. It is true that your office received my letter on 02/20/02 and I wrote my complaint on 02/16/02, however, the City tow desk received actual notice on 02/16/02. The tow office is responsible for destroying my property. (I am assuming there is communication between the city attorney's office and the city tow desk). The City had notice that I wanted a hearing on this matter and they chose to ignore my property rights by "recycling" my car and its contents. I should have had my car at this point since it is obvious that I would not receive a hearing. My first letter received no response from your office. I received the letter from your office on 3/25/02 after a second letter, more than a month after my complaint. I understand that I must first file an administrative complaint against City officials. I have to admit that writing this letter seems almost futile, because the City Attorney is not a neutral official in this matter. It is your office that enforces the towing of vehicles.

Destroying my Property Without a Hearing is Unconstitutional: The main issue in the above set of facts is whether the City of Milwaukee provisions for towing a vehicle to the impound lot without prior notice or opportunity for hearing violates the requirements of the Due Process Clause of the Fourteenth Amendment. Constitutional Due Process requires an opportunity for a hearing before the state or city may deprive a person of his property, absent exceptional circumstances. Armstrong v. Manzo, 380 U.S. 545, 552, 85 S. Ct. 1187, 1191, 14 L. Ed. 2d 62; Boddie v. Connecticut, 401 U.S. 371, 378, 91 S. Ct. 780, 786, 28 L. Ed. 2d 113; Fuentes v. Shevin, 407 U.S. 67, 92 S. Ct. 1983, 32 L. Ed. 2d 556. The Supreme Court has held a temporary, nonfinal deprivation of property is nevertheless a deprivation. Fuentes, supra, 84-85, 86, 92 S. Ct. 1996, 1997. Other courts have recognized a protected interest in a person's continued use of his automobile, especially for business. Stypmann v. San Francisco, 557 F.2d 1338 (9th Cir. 1977). Since the ordinance in question (towing a vehicle during an emergency) requires what amounts to the temporary deprivation of either a person's automobile or his money, a property interest is involved.

The City of Milwaukee Snow Removal Process Caused the Emergency in Question: I questioned the tow office on numerous occasions, asking the clerk to explain to me how my vehicle parked on Vliet St was the cause of an public emergency. They could not give me an answer. My vehicle was not abandoned or impeding the flow of traffic. So far the City has offered two reasons for towing my vehicle. When I checked on my vehicle on 02/02/02 it did not have a parking ticket or the orange impound sticker on the car. On 02/14/02, I received a parking ticket in the mail for parking during an emergency. On 02/04/02, I received the "Notice of Towed Vehicle" which indicates that the reason for the tow was due to unpaid citations. (Attached) I certainly would like to be informed about the specific violation that caused the tow. I do not want


to experience this problem in the future. Moreover, the city's interest in removing my car from the street is different in either violation and this in turn affects the timing and extent of the hearing required by the Fourteenth Amendment.

In *Gillam v Landrieu* (1978, ED La) 455 F Supp 1030, the court held that a city ordinance denied procedural due process by being overbroad in authorizing the towing or impounding of unoccupied vehicles which were found to be allegedly violating "any traffic law." The court explained that there would be no great fiscal or administrative burden in making the city's ordinance more specific with respect to exactly which ordinances presented proscriptions whose violation would subject the car to risk of towing, and which would not incur such risk, reasoning that if the city chose to put up signs to demarcate tow-away zones, the only added expense and effort would be for placement and maintenance of the signs. The court added that making the ordinance more specific, as well as the citizens' interest in knowing what they can and cannot do, and what sanctions apply to specific conduct would thus further the government's interest in an informed citizenry.

For the reasons stated above, I am demanding damages of \$10,419.00. If this issue is not resolved before my daughter graduates from college on May 11, 2002, please add an additional 500.00 for the rental of a car and a U-Haul truck. I sincerely hope this issue is resolved expeditiously because I will be moving to Vancouver to complete my education. As I stated in my initial complaint, all my books were in the car. I desperately need my books. I cannot stress how invaluable all my outlines, tapes, review materials, treatises and other school related items are to my life and livelihood. I had every intention to using each item for years to come.

I have enclosed the documents mentioned above: letters, notices of violation and the complaint/investigation form. Also, I have included itemized statements of the contents which shows the basis for my claims and some of the evidence on which it rests.
