Our office has received your claim relating to the towing of 3 of your cars. You indicate that your vehicles were towed to the tow lot in February and March of 2002.

Regarding tow numbers 1112825 and 1112921, our investigation reveals that you are not the registered owner of either one of these vehicles. Therefore we are denying that portion of your claim related to those two tow numbers. Regarding tow number 1112824, on March 8, 2002, Assistant City Attorney Jay Unora waived all the towing and storage fees totaling \$1060.00 and you were ordered to pay 5 days storage which totaled \$195.00 if you claimed the vehicle by March 9, 2002. You authorized Eagle Towing to tow the vehicle off the tow lot on March 9, 2002. The PT-27, which is filled out prior to the tow, indicates that this vehicle was in serious disrepair prior to the tow; it was dented all over, had no rear windshield and no carburetor. The damage to your vehicle appears to have happened prior to the tow and therefore, we are denying your claim for tow number 1112824 also.
