To Whom This May Concern,

I am an elderly 65 year old woman and was in the hospital when this happened. I was parked in front of the house where I always parked because I thought it was safe to do so. There weren't any barricades or no parking sign around or else I wouldn't have parked there. I understand the rear end of the car came away on the curved part of the street due to a water main break. The car was pulled out of the ditch dragging the back wheels up to the street level, then taken 3 or 4 houses down the street. While car was down there someone came along and put 2 bricks on the tires, being afraid it would be towed away as an abandoned car, my son brought it back in front of the house. On 4/29/02 8 in the morning someone placed a temporary no parking sign on the tree by the car.

5 hours later a parking violation - ticket
was put on car began my son + daughter
could push it onto the drive way. On
4/30 I had car towed to and from
Ornato Olds to get an estimate only to
find out the damages exceeded the
value of the car. I've been told the
ditch breaks at least 2-3 times a
year, so now instead of a black tar
patch there is a big slab of concrete
like the rest of the street. This
happened the week of the 22nd when I went
into the hospital.
