**1. Description of Grant Project/Program (Include Target Locations and Populations):**

The Centers for Disease Control and Prevention (CDC) supports thirteen community projects with the goal of mobilizing and organizing local resources in support of comprehensive, effective and sustainable programs to prevent initial and repeat teen pregnancies. This is a seven-year demonstration project that will end in the fall of 2002, and the emphasis is on teen pregnancy prevention through positive youth development. The Milwaukee Adolescent Pregnancy Prevention Consortium (MAPPC) represents a genuine effort which builds upon the previous work of professionals, adolescents, parent, community leaders, schools, elected officials, and the faith community to develop and implement a city-wide community action plan for the prevention of adolescent pregnancy. The broader goal of the consortium is the promotion of optimum health and well being of adolescents and their families. The program is now in its implementation phase. MAPPC has made a commitment to ongoing evaluation, including process evaluation to monitor progress in ongoing consortium activities, and outcome evaluations examining the immediate and longer term accomplishment of the goals and activities of the consortium.

**2. Relationship to City-wide Strategic Goals and Departmental Objectives:**

Early childbearing reduces the chances of self-sufficiency and economical independence. Pregnant teens also have other risk factors including but not limited to low birth weight, sexually transmitted diseases, substance abuse, child abuse and neglect. The Health Department has a goal to make Milwaukee a city of healthy women and infants.

Until MAPPC, there was not a sustained, supported, and viable forum in Milwaukee for collaboration and cooperation among agencies, parents, teens, schools and elected officials, and the faith community related to adolescent pregnancy prevention. MAPPC has provided such a forum. According to results from a member survey, consortium members reported a major increase in coordinating services, undertaking joint projects, intergroup referrals, and exchange of information as a result of the MAPPC.
