Dear Ms. Thomas:

This office is in receipt of your claim in the amount of \$3,000.00, relating to injuries you sustained on December 8, 1999 when walking on City's sidewalk at 1102 West Mitchell Street.

The Infrastructure Services Division records indicate they did not have any requests between December 8, 1998 and December 8, 1999 to patch the sidewalk on South 11th Street between West Mitchell Street and West Lapham Boulevard. In the Spring of 2000, an asphalt shim was placed around a sidewalk slab at the northwest corner. Prior to this complaint, the City had no notice of any defect in the sidewalk and because of this lack of notice, the City would not be liable. Accordingly, we are denying your claim.
