On October 2, 1995, Milwaukee Police Department officers responded to the licensed premises then operated by the licensee at 2338 West Rogers Street, Milwaukee, Wisconsin ("Neza Cantina") regarding loud music and disorderly patrons. The licensee was cited for doors to be kept closed after 10:00 p.m. and on November 20, 1995 he was found guilty in Milwaukee Municipal Court and fined \$122.40.
- F. On November 28, 1996 at 2:15 a.m., Juan Roberto was shot and killed in an armed robbery attempt occurring in the parking lot of a licensed premise then operated by the licensee at 2338 West Rogers Street ("Neza Cantina"). A criminal complaint was filed.
- G. On January 5, 1997 at 1:28 a.m., Milwaukee Police Department officers were dispatched to the licensed premises at 2338 West Rogers Street ("Neza Cantina") for a complaint of underage patrons in the tavern. Upon their arrival, offices found an underage female, 19 years of age, inside the tavern. The licensee indicated that he thought the person was with her mother, however, the mother of the underage person was not in the licensed premises at the time. The licensee was cited for a presence of an underage person on a Class "B" premises and on April 28, 1997 was found guilty in Milwaukee Municipoal Court and fined \$332.50.

- H. On October 15, 1999, the licensee filed an application for a Class "B" tavern premises at 1704 South Pearl Street. Along with the application the subject filed the mandatory auxilliary questionnaire. Question No. 2 on that forms states: "Have you ever been convicted of any felony or misdemeanor (other than traffic) for violations of any federal laws, Wisconsin laws, any laws of any other states or ordinances of any municipality?" The question was answererd "No." The form was subscribed and sworn to before a notary public on October 12, 1999 and signed by the applicant. The licensee was cited for truth of statements and affidavits (falsifying) and on February 21, 2000 was found guilty in Milwaukee Municipal Court and fined \$250.00.
- I. On November 15, 1999, the licensee was charged with possession of cocaine and on June 26, 2000 was found guilty and sentenced to 18 months probation.
- J. On January 28, 2002 at 2:32 a.m. Milwaukee Police Department officers were dispatched to St. Francis Hospital regarding a cutting which occurred in front of the license premises at 1704 South Pearl Street ("Taqueria Neza"). The victim told officers that he was involved in an argument with a person inside the bar but he "backed off" and tried to let the problem die out. At 2:00 a.m. when he left the bar, he was followed by the other person who argued with him. They had words and the other person pulled out a box cutter. The victim took off running and was chased at which time he was cut with the box cutter on his stomach causing a 12 inch laceration requiring 36 staples. He drove himself to the hospital and an incident report was filed.
- K. On September 5, 2002 at the licensed premises at 1704 South Pearl Street ("Taqueria Neza") an undercover Milwaukee County Deputy Sheriff entered the premises along with another person. The licensee sold the undercover officer and his associate three separate sales of corner-cut plastic bags containing cocaine. The sales took place at 7:50 p.m., 8:30 p.m., and 8:45 p.m. on September 5, 2002. On September 8, 2002 the officer and the associate returned to the licensed premises at 1704 South Pearl Street. Two corner-cut plastic bags containing cocaine in five deliveries. The first delivery was for .39 grams, the second was .40 grams, the third was .43 grams, and the fourth and fifth deliveries total weight was .3 grams. The licensee was charged with delivery of a controlled substance five counts. He was found guilty and sentencing has been adjourned to February 25, 2003.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Arturo Martinez has not met the criteria to allow renewal of his Class "B" Tavern license, nor has he appeared to answer the report of the Milwaukee Police Department.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Class "B" Tavern license of Arturo Martinez for the premises located at 1704 South Pearl Street in the City and County of Milwaukee, Wisconsin ("Taqueria Neza") based upon his past activities as a Licensee and for the danger that the continued operation of the premises poses to the health, safety and welfare of the citizens of the City of Milwaukee, as well as for his failure to appear.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) noe and one (1) excused, recommends that the Class "B" Tavern License of Arturo Martinez for the premises located at 1704 South Pearl Street ("Taqueria Neza") in the City and County of Milwaukee, Wisconsin not be renewed



Re: Report of the Renewal Application of Charles E. Spahn, as agent for "IJDM, Inc." for a Class "B" Tavern and Tavern Dance license, for the premises located at 2800 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("McGinty's").

FINDINGS OF FACT

- 1. Charles E. Spahn (hereinafter the "Licensee") was the agent for "IJDM, Inc." doing business at 2800 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("McGinty's"). Said license expires at midnight, November 27, 2002.
- 2. An application to renew said license was filed with the Office of the City Clerk on September 5, 2002.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On September 6, 2002 the Milwaukee Police Department responded with a report which could form the basis for non-renewal or suspension of the Class "B" Tavern and Tavern Dance license held by "IJDM, Inc." for 2800 West Forest Home Avenue ("McGinty's"). In addition to the police report there were also objections to loitering, littering, noisy patrons, fights, shootings, vandalism, public urination, car jackings, and conduct which is detrimental to the health, safety and welfare of the neighborhood.
- 4. On November 1, 2002, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of a report of the Milwaukee Police Department that could form the basis for suspension or non-renewal of the licenses of the Licensee, and included therewith a copy



of the Milwaukee Police Department report and notice of the other objections. The matter was scheduled for a hearing on the police department report and neighborhood objections on November 12, 2002 at 11:00 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing together with a copy of the Milwaukee Police Department report. The Licensee was not represented by counsel.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
- A. On Saturday, August 12, 2000, at 1:34 a.m. Milwaukee Police Department officers were dispatched to the licensed premises at 2800 West Forest Home Avenue then known as "Scott E's Pub" regarding a shooting. The investigation revealed that one shot was fired in the bar and four shots were fired outside the bar. A subject was shot in the leg while in the bar. A criminal complaint was filed and one person was arrested for recklessly endangering safety.
- B. On January 7, 2001, Milwaukee Police Department officers investigated a sexual assault in which a 19 year old woman was the complainant. She related that she had been drinking in the licensed premises at 2800 West Forest Home Avenue, Milwaukee, Wisconsin then known as "Scott E's Pub." A citation was issued to the applicant but was dismissed. The Milwaukee Police Department filed an incident report.
- C. On February 16, 2001, an officer of the Milwaukee Police Department responded to the licensed premises at 2800 West Forest Home Avenue (then known as "Scott E's Pub") regarding trouble with a customer. The officer observed an intoxicated patron being escorted out of the bar by a bartender. The investigation revealed that prior to their arrival, there was no licensed person on the premises. A citation was issued to the applicant, but the City Attorney's Office declined to prosecution. An incident report was filed.
- D. On February 25, 2001 officers of the Milwaukee Police Department made a lawful inspection of the license premises at 2800 West Forest Home Avenue, then known as Scott E's Pub. The officers were advised that upon their arrival a patron might be armed with a handgun. No weapons were found, however, several patrons became disorderly resulting in one arrest for obstructing an officer. An incident report was filed.
- E. On July 7, 2002, at 2:04 a.m. Milwaukee Police Department officers were flagged down to investigate a complaint of shots fired from the licensed premises at 2800 West Forest Home Avenue ("McGinty's).

One of the victims was walking to a car from across the street. He stated he was shot as he was walking outside of the door of the tavern. The second victim was in the tavern. The first victim had a bullet wound to the abdomen and the second victim had a bullet wound to the right calf and one bullet to the left knee. The victim and the shooter had earlier gotten into a verbal argument. The shooter returned to the tavern and two persons, one of whom was sitting at the bar and not involved in either argument.

F. The licensee advised the committee that he has installed metal detectors through the use of a wand. He also indicated that between March and July of 2002, he was opened four days a week, but since July of 2002, he is only open on Friday and Saturday evenings. The licensee also indicated that he has been involved with this premises for the past seven years and in the last year has changed the name to "McGinty's."

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the <u>Wisconsin Statutes</u> and Chapter 90 of the <u>Milwaukee Code of Ordinances</u>.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Charles E. Spahn, as agent for "IJDM, Inc." d/b/a "McGinty's" at 2800 West Forest Home Avenue has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Class "B" Tavern license without undergoing a suspension of ten (10) days and non renewal of the Tavern Dance License. The Committee finds the police report and other objections to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew with a ten (10) day suspension the Class "B" Tavern license and to not renew the Class "B" Tavern Dance license held by Charles E. Spahn, as agent for IJDM, Inc., for the premises located at 2800 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("McGinty's ") based on police report and neighbor objections.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) noe, and one (1) excused

recommends that the Tavern Dance license not be renewed, but that the Class "B" Tavern license be renewed with a ten (10) day suspension.

Said suspension is to be in effect between midnight, November 27, 2002 and midnight December 6, 2002.
