## **CONCLUSION:**

Because complainant Alice WYNN has permanently moved out of state with no forwarding address, she would be unavailable for District Attorney review or prosecution in this investigation. WYNN also did not allow her two children, the only witnesses to the officers being in possession of the photos, to be interviewed. Subsequently, probable cause cannot be established at this time, against the officers involved in this investigation, without further cooperation from the complainant. This inquiry will be cleared as unfounded/baseless.
