Dear Council Members:

Returned herewith is a document filed by Attorney D. Michael Guerin for attorney's fees for representing Police Sergeant Louis Staton. The claim is in the amount of \$1884.81, including \$1180.81 in disbursements for private investigator's fees. The attorneys fees claim is for 6.40 hours of service billed at the rate of \$110.00 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the Police Officer on whose behalf this claim was filed. The officer was, however, suspended for ten days from work for his conduct related to this incident, and that suspension was reduced to four days by stipulation with our office and the chief on the officer's appeal to the Fire and Police Commission.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Sec. 895.35, Stats., *Bablitch and Bablitch v. Lincoln County*, 82 Wis. 2d 574 (1978).


