This is to notify you that on Tuesday, January 27, 2015, the Licenses Committee voted to recommend to the Common Council to deny your application for a Class A Fermented Malt Beverage Retailer's License for the premises located at 401 N 35th St ("Natt Grocery") based on neighborhood testimony and concentration.

On Tuesday, February 10, 2015, the Common Council considered the Committee's recommendation regarding your application. On that date, the Common Council adopted the Committee's recommendation and denied your application for a Class A Fermented Malt Beverage Retailer's License based on neighborhood testimony and concentration.

This is to notify you that on Tuesday, January 27, 2015, the City's Licenses Committee voted to recommend to the City's Common Council renewal with a 20 day suspension of your Class "D" Operator's license based on your police report.

On January 30, 2015, you were mailed a true and correct copy of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the renewal application for the Class "D" Operator license in which the Committee recommended that the license be renewed with a suspension of 20 days. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of Tuesday, February 10, 2015, commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of the right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time, and place, you did not appear, and you did not file written objections to the report of the Licenses Committee. You were not represented by counsel.

Following consideration of the report of the Licenses Committee, the Common Council voted to renew your Class "D" Operator's license with a 20 day suspension based on your police report.

Said suspension of your Class "D" Operator's license is to be in effect February 10, 2015 through 11:59 p.m., March 1, 2015.


