This office is in receipt of your claim in the amount of \$130.00, relating to the health abatement charges on your 2002 tax bill for the property located at 525 West Maple Street.

Our investigation reveals that the Department of Neighborhood Services records indicate that they inspected your property on April 25, 2002 and found that a litter nuisance was present. An order for clean-up was issued and posted on the premises and also mailed to 525 West Maple Street. Your property was re-inspected on May 15, 2002 and revealed that the condition was unchanged. The City hired a contractor to perform a clean-up. The contractor went to your property but found that the litter had been removed. The City policy is to pay a \$39.00 stop charge in this situation and, in addition, there were \$91.00 in administrative fees. The department acted appropriately and as such, the City would not be liable. Accordingly, we are denying your claim.
