Dear Ms. Albiter and Attorney Padway:

This is to notify you that on March 11, 2003 the City's Utilities and Licenses Committee voted to recommend to the City's Common Council that your renewal application for a Class "B" Tavern and Tavern Dance license for the premises at 1900 West Lincoln Avenue, Milwaukee, Wisconsin ("Tex Mex Place") be approved after undergoing a forty (40) day suspension. The Committee made such a recommendation based upon police and neighborhood objections.

On March 14, 2003, you were sent a true and correct copy of the findings of fact, conclusions of law and recommendations of the Utilities and Licenses Committee with respect to your renewal application for a Class "B" Tavern and Tavern Dance license in which the Committee recommended that your renewal application be approved after undergoing a forty (40) day suspension. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of March 25, 2003 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of your right to file written objections or to appear personally or by counsel to address the Common Council. At that date, time and place you, by your counsel, were in the chambers but did not appear. You also filed a document which was specifically denominated as not being an objection.

Following consideration of the report of the Utilities and Licenses Committee, and your documents, the Common Council adopted the Committee's recommendation by a vote of fifteen (15) ayes, zero (0) noes and zero (0) excused to renew your Class "B" Tavern and Tavern Dance License with a forty (40) day suspension.

Said suspension is to be in effect between midnight, April 22, 2003 and midnight, June 1, 2003.

You were advised of your right to file written objections or to appear personally or by counsel to address the Common Council. At that date, time and place you and counsel appeared, and you did file written objections to the report of the Utilities and Licenses Committee.

Following consideration of the report of the Utilities and Licenses Committee, your objections and arguments, the Common Council amended the Committee's recommendation by a vote of eight (8) ayes and seven (7) noes to amend the file to a renewal with no suspension. The council then approved the file as amended by a vote of fifteen (15) ayes, zero (0) noes and zero (0) excused.
