We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimant, Steven Bajorek, 2256 South 37<sup>th</sup> Street, Milwaukee, WI 53215, alleges that on January 13, 2003 he sustained injuries when he fell on an uneven portion of a pedestrian bridge located on South 43<sup>rd</sup> Street near Jackson Park. He claim s damages in the amount of \$9,218.40.

Our investigation reveals that the pedestrian bridge is within the limits of the Milwaukee County Park. Because this park is under the jurisdiction of Milwaukee County, the City cannot be held liable. Accordingly, we recommend that this claim be denied.
