#### **Details of Incident:**

I am a first time home buyer and have only lived in my residence for 3 ½ years am in the process of making home improvements and have purchased many items that will later be used for interior decorating. Most of these items are temporarily stored in my basement area. My basement is one-half recreation room and one-have storage and laundry facilities. The recreation area and the laundry/storage room are separate rooms. There is also a half-bath located just off the laundry/storage room.

On the morning of January 5, 2003, I went down to my basement to sort clothing as I always do to prepare for washing. Several piles of clothing were sorted on the floor for laundering later that evening.

Sunday, January 5 was a particularly busy day for me in that I was preparing to return to work after a three week vacation during the Christmas and New Year holiday. This meant I was taking down Christmas decorations and preparing them for storage in my basement. This activity and others lasted through the early part of the evening.

At approximately 4:30 p.m. I returned to my basement to put in a wash load. I returned upstairs and dosed off for a nap. At approximately 6:15 p.m. I awoke from my nap and returned to my basement to continue with my laundering. Before even reaching the bottom of the stair case leading into my basement, I

smelled a foul scent. Once I reached the basement floor, I found the recreation room and the laundry room was immersed in water.

I immediately called the Milwaukee Water Works customer service number and explained the situation to the dispatch person; answering her questions and providing her with the information she asked. The dispatch person indicated that someone would be out to my residence within the hour.

Within the hour my door bell rang and an individual from the City of Milwaukee indicated that the problem I was having with water in my basement was due to a clogged sewer. He asked if I had a lot of water in my basement and I indicated that I did. He further stated that the first thing they needed to do was unclog the sewer so the water could drain out. He indicated that the City would reimburse me for all damages since this was their fault. He further stated that someone would return and take additional information from me. This person did not state their name. The individual had dark hair, was medium/tall build and appeared to be of Hispanic decent.

Approximately 15 minutes later Dave Dulek, a Sewer Investigator at the City of Milwaukee, came to my residence and indicated that the backwater in my basement was due to a clogged sewer. He further stated that the clog stretched about 50 feet. I asked him what could be the cause of something like this? He indicated it could be caused by grease, etc. He asked if I had any damage and I indicated that I did. He then informed me that I would have to file a claim if I wanted to be reimbursed for damage to any of my personal property. I then asked him if I could get a copy of the report he was filing. He indicated that a copy would be available in a couple of days.

Needless to say, Sunday, January 5 was a very eventful day for me. Not only did I have the incident with the backwater in my basement, my fiancé was involved in a terrible car accident. He was off work for several months due to injuries he suffered. With his health being my first priority, I am just now dealing with filing this claim in time to meet the 120 day deadline you have established.

Provided in the attached document is a listing of all the items that were damaged due to the backwater incident experienced at my residence on January 5. I would appreciate your evaluation of this claim and reimbursement for expenses incurred and cost to replace my personal property that was damaged as a result of this incident.






