BY EAST EDGEWOOD AVENUE, EAST PARK PLACE,

NORTH CAMBRIDGE AVENUE AND NORTH

MARYLAND AVENUE BETWEEN 8:00 AM AND 2:00 PM

ON THE 1ST AND 3RD FRIDAYS OF THE MONTH

FROM APRIL THROUGH NOVEMBER

Dear Alderman D'Amato:

To implement an enhanced street sweeping program in the area generally bounded to the west by North Cambridge Avenue, to the south by East Park Place, to the east by North Maryland Avenue, and to the north by East Edgewood Avenue, "No Stopping, Tow Away Zone" parking restrictions will be required on streets in the area during periods when street sweeping operations will take place. It is proposed that the "No Stopping, Tow Away Zone" restriction be placed on alternating sides of the streets in the area on the first and third Fridays of the month from April through November. Additionally, the proposed restrictions will be in effect from 8:00 AM through 2:00 PM on the affected side of the roadway to allow sweeping operations to be completed.

If you have no objection to the proposed parking prohibitions, we will prepare the legislation necessary to implement the restrictions, and ask that you support them to final passage. Dear Alderman D'Amato:

As part of a comprehensive program of transportation improvements to cooperatively address parking and transportation related issues in the University of Wisconsin-Milwaukee Campus Area, the East Side Transportation Management Association (ETMA) Board of Directors unanimously endorsed the implementation of uniform times of day and days of the week that parking time limits would be in effect within the boundaries of the proposed enhanced street sweeping program in the area. With deployment of parking restrictions necessary to implement the street sweeping program, the time limits on parking in the area generally bounded by East Edgewood Avenue, North Cambridge Avenue, East Park Place and North Maryland Avenue would be changed to be in effect from 7:00 AM to 7:00 PM except Saturdays, Sundays and by permit. These uniform periods will replace a wide variety of time of day and day of week periods currently in effect in the area.

If you have no objection to the proposed changes, we will prepare the legislation necessary to implement the restrictions, and ask that you support them to final passage.
