Dear Ms. Dukes:

Please find attached, the above-referenced matter. The attachment details the various "inquiry categories" as well as the "referral categories" for the years of 2001, 2002 and a tally of the inquiries so far this year. More specifically:

Year 2001

- -a total of 1,019 inquiries:
 - -352 of the 1,019 inquiries were for alleged employment discrimination
 - -38 of the 1,019 inquiries were for alleged housing discrimination
- -a total of 398 referrals to other agencies:
 - -138 of the 398 referrals were referred to the Equal Rights Division
 - -21 of the 398 referrals were referred to the Equal Employment Opportunity Commission
 - 52 of the 398 referrals were referred to the Department of Labor

Year 2002

- -a total of 1,444 inquiries:
 - -483 of the 1,444 inquiries were for alleged employment discrimination
 - -71 of the 1,444 inquiries were for alleged housing discrimination
- -a total of 320 referrals:
 - -118 of the 320 referrals were for the Equal Rights Division
 - -24 of the 320 referrals were for the Equal Employment Opportunity
 - -69 of the 320 referrals were for the Department of Labor

Year 2003 (Up to June)

-a total of 532 inquiries:

- -260 of the 532 inquiries were for alleged employment discrimination
- -25 of the 532 inquiries were for alleged housing discrimination

-a total of 151 referrals:

- -31 of the 151 referrals were for the Equal Rights Division
- -12 of the 151 referrals were for the Equal Employment Opportunity Commission

-62 of the 151 referrals were for the Department of Labor
