#### **Dear Council Members:**

Returned herewith is a document filed by Attorney Laurie Eggert for attorney's fees for representing Lieutenant of Police Officer Kevin Porter. The claim is in the amount of \$561.00 for 5.10 hours of service billed at the rate of \$110 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the police officer on whose behalf this claim was filed.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Sec. 895.35, Stats., *Bablitch and Bablitch v. Lincoln County*, 82 Wis. 2d 574 (1978).

Claims for Attorney's Fees for Representation of Police Officers Jon DuChateau, George Suvaka, Jennifer Wardinski, Doug Williams, Wendy Shaw and Kevin Porter

Dear Ms. Eggert:

I have certain concerns regarding your three claims for representing the officers named above. For your convenience, copies of your claims accompany this letter.

With regard to your representation of Officers DuChateau, Suvaka, Wardinski and Williams, I am concerned that the officers were not entitled to separate representation from your office under the circumstances described in your letter. The City is not, therefore, in position of having to reimburse them for attorney's fees. It does not appear a Wisconsin Department of Corrections inquiry into a death in custody constitutes "charges of any kind" nor does it constitute an "action . . . brought against any officer . . . " See § 895.35, Stats. Just as significantly, your explanation of your involvement in this inquiry begins with the statement that, the "City Attorney's Office has refused to represent" these officers. I do not understand how that representation could be made in light of your further explanation that the inquiry was a Wisconsin Department of Corrections' investigation, and that it followed a criminal investigation which had been "completed" before the Wisconsin Department of Corrections' inquiry began. If this is merely a state departmental inquiry into an incident involving City of Milwaukee employees, and if a criminal inquiry had already been completed and no charges had been brought against the officers, our office would have been fully

qualified to represent them and should have appeared to represent their interests, if they desired counsel.

I note in your bill for this matter that you have included a of couple telephone conversations with Mr. Langley. Before writing this letter to you, I spoke to him about this matter. He indicated to me that he did not recall ever authorizing you to represent these officers in this matter. Under these circumstances, in the absence of further satisfactory explanation, I cannot recommend payment of this claim.

The next claim about which I have some questions involves your claim for representing Officer Wendy Shaw. The explanation that you provide indicates that you represented Ms. Shaw in connection with a criminal investigation of another police officer, Brian Blumenberg, relating to an incident which "occurred after a party for P.O. Wendy Shaw."

Sec. 895.35, Stats., however, is limited to "charges of any kind... against any officer... in the officer's official capacity..." In order to evaluate your claim properly, I will need a better explanation of the way in which a criminal investigation of another officer for conduct occurring after a private party for your client police officer is connected to your client's "official capacity." In the absence of an adequate explanation, I will also have to recommend denial of this claim.

Lastly, with respect to your claim for attorney's fees for representing Officer Kevin Porter, your explanation also leads to a concern about the "official capacity" requirement. You explained that the "incident involved an allegation of harassing phone calls on duty:" While it is certainly possible that these phone calls could be connected to your client's duties as a police officer, your minimal explanation also leaves open the possibility that this could relate to phone calls which were entirely personal in nature, given that the complainant is identified as a Ms. Tina Prusak. Please provide me with further details relating to this incident that would tend to show that the calls were made as part of the officer's official capacity. If it appears that they are telephone calls of a purely personal nature which do not involve his duties as a police officer, I would, again, have to recommend denial of this claim.

Dear Jan:

In your letter of May 7, 1999 regarding this claim, you expressed concert about the "official capacity" requirement. You state that if the officer were making purely personal phone calls, you would recommend denial of the claim.

You asked for more details regarding the allegations. The MPD investigated an allegation that Officer Porter made harassing phone calls to Ms. Prusik while he was at work and in uniform. The allegations were untrue; Porter did not make the phone calls to Ms. Prusik. It is, consequently, difficult to assure you that he was not making those calls for purely personal reasons.

The MPD investigated Porter because they had reason to suspect that the person who made the phone calls was a police officer who was on duty in a marked squad. The MPD concluded that it was not Porter.

Porter's claim should be paid, just as the City has paid the claims of other officers who were improperly identified as having participated in alleged wrongdoing while on duty. Both sets of officers have the misfortune of being identified as the culprit, even though neither did anything wrong. For example, the City routinely pays fees for representing officers wrongly accused of theft, even though stealing while on duty could be construed as going on a lark of one's own. However, where the officer did not steal anything, and suspicion was placed on him due to the fact that the complainant identified him as the police officer that stole the money while on duty, the innocent officer should not suffer the additional indignity of having to pay a lawyer to get rid of the charges. So far, the City has agreed with that proposition.
