Dear Mr. Kupper:

This office is in receipt of your claim in the amount of \$900.00, relating to the removal of debris from your property on June 9, 2003 that was considered a litter nuisance at the property located at 2924 West Arthur Avenue.

Our investigation reveals that the Department of Neighborhood Services records indicate that they inspected your property on May 16, 2003 and found that a litter nuisance was present. The nuisance consisted of siding, dismantled motorcycle, metal storage containers, metal shelving, tires loose debris and all other debris on the property in the backyard and around the garage. An order for clean-up was posted on the premises that day. It was also mailed to you on May 20, 2003. Your property was reinspected on June 5, 2003 and revealed that the metal shelf and tires had been removed but the rest of the debris remained. There was no contact from you. The City hired a contractor who performed a clean-up on June 9, 2003. The department acted appropriately in this matter and as such, the City would not be liable for your loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
