Dear Council Members:

We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimants, Gene & Mary Werth and Joseph Werth, 2036 South 28th Street, Milwaukee, WI 53215, allege through their attorneys First, Blondis, Albrecht & Novotnak, S.C., 158 North Broadway, Suite 600, Milwaukee, WI 53202, that on July 8, 2003 the Department of Neighborhood Services removed and discarded their personal property and in the process, caused injury to their minor child. They claim damages in the amount of \$100,000.00.

Our investigation reveals that the Department of Neighborhood Services records indicate that an order was issued to Mary and Gene Werth on June 17, 2003 for removal of debris on the property. The order was posted on the property the same day. The order was mailed to 2036 South 28th Street on June 18, 2003. They had a conversation with Mary Werth on that day and granted an extension to July 2, 2003. A re-inspection at that time revealed that much of the debris remained. A contractor was at the property on July 8, 2003 and attempted to remove the remaining debris. The contractor contacted the department for assistance due to the hostile and
