Dear Council Members:

Returned herewith is a document filed by Attorney Laurie A. Eggert for attorney's fees for representing Police Officers Todd Higgins and Richard Schellhammer. The claim is in the amount of \$1,649.00, including \$10.00 in disbursements for 14.90 hours of service billed at the rate of \$110.00 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by the filing of a citizen's complaint against the officers with the Fire and Police Commission. The complaint was dismissed by the Commission.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Sec. 895.35, Stats., <u>Bablitch and Bablitch v. Lincoln County</u>, 82 Wis. 2d 574 (1978).

The above-named police officers have retained us to represent them in connection with the above-referenced matter. Consistent with its policy, the City Attorney's Office has refused to represent them and as they were performing the duties of their office at the time of the events giving rise to the incident, the claim is hereby made on their behalf for the indicated legal fees. This incident involved a field interview.

This matter began as a citizen complaint filed by the citizen with the FPC. During the pendency of the FPC case, the Milwaukee Police Department also conducted an internal investigation regarding the same incident and issued a PI-21 to the officers requiring them to answer questions about the incident. This statement includes time spent representing the officers when giving statements to IAD pursuant to the PI-21, as well as time spent on the remainder of the representation regarding the FPC citizen complaint.

The Fire and Police Commission dismissed the complaint. Attached is a copy of the dismissal notice and an itemization of the time and services rendered.
