FINDINGS OF FACT

1. Deborah L. Colavita (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2003.

- 2. A timely application to renew said license was filed with the Office of the City Clerk on October 30, 2003.
- 3. Pursuant to Chapter 90 of the <u>Milwaukee Code of Ordinances</u> and Chapter 125 of the <u>Wisconsin Statutes</u>, the matter was referred to the Milwaukee Police Department for investigation. On October 31, 2003, the Milwaukee Police Department responded with a police report which could form the basis for non-renewal or suspension of said license.
- 4. On December 19, 2003, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on January 6, 2004, commencing at 9:30 a.m. in Room 301B of City Hall. The licensee appeared but was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

- A. On February 16, 2001, Deborah L. Colavita was arrested in Ozaukee County for operating while intoxicated. She was convicted of that offense on March 13, 2002 and her driver's license was suspended for 7 months.
- B. On May 6, 2003, Deborah L. Colavita was arrested in Ozaukee County for operating while intoxicated. She was convicted on October 6, 2003 and was jailed under the Huber Law for 30 days and her driver's license was suspended for 14 months. She was fined \$936.

CONCLUSIONS OF LAW

- The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee finds that the licensee, Deborah L. Colavita, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license held by her without undergoing a twenty (20) day suspension of said license. The Committee finds the report of the Milwaukee Police Department to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "D" Bartender license held by Deborah L. Colavita with a twenty (20) day suspension.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes to zero (0) noes, recommends that the Class "D" Bartender Li cense of Deborah L. Colavita be renewed with a twenty (20) day suspension.

Said suspension is to be in effect between midnight, January 21, 2004 through midnight, February 9, 2004.

Re: Report of the Renewal Application of Ana M. Aguilera Del Castillo for a Class "B" Tavern license for the premises located at 2011 Weset Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("El Tequila").

FINDINGS OF FACT

- 1. Ana M. Aguilera Del Castillo (hereinafter the "Licensee") holds a Class "B" Tavern license for the premises at 2011 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("El Tequila"). Said license expires at midnight, January 21, 2004.
- 2. An application to renew said license was filed with the Office of the City Clerk on November 26, 2003.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report dated November 28, 2003 that could form the basis of non-renewal or suspension of this license. There were also neighborhood objections to loitering, littering, loud music and noise, disorderly patrons, minors on the premises, vandalism, gang activity, shootings, property damage, parking and traffic problems, and conduct which is detrimental to the health, safety and welfare of the neighborhood.
- 4. On December 19, 2003, the City Clerk's Office provided notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the <u>Wisconsin Statutes</u> of the police report that could form the basis for suspension or non-renewal of the licenses of the Licensee and the neighborhood objections. The matter was scheduled for a hearing on the police report and neighborhood objections on January 6, 2004 at 10:30 a.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensee

- appeared at the hearing and was represented by Attorney Alan Eisenberg, 3111 West Wisconsin Avenue, , Milwaukee, WI 53208.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On April 27, 2003, at 12:21 a.m. officers of the Milwaukee Police Department were dispatched to a "subject with a gun" complaint later updated to a "shots fired inside a bar" at the intersection of 20th Street and Forest Home Avenue in the City and County of Milwaukee, Wisconsin. Upon arrival, officers observed the only bar on the corner, which was the licensed premises at 2011 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("El Tequila"). The tavern appeared to be closed for the evening. There were no lights on and the doors were secured. However, the officers observed what appeared to be gunshot holes in the front window. Checking with neighbors, the officers were told that two girls came to the front door of the neighbor and asked her to call the police because several males were fighting at the licensed premises located at 2011 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("El Tequila"). The women claimed that some of the actors had guns. The neighbor said she did not hear any shots being fired. At approximately 1:30 a.m., three males arrived on the scene. One of them, Guadalupe Macias, related that he was the manager on duty that evening and that at approximately 12:00 a.m., several males entered the bar and began to cause a disturbance with other patrons. A fight broke out and two of them pulled out guns and started to fire. A victim was struck who was sent to St. Francis Hospital and reported the incident. That individual suffered a wound to his back which exited his left rib cage and entered his left bicep. The manager, Guadalupe Macias, stated that he closed the tavern after the incident and left the premises because his wife was pregnant, she was on the premises, and she became frightened and suffered a panic attack. He stated that he intended to return to the premises to report the incident to the police. The manager was cited for disorderly premises and on September 16, 2003 was found guilty and fined \$352.00.

At the hearing the licensee claimed that she did not know of the incident, but when she discovered the incident she fired the manager, Guadalupe Macias.

B. On May 24, 2003 at 10:47 p.m. officers of the Milwaukee Police
Department were dispatched to a threat complaint at the licensed premises
at 2011 West Forest Home Avenue in the City and County of Milwaukee,
Wisconsin ("El Tequila"). The officers were told that a guest at a wedding
on the premises was causing a disturbance and was escorted from the
premises. The father of the guest, upon seeing his son escorted, became

upset and started to yell. This person told his son to shoot the person escorting him from the premises. Subsequently, the security staff called the police and shut down the wedding. All of the guests left without incident. The persons causing the disturbance apologized to the security staff. The premises manager did not wish to pursue the matter. The officers checked the premises and also found that there was no Class "B" license visible. They were told that the license was kept at a co-worker's residence during a remodeling of the tavern. About one hour later the co-worker delivered the license to the tavern.

C. On June 20, 2003 at 10:15 p.m., officers of the Milwaukee Police Department conducted a licensed premises check at the licensed premises at 2011 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("El Tequila"). The police department was advised that there was to be a large party at the location involving subjects of all ages. Upon arrival, officers observed a line of subjects, many of whom appeared to under 21 years of age, waiting outside of the door to gain entry to the location. There were bouncers at the door handing out yellow wristbands to those who were under 21 years of age and red wristbands to those who were 21 years of age or older. Upon entering the premises the officers observed numerous subjects, both underage and of proper age in the bar area drinking, socializing, and playing billiards. Alcoholic beverages were being served in the area. In the rear of the location there was a large hall in which there was another bar and numerous subjects, who were later identified as being either mostly juveniles or underage persons in attendance. Those under 21 years of age were observed wearing the vellow wristbands and those over 21 years of age were observed wearing the red wristbands. Alcoholic beverages were available and being served in the back hall where the iuveniles and underage persons were both present. Forty-three (43) citations were issued, 28 juveniles, 12 adults, and 3 individuals who were 17 years of age. This matter is set for a trial on March 4, 2004.

Under the provisions of § 125.07(8) and (10), Wis. Stats., and § 90-19.5 of the Milwaukee Code of Ordinances, a procedure exists for underage events which was on a Class "B" premises not followed by the licensee in this case.

At hearing it became apparent that no occupancy certificate has been secured for the dance hall portion of the premises, and that the tavern portion of the premises has a capacity of 25 persons. However, at hearing the licensee claimed that the bar can hold 80 people, and that the capacity of the hall is 290 persons.

- D. At the hearing, the committee was advised that a second party was held at this location which properly secured alcoholic beverages during an underage event.
- E. The supporters included the daughter and former employee of the licensee, and a friend who owns a nearby restaurant. Both of the supporters, however, admitted that the management of this location has not been the best in recent years.
- F. The prior record of this location demonstrates that it was first granted in the year 2000 and renewed in the year 2001. In 2002 there was a 10-day suspension of the tavern dance license and in 2003 the Class "B" tavern license was renewed with a warning.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Ana M. Aguilera Del Castillo for the premises located at 2011 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("El Tequila"), has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of her Class "B" Tavern license without undergoing a twenty (20) day suspension. The Committee finds the police report to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern license of Ana M. Aguilera Del Castillo for the premises located at 2011 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin with a twenty (20) day suspension.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes recommends that the Class "B" Tavern license of Ana M. Aguilera Del Castillo for the premises located at 2011 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("EL Tequila") be renewed with a twenty (20) day suspension.

Said suspension is to be in effect from midnight, January 20, 2004 through midnight, February 9, 2004.

FINDINGS OF FACT

- 1. Ramon Orozco, agent for 3 Hermanos, Inc. (hereinafter the "Licensee") holds a Class "B' Tavern and Tavern Dance license for the premises at 1332 West Lincoln Avenue in the City and County of Milwaukee, Wisconsin ("Club Hermanos"). Said license expires at midnight, February 13, 2004.
- 2. An application to renew said license was filed with the Office of the City Clerk on December 1, 2003.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was no Milwaukee Police Department report which could form the basis of nonrenewal or suspension, but there were neighborhood objections to loitering, littering, parking and traffic problems, loud music and noise, disorderly patrons, fights, trespassing, damage to private property, and conduct which is detrimental to the health, safety and welfare of the neighborhood.
- 4. On December 22, 2003, the City Clerk's Office provided notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the neighborhood objections that could form the basis for suspension or non-renewal of the licenses of the Licensee. The matter was scheduled for a hearing on the police report and neighborhood objections on January 6, 2004 at 1:30 p.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensee appeared at the hearing and

was represented by Attorney Jon Monson, 1 Plaza East, Suite 1125, 330 East Kilbourn Avenue, Milwaukee, WI 53202.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. One neighbor adjoining this premises has had a continual problem with patrons of the premises illegally parking in driveways and on private property and in front of access points to driveways. This has caused the disruption in the adjoining neighbor's business. Some of the operators of these vehicles have also damaged fencing that the adjoining neighbor has installed. The adjoining neighbor has put up no parking signs, but these are apparently ignored by the patrons of this premises.
 - B. Adjoining neighbors have experienced broken beer bottles and litter being thrown on to their properties. The neighbors have complained to the operators of the premises, but they tend to ignore the complaints.
 - C. The adjoining neighbor experiencing the parking problems knows that the parkers are patrons of the premises because he has called to get the cars ticketed and towed. He has then waited for the patrons to come to their cars and they have exited from the licensed premises.
 - D. Another adjoining neighbor provided videotaped demonstrations of disturbances of patrons exiting this premises. This adjoining neighbor has for 8 years, out of the 28 years he has lived at this location, put up with noise at closing time, public urination, and being awoken out of his sleep regularly on Friday evenings. That adjoining neighbor is required to get up early on Saturday mornings, and the conduct of the patrons of this premises has been particularly aggravating to him. That adjoining neighbor also has personally observed a patron drive into and wreck the fence of the other adjoining neighbor who testified in these proceedings.
 - E. Both neighbors who object to this premises, indicate that the problem is not the existence of a Class "B" Tavern license or the operation of the restaurant on this premises. Rather, it is the noise associated with the activities of the tavern dance license after the restaurant closes.
 - F. Both neighbors have no objection to the operation of the restaurant at this location or the tavern as such. Rather, it is the nightclub operation after the restaurant closes, which has been the source of the neighborhood disruption noted above.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact

and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.

- 2. Based upon the above facts found, the Committee concludes that the licensee, Ramon Orozco, agent for 3 Hermanos, Inc. d/b/a "Club Hermanos" at 1332 West Lincoln Avenue in the City and County of Milwaukee, Wisconsin, has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "B" Tavern Dance license without undergoing a twenty-five (25) day suspension. The Committee also concludes that the Class "B" Tavern license may be renewed because the operation of the Class "B" Tavern has not been the source of the problems experienced by the objecting neighbors. The Committee finds the neighborhood objections to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern license of Ramon Orozco, agent for 3 Hermanos, Inc., d/b/a "Club Hermanos" for the premises located at 1332 West Lincoln Avenue in the City and County of Milwaukee, Wisconsin but should also exercise its judgment to renew with a twenty-five (25) day suspension the Tavern Dance license held by Ramon Orozco, agent for 3 Hermanos, Inc., d/b/a "Club Hermanos" for the premises located at 1332 West Lincoln Avenue in the City and County of Milwaukee, Wisconsin.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) noes recommends that the Class "B" Tavern license be ren ewed and the Tavern Dance license held by Ramon Orozco, agent for 3 Hermanos, Inc., d/b/a "Club Hermanos" for the premises located at 1332 West Lincoln Avenue in the City and County of Milwaukee, Wisconsin be renewed with a twenty-five (25) day suspension.

Said suspension is to be in effect from midnight, February 13, 2004 through midnight, March 9, 2004.

FINDINGS OF FACT

- 1. Marvin A. Berg, III, as agent for Utopia, Inc. (hereinafter the "Licensee") holds a Class "B' Tavern and Tavern Amusement (Cabaret/Nite Club) license for the premises at 162 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin ("Pure"). Said license expires at midnight, January 30, 2004.
- 2. An application to renew said license was filed with the Office of the City Clerk on November 10, 2003.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report dated November 11, 2003 that could form the basis of non-renewal or suspension of this license. There were also neighborhood objections to loitering, littering, noisy patrons during and after hours, patrons fighting, gunshots, damage to private property, parking and traffic problems, and conduct which is detrimental to the health, safety and welfare of the neighborhood.
- 4. On December 19, 2003, the City Clerk's Office provided notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report that could form the basis for suspension or non-renewal of the licenses of the Licensee and the neighborhood objections. The matter was scheduled for a hearing on the police report and neighborhood objections on January 6, 2004 at 11:00 a.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensee appeared at the hearing and was represented by Attorney D. Michael Guerin,

Gimbel, Reilly, Guerin & Brown, 330 East Kilbourn Avenue, Milwaukee, WI 53202.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On April 14, 2002, at 1:40 a.m. officers of the Milwaukee Police
 Department made a lawful inspection of the licensed premises at 162 West
 Wisconsin Avenue in the City and County of Milwaukee, Wisconsin
 ("Pure"). Officers observed two female patrons fighting in the rear of the
 tavern. Both women were cited for battery. Officers reported that the
 tavern personnel were cooperative with the officers, and an incident report
 was filed.
 - B. On April 21, 2002 at 1:40 a.m., officers of the Milwaukee Police Department responded to a fight in the area of the licensed premises at 162 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin ("Pure"). The investigation revealed that there had been a fight in the tavern and the tavern security personnel broke it up and summoned an ambulance for one of the combatants. The applicant, who was on the scene, was cited for disorderly premises. However, that charge was refused by the City Attorney's Office. An incident report was filed.
 - C. On August 3, 2002, at 1:30 a.m. officers of the Milwaukee Police
 Department made a lawful inspection of the licensed premises at 162 West
 Wisconsin Avenue in the City and County of Milwaukee, Wisconsin
 ("Pure"). Officers observed that a cover charge was being charged but no
 cover charges were posted. Officers also observed that there was no
 posted capacity sign. The applicant was warned regarding these offenses
 and an incident report was filed.
 - D. On February 26, 2003, at 3:40 a.m. at 162 West Wisconsin Avenue, Marvin A. Berg III was issued a citation for fire prevention enforcement. He was found guilty of that citation on October 9, 2003 and forfeited \$150.
 - E. On October 18, 2003 at about 2:00 a.m., a Milwaukee police lieutenant supervising the violent crimes task force observed that the premises at 162 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin ("Pure") was closing and several hundred patrons leaving. Due to known traffic control problems when the licensed premises at 162 West Wisconsin Avenue ("Pure") closes, the lieutenant blocked westbound traffic on Wisconsin Avenue at Plankinton. During this time, several hundred people began loitering outside of the club and on the street. They were blocking traffic in both directions. Numerous cars going eastbound on Wisconsin Avenue began stopping. The occupants were talking to and

attempting to pick up women. Pure's security people were standing outside and were not observed taking any action to assist in clearing the area. During this time, a Milwaukee County Sheriff's squad, operating as an emergency vehicle driving east on Wisconsin Avenue, was responding to assist an officer at the intersection of Edison and Juneau in the City and County of Milwaukee, Wisconsin. The Sheriff's Department squad car was unable to get vehicles or people standing in the street to move. The lieutenant noted that this occurs nearly every Friday night and that on most Fridays, Police District No. 1 and violent crimes task force squads are available to close Wisconsin Avenue and have the officers keep the people on the sidewalks. However, on October 18, 2003, no additional squads were available.

- On November 8th and one week later on November 15, 2003, at and F. around closing time, two incidents occurred wherein shots were fired. On November 8, 2003, Mr. Berg was on the premises. Two patrons became involved in an argument and security personnel escorted them out. However, the victim and the aggressor met outside and another problem occurred. On November 15, 2003, shots were fired from a maroon vehicle into a Suburban that was parked across the street from the licensed premises at 162 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin ("Pure"). Two of the bullets exited the Suburban and broke out glass at a TJ Max store located at the Grand Avenue Mall. Five of the bullets entered the Suburban. The licensee maintains that this incident was not connected with activity at "Pure." However, an incident report filed by security personnel at the Grand Avenue Mall and received into evidence at the proceeding demonstrated that, in fact, the incident was connected with patrons who had been at "Pure".
- G. Residents of the area, particularly residing at 730 North Plankinton Avenue, complain that they are regularly awoken by conduct of patrons exiting the "Pure" as well as the gunshots that occurred on November 8, 2003 and November 15, 2003.
- H. One individual who resides at 730 North Plankinton Avenue, and also is employed in an adjacent restaurant and pub, personally observed crowds standing outside of the "Pure" nightclub on a regular basis nearly every Friday night. It is necessary for the police to shut down the street because of the crowds which enter into the vehicular pathways of Wisconsin Avenue. The shootings have been a particular concern to the staff of other premises open at that hour as well as their customers. This same woman personally observed two of the patrons from "Pure" engage in a fight which eventually went across the street and involved 20 patrons.

- I. These same witnesses observed that on those nights when "Pure" is not operating, the events as described above, do not occur despite the fact that other licensed premises in the area continue to operate.
- J. The manager of the Howard Johnson Hotel, immediately adjacent to "Pure", informed the committee that the hotel cannot rent rooms adjacent to "Pure" on Fridays and Saturdays because of the noise associated with the operation of "Pure." On occasion, discounts and refunds have had to be given to occupants of such rooms. This has caused a loss of business and revenue to the hotel operators.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Marvin A. Berg, III, agent for Utopia, Inc. d/b/a "Pure" at 162 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin, has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license without undergoing a seventy-five (75) day suspension. The Committee finds the police report and neighborhood objections to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license of Marvin A. Berg, III, agent for Utopia, Inc., d/b/a "Pure" for the premises located at 162 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin with a seventy-five (75) day suspension.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) noes recommends that the Class "B" Tavern and T avern Amusement (Cabaret/Niteclub) license of Marvin A.
