NOTICE OF CLAIM FOR DAMAGES

PLEASE TAKE NOTICE that on April 8, 2003, April J. Bhayana of 307 North 95th Street, #211, Milwaukee, WI 53226 was in an automobile accident at the location of North Humboldt Avenue and North Commerce Street, City of Milwaukee, State of Wisconsin.

That on April 8, 2003 April J. Bhayana was operating a vehicle, to wit, a 1991 Ford Escort owned by Laureen D. Ingram, which vehicle sustained substantial damage as a result of the accident above and was towed from the accident scene by the City of Milwaukee Tow Lot.

That Laureen D. Ingram received a notice from the City of Milwaukee Tow Lot dated April 10, 2003 stating that the vehicle and/or property were to be retrieved within "15 days" from the date of the notice from said vehicle.

That on April 25, 2003 April Bhayana went to the City of Milwaukee Tow Lot with the proper notarized document requested per the notice to retrieve personal items from said vehicle. Ms. Bhayana was informed that said vehicle was "recycled" on April 24, 2003.

That as a result of the vehicle being "recycled" <u>before</u> the fifteen (15) day deadline, Ms. Bhayana had lost many personal items; the value of which totals \$1,275.00 (see attached itemization).

Liability for the lost property is claimed as follows:

The City of Milwaukee and City of Milwaukee Tow Lot on account of its liability for the acts of its agents and unknown employees, and particularly the City of Milwaukee Tow Lot and said unknown employees, as further set in this Notice of Claim for Damages, who were acting within the scope of their employment at the time of the "recycling" of said vehicle.

That the "recycling" of said vehicle was caused by the negligence of the City of Milwaukee Tow Lot on account of its unknown employees for "recycling" said vehicle before the fifteen (15) day deadline and not notifying either April Bhayana or Laureen D.
