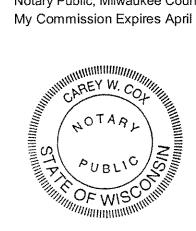

Notice is hereby given that an ordi-nance (passage of which is now pending) was introduced at the May 25, 2004 meeting of the Milwaukee Com-mon Council, the essence of which is as

Substitute ordinance relating to the change in zoning from industrial Mixed (IM) to a Detailed Planned Development DFD) known as First Mace Condomini ums, on land located on the West Side of South Ist Place and North of West Seeboth Street, in the 12th Aldermanic

The Mayor and Common Council of the City of Milwaukee ("Common Coun-cil") do ordain as fallows:

Part I. There is added to the Mil-waukee Code of Ordinances ("Code") a new section to read as follows: Section 295-907(2)(b) 0053

I) In accordance with the provisions of Section 295-907 of the Code relating to the establishment of planned development districts, the Common Countries of the Countries of t cil approves the subject Detailed Planned Development, a copy of which is attached to this Common Council File as Exhibit A which is on tile in the office of the City Clerk and made a part as though fully set forth herein.

(2) The zoning map is changed for the area bounded and described by the zoning line within the right-of-way of West Seeboth Street, the zoning line within the right-of-way of South 1st Place, the zoning line within the Mil-waukee River and the zoning line within the South Menomonee Canal.

(3) The requirements set forth in said detailed plan attached to this Common Council File as Exhibit A, constitute the zoning regulations for the area contained in such planned development district described, provided further, that the effect of the approval of such detailed plan is that such plan shall limit and control construction location use and control construction, location, use and operation of all land and structures included within the detailed plan to all conditions and limitations set forth in

such detailed plan. Part 2 Any persons, firm, company or corporation owning, controlling, or managing any building or premises wherein or whereon there shall be

placed or there exists anything in vio-lation of the terms of this ordinance, or who shall build contrary to the plans or specifications submitted to and approved by the Commissioner of the De-partment of City Development or any person, firm, company or corporation who shall omit, neglect or refuse to do any act required in this ordinance shall be subject to the penalties provided in Section 200-19 of the Code. Part 3. In accordance with the provi-

sons of Section 295-907 of the Code the City Clerk shall transmit a certified copy of the action taken by the Com-mon Council to the Department of City

Development. Part 4. It any section, subsection, ser-tence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and Independent provision, and such holding shall not affect the validity of the remaining portions. The Common Council declares that it would have passed this ardinance and each section, subsection, sentence, clause, phrase or portion irre-spective of the lact that any one or more sections, subsections, sentences, clauses or phrases or other portions be declared void or invalid
