

Mark is a lifelong resident of Milwaukee who graduated from Washington High School. Mark and his wife, Charlotte, are the proud parents of four adult daughters and the proud grandparents of three grandsons. The eldest grandson is attending Gwen T. Jackson School in MPS.

Mark became a Firefighter in 1980 and retired after a stellar career in 2008. He held multiple positions, from Firefighter up to Assistant Chief. As the Assistant Chief, he provided leadership to the 1,100 members of the Milwaukee Fire Department. Mark managed an annual budget of \$92 million and was responsible for supervising six bureaus — Administration, Communications, Training, Emergency Medical Services/Special Operations, Equipment Repair/Maintenance, and Firefighting.

Mark has continued being an active member of the community. He has worked with the Helen Bader Foundation's Homework First Program at Phillis Wheatley School. He has tutored MPS high-school students in reading comprehension. He sits on the Advisory Committees of the Blood Center of Southeast Wisconsin's Community Blood Donation Drive Campaign and Make A Difference of Milwaukee. He has worked with Marquette University's Mediation Program.

Mark is committed to the education of the students of MPS. With the help of parents, teachers, students, and the Milwaukee community, he feels we can make it happen.



# Ellen M. Gilligan President and CEO



Ellen joined the Greater Milwaukee Foundation in 2010 as its third president and CEO. The Foundation is one of the first community foundations in the country and serves a four-county area in Wisconsin that includes Milwaukee, Washington,

Waukesha and Ozaukee counties. With more than \$847 million in assets, it also is among the largest. The Foundation and its donors made grants of \$38.9 million in 2013, the highest grantmaking year in the Foundation's history.

For a century, the Foundation has helped individuals, families and organizations realize their philanthropic goals and make a difference in the community, during their lifetimes and for future generations. It has more than 1,200 individual charitable funds, each created by donors to serve the charitable causes of their choice. The Foundation also deploys both human and financial resources to address the community's most critical needs and ensure the region's vitality.

Under Ellen's leadership, the Foundation organized and launched Milwaukee Succeeds, a communitywide educational partnership involving more than 300 partners that focuses on success for every child in every choice, charter and public school, from cradle to career. She also introduced Match Day, an online giving event supporting food and shelter agencies that has raised more than \$7.6 million since 2012.


In 2014, on the eve of the Foundation's centennial year, it received a \$100 million gift, the largest in its history and one that positioned the Foundation as a philanthropic hub for giving in southeastern Wisconsin.

Prior to joining the Foundation, Ellen spent 12 years at the Greater Cincinnati Foundation, most recently as its vice president of Community Investment and president of the \$30 million HealthPath Foundation. Ellen has spent her career in the nonprofit sector, serving in leadership roles at the United Way of Greater Cincinnati, United Way Worldwide, The Eisenhower Foundation and the Local Initiatives Support Corporation. She is dedicated to advancing efforts that provide opportunity for individuals and families through education, economic opportunity and inclusion.

Ellen is a member of the Greater Milwaukee
Committee and the national LISC board, and is
a board director of the United Way of Greater
Milwaukee & Waukesha County. She also has
served as co-chair of the LISC Advisory Committee
in Cincinnati, on the board of Lighthouse Youth
Services, and chair of New Life Properties. Ellen is a
graduate of Leadership Cincinnati. Her philanthropic
leadership includes past service on the Ohio
Grantmakers' Forum Education Task Force and the
Community Foundation National Task Force on
Community Leadership.

Ellen attended Boston College and received her undergraduate from the University of Colorado. She and her husband, Charlie DeSando, have two collegeage sons.

#### BIOGRAPHY

Newly elected state Senator Nikiya Q. Harris (D- Milwaukee) was sworn in on Monday, January 7 as a member of the 2013-2014 Wisconsin Legislature. Ms. Harris replaces former Senator Spencer Coggs, who left the seat to run successfully for City of Milwaukee Treasurer.

Senator Nikiya Harris is a Milwaukee Native who cares deeply for the needs of her family and community. After her loss of her mother over ten years ago, Nikiya raised three of her younger siblings herself, determined to keep them out of the foster care system. A former Milwaukee County Supervisor, Senator Harris graduated from the University of Wisconsin-Milwaukee with a bachelor sidegree in community education and a master's in adult education.

Sen. Harris supports legislation to create family-supporting jobs and fund public education, and has marched with unions, their members and supporters in Madison against the elimination of collective bargaining. As a County Supervisor, Nikiya led the fight for voters' rights by opposing Governor Scott Walker's voter ID law. She fought to stop voters from being turned away from the polls due by making it possible for 5,000 Milwaukee County, residents to receive a free birth certificate.
