In re the Class "B" Tavern license, Public Entertainment Premises, and Food Dealer - Restaurant licenses of:

L AND T, INC. as the Licensee for the licensed premises known as Leden's Villard Inn, located at 4923 West Villard Avenue, Milwaukee, Wisconsin

SWORN CHARGES BY CHIEF OF POLICE FOR REVOCATION OF LICENSES

Pursuant to Wisconsin Statutes Section 125.12 and Sections 90-12, 108-11, 68-21 and 85-4, Milwaukee Code of Ordinances ("MCO"), Chief of Police Edward Flynn, a City of Milwaukee resident and interested party, by Captain Jutiki Jackson, Commander of Police District 7, City of Milwaukee resident and interested party, being first duly sworn and upon his oath, respectfully charges the following based upon review of official Milwaukee Police Department ("MPD") reports drafted in the ordinary course of business, review of documents received by MPD District 7, and communication with other police and municipal officials:

- 1. Theresa Tucker (DOB 09/27/1953) is the agent of L and T, Inc. (collectively, the "Licensee"), the holder of a Class "B" Tavern license, a Public Entertainment Premises license, and a Food Dealer Restaurant license for the licensed premises known as Leden's Villard Inn (hereinafter, the "Villard Inn") located at 4923 West Villard Ave, Milwaukee, Wisconsin. Theresa Tucker and Tucker Leden are listed as each holding a 50% ownership interest in L and T, Inc.
- 2. On October 12, 2014, at approximately 12:55 a.m., MPD responded to the Villard Inn regarding a shots fired complaint. Officers spoke with Steven Riser who represented himself as the owner. Mr. Riser stated he observed a subject standing in the middle of Villard Avenue in

front of the parking lot at 4949 West Villard Avenue firing three shots into the air. While responding to the shots fired complaint, officers observed a female patron with blood on her face, shirt, and pants. The patron told officers that she was assaulted by an unknown male while attempting to exit the bar. The patron believed she was struck approximately nine times. She also told officers she observed "a lot of family members fighting," including her niece who she observed was being struck and "stomped on." Officers personally observed large crowds that were fighting and being disorderly when they arrived. Officers attempted to view the Villard Inn's surveillance cameras but a fuse went out and shut down the system. When officers returned later that evening to view the cameras, Mr. Riser advised officers the cameras were still not working. When officers returned on October 23, 2014 to review the cameras, the video was no longer available.

- 3. Mr. Riser does not hold any licenses issued by the City of Milwaukee, including a Class "B" Manager's License.
- 4. On December 5, 2014, at approximately 2:30 am, MPD responded to the Villard Inn regarding a shooting complaint. Officers located 8 9mm casings in the parking lot at 4949 West Villard Avenue, which upon information and belief, the Licensee uses as parking at night for tavern patrons and employees per an agreement the Licensee has with Word of Grace Fellowship church. Police spoke with Mr. Riser, who stated he was the manager of the Villard Inn, about the incident. Mr. Riser stated he and his employees heard shots fired outside of the location but that they did not call the police. It was determined there was a fight outside of the tavern in the parking lot when someone shot several rounds. One of the rounds struck the victim in the back of the neck while she was driving away from the Villard Inn. The victim was a patron of the tavern. According to the victim, she was walking to her car with a friend and she could

hear people arguing in the parking lot at 4949 West Villard Avenue immediately prior to getting in a vehicle and being struck by a bullet.

- 5. On December 12, 2014, the Milwaukee Police Department met with the Licensee and Mr. Riser to discuss the recent violent activity and abatement strategies. At the meeting, Mr. Riser admitted to not having a Class "B" Manager's license and committed to obtaining one.
- 6. On December 29, 2014, at approximately 8:00 pm, MPD responded to the Villard Inn regarding a complaint of a juvenile party. MPD spoke with Mr. Riser and Anthony Williams. Mr. Riser stated that he allowed Mr. Williams to host a party at the Villard Inn for his daughter. Mr. Riser also stated he covered the alcohol at the bar with a sheet. An MPD officer observed that one of the sheets appeared to have fallen off of the liquor and was on the floor. Mr. Williams stated he was charging the guests \$2.00 per person to enter the party. A capacity check revealed approximately 120 patrons in the Villard Inn, with approximately 110 of the patrons under the age of 21. The party was closed down and the patrons were instructed to leave. While the patrons were leaving, one of the patrons hung out of a vehicle window and displayed a firearm, which was later determined to be a BB gun. That individual was cited for disorderly conduct (case # 15006608). Two individuals who had left the tavern were shot in the 4100 block of North Sherman Boulevard. It is unknown whether the shooting was related to any event that occurred at the Villard Inn.
- 7. MPD was not notified by Mr. Riser, Mr. Williams, the Licensee or any affiliate of the Villard Inn regarding the presence of underage persons during the times when no alcohol beverages are sold. This is in violation of MCO 90-19.5. In addition, MCO 90-19-5-2-c requires "[a]ll alcohol beverages on tables shall be removed."
 - 8. On January 3, 2015, at approximately 2:01 a.m., MPD responded to the Villard

Inn regarding a shooting complaint. While on scene, MPD officers observed two casings in the parking lot at 4949 West Villard Avenue. The Licensee was not at the scene; however, Mr. Riser was and identified himself as the owner of the bar. Mr. Riser denied knowing what caused the shooting. According to the shooting victim, she was leaving the tavern with a friend and was shot in the shin on a grassy patch dividing the Villard Inn and the parking lot at 4949 West Villard Avenue. The victim was a patron at the bar and was only 18 years old. A witness to the incident was also a patron at the tavern and was only 17 years old. The Licensee was cited and convicted of Presence of Minor at Licensee Premises (case # 15003993). A copy of the City of Milwaukee Municipal Court website showing the guilty finding is attached as **Exhibit A**.

- 9. On January 17, 2015, at approximately 12:46 a.m., MPD and the Department of Neighborhood Services ("DNS") conducted a tavern check of the Villard Inn. During the investigation, MPD and DNS observed evidence that the Villard Inn might be buying liquor from a non-wholesaler/distributor in violation of state law.
- 10. On February 4, 2015, at approximately 11:46 a.m., MPD, DNS and the Department of Revenue ("DOR") conducted a follow-up investigation from the observations made by MPD and DNS on January 17, 2015. Upon request from MPD, Mr. Riser responded to the Villard Inn. Mr. Riser produced receipts of the liquor purchases from a local store in violation of state law. As a result, over 125 bottles of liquor and malt beverages were confiscated by the DOR for violations of excise laws. An MPD officer asked Mr. Riser if he had acquired his Class "B" Manager's license as he had committed to while meeting with MPD. Mr. Riser stated that he went to City Hall on January 30th to file. MPD contacted the License Division who confirmed Mr. Riser has not held and does not hold a Class "B" Manager's license. Mr. Riser signed the Field Report as the "person in charge of licensed premises." Photographs of the

alcohol confiscated, the DOR Field Report of the violations, the DOR Property Receipts, and Mr. Riser's sale receipts are attached as **Exhibit B**.

- 11. On February 4, 2015, the Health Department conducted an inspection of the Villard Inn's cooking area and food and found six violations. The order was signed by Mr. Riser as the "Operator Signature." A copy of this report has been attached as **Exhibit C**.
- 12. On February 15, 2015, at approximately 1:16 a.m., an MPD squad car was driving by the Villard Inn when officers observed people running away from the Villard Inn parking lot. Approximately thirty seconds later, the same officers heard two gunshots, which they believed came from the Villard Inn parking lot. Investigation revealed a security guard put a group of people out of the bar prior to the shots being fired. The security guard stated after he put the group out of the bar he observed one of the people firing shots in the parking lot. The security guard believed the individual was affiliated with the gang known as the "Hundreds." MPD officers located spent bullet casings in the Villard Inn parking lot as well as a fired bullet.
- Inn regarding a shooting complaint. Investigation revealed that there was a repast taking place at the Villard Inn, and an argument began by the front door. Several subjects ran out the side door and multiple shots were fired from the parking lot by multiple shooters. The victim was shot in the parking lot. Other people at the Villard Inn then proceeded to drag the victim inside the Villard Inn. MPD recovered 27 bullet casings at the scene. Multiple attendees at the Villard Inn were under the age of 21. A copy of the surveillance video from the Villard Inn is attached as **Exhibit D**.
- 14. MPD was not notified by Mr. Riser, the Licensee or any affiliate of the Villard Inn regarding the presence of underage persons during the times when no alcohol beverages are

sold. This is in violation of MCO 90-19.5.

- 15. Pursuant to MCO 80-10, the Villard Inn has been designated a nuisance property.
- 16. Based on the aforementioned violent activity at and around the Villard Inn, MPD has deployed squad cars to monitor the property on certain Thursday Sunday nights. This is a drain on City resources.
- 17. The Villard Inn, particularly during closing time, has been the source of loud and raucous noise, which has had a substantial adverse effect upon the health, safety or convenience and prosperity of the immediate neighborhood.
- 18. The Villard Inn is operated in such a manner that it constitutes a public nuisance and the conduct associated with the licensed premise has had a substantial adverse effect on the health, safety or convenience and prosperity of the neighborhood.

BASED UPON the October 12, 2014 shots fired and fight, the December 5, 2014 shooting and fight, the December 29, 2014 underage party and disorderly conduct, the January 3, 2015 shooting and presence of minors at the Villard Inn, the February 4, 2015 violation of state excise laws, the February 15, 2015 shots fired, the February 18, 2015 shooting and fight, the failure of Mr. Riser to seek and obtain either a transfer of the Class "B" Tavern license or obtain a Class "B" Manager's license, the drain on police resources and the loud and raucous noise, which has cumulatively had a substantial adverse effect upon the health, safety or convenience and prosperity of the immediate neighborhood;

THE CHIEF OF POLICE, by his designee, respectfully requests the immediate revocation of the Class "B" Tavern license, Public Entertainment Premises license and Food Dealer – Restaurant

license relative to the above-referenced Licensee and licensed premise because:

- 1. Pursuant to Wis. Stat. Sec. 125.12(2)(ag)2, the Licensee has kept a disorderly and riotous house;
- 2. Pursuant to MCO 90-12-1-d, the Licensee has: (1) connived, colluded or agreed with Mr. Riser to enable Mr. Riser to conduct the business operations of the Villard Inn in the name or under the license of the Licensee in violation of MCO 90-9; (2) permitted the presence of underage persons in the places of sale, and been convicted thereof, in violation of MCO 90-19; (3) permitted the presence of underage persons during times when no alcohol beverages are sold in violation of MCO 90-19.5; and (4) permitted a disorderly premises in violation of MCO 90-21;
- 3. Pursuant to MCO 68-21-9-g, 68-21-9-k, 85-4-4-c and 108-11-3, the Villard Inn has contributed to and been the source of congregation of persons which has resulted in one or more of the following: disturbance of peace, assaults, battery, loitering, illegal parking, and loud noises at times when the licensed operation is open for business;
- 4. Pursuant to MCO 68-21-9-f and MCO 90-12-1-e, the Licensee, or an agent on behalf of the Licensee, purchased and sold liquor from a non-distributor in violation of the excise laws of the state, including, but not limited to, Wis. Stat. § 125.69;
- 5. Pursuant to MCO 85-4-4-c and 90-12-1-f, the Villard Inn is operated in such a manner that it constitutes a public or private nuisance or that conduct on the Villard Inn premises, including but not limited to loud and raucous noise, has had a substantial adverse effect upon the health, safety or convenience and prosperity of the immediate neighborhood; and
- 6. Pursuant to MCO 68-21, 85-4-4, 90-12 and 108-11, the misuse of the licensed premises

unreasonably interferes with the best interests and good order of the City.


