This office is in receipt of your claim in the amount \$316.80, relating to the towing of your truck on July 28, 2004 when it sank into a void at North 3rd Street and West Abert Place.

Our investigation reveals that the Milwaukee Water Works records indicate that a possible water main break in the area of 3864 North 3rd Street was reported to them at approximately 3:15 p.m. on July 28, 2004. Their investigator was immediately dispatched to the location. He arrived within 45 minutes and found your truck had sunk approximately 5 fee into a void created by the water main break. He completed an emergency shut-off so that the truck could be towed. After the truck was towed, he throttled the main in order to find the location of the leak. A repair crew arrived at the site by 5:00 p.m. and made the necessary repairs. The Milwaukee Water Works responded to this main break in a timely manner. They also followed standard procedures regarding repair activity. As such, the City cannot accept liability for your damages. Accordingly, we are denying your claim.
