a. Award of Contract C98039C01, Construction of Conveyance Pump Station Improvements  
Contract C98039C01 for Construction of Conveyance Pump Station Improvements is awarded to J.F. Ahern Company in the amount of \$3,567,000, and the Executive Director is directed to execute the contract on behalf of the District.

b. Approval of Amendment No. 1, Contract C05020D01, Providence Avenue MIS Replacement

g. Award of Contract M03008P03, Satellite Municipality Capacity, Management, Operation, and Maintenance (CMOM) System Evaluation and Capacity Assurance Plan (SECAP) Analyses

The Executive Director is authorized and directed to negotiate and execute Contract M03008P03, with Camp Dresser & McKee for Satellite Municipality Capacity, Management, Operation, and Maintenance (CMOM) System Evaluation and Capacity Assurance Plan (SECAP) Analyses in an amount not to exceed \$1,817,116.

Award of Contracts J06014C01, Jones Island Wastewater Treatment Plants Instrumentation and Control Upgrades; J06014C03, Instrumentation and Control Resident Engineer Services; J06014C04, Instrumentation and Control Resident Inspector Services; and J06014C05, Support Services During Construction of Instrumentation and Control Upgrades

The following contract is awarded and the Executive Director is directed to execute the contract on behalf of the District:

1. Contract J06014C01 for construction of Jones Island Wastewater Treatment Plant Instrumentation and Control Upgrades to Staff Electric Company in the amount of \$8,849,000.00 and further, deny the bid protest from Pieper Electric Inc.
