Subject: Common Council Resolution File Number 030313

Dear Honorable Members:

Return herewith is Common Council Resolution File 030313, being a petition from Holmes Simpson for a special privilege to allow a trash enclosure to be located in the public right-of-way adjacent to the premise of 1437 East Brady Street.

The enclosure is essentially a 3-sided fence. Our recent field viewing reveals that there are two enclosures. The larger one is for the metal dumpsters and the smaller one is for recycling containers similar to a residential type. We also found several wooden, so-called moveable stands into which planters with evergreens have been inserted. In addition there are several "whiskey barrel" moveable planters flanking the other planters.

These items are placed within the fully concrete paved, 13-foot side walk area on the south side of East Brady Street. One enclosure centered approximately 43 feet west of North Farwell Avenue, extends 5 feet 8 inches into the public way and has a moveable gate on the north side of the enclosure to allow access to the dumpster. The second enclosure, centered approximately 54 feet west of North Farwell Avenue, extends 4 feet 11 inches into the public way and has a moveable gate on the west side of the enclosure to allow access to the dumpsters. A total of nine moveable planters, four of them square and five round, currently are located within the sidewalk area. These planters are centered 33 feet, 35 feet, 50 feet, 67 feet, 70 feet, 81 feet, 93 feet, 96 feet and 100 feet west of the westline of North Farwell Avenue and extend a maximum of 3 feet 8 inches into the public right-of-way. Finally, a 7.6-foot wide concrete step was found to encroach into the public way by one foot. A minimum clear path of approximately 5 feet exists between the most easterly fence enclosure and a City harp light. To the Public Improvements Committee December 1, 2004 Page 2

We are not aware that the presence of the aforementioned items has had an adverse effect upon the general use of the public right-of-way. We have, therefore, prepared the attached special privilege resolution, which, if adopted, will formally allow said items to occupy the public right-of-way.
