FINDINGS OF FACT

1. Amjad Anwar (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver's Licens e in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, October 31, 2004.

- 2. An untimely application to renew said license was filed with the Office of the City Clerk on November 9, 2004.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and Section 349 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On November 10, 2004, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
- 4. On November 22, 2004, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 100 of the Milwaukee Code of Ordinances of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on December 7, 2004, commencing at 8:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee appeared and admitted receipt of the police report.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On September 7, 2004 the Wisconsin Department of Transportation suspended the licensee's driver's license for a period of two months as a

result of the accumulation of points on his driving record. The licensee's convictions are as follows:

October 11, 2004	defective speedometer	2 point violation
September 20, 2004	defective speedometer	2 point violation
October 25, 2004	excessive speed	6 point violation
September 19, 2003	speeding	3 point violation
April 29, 2003	speeding	3 point violation

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter of the Wisconsin Statutes Sec. 349.24 and Chapter 100 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Amjad Anwar, has not met the criteria of Wis. Stat. Sec. 349.24 or Chapter 100 of the Milwaukee Code of Ordinances to allow renewal of the Public Passenger Vehicle Driver's Licens e held by the licensee without undergoing a suspension of said license. The Committee finds the police report that could form the basis of nonrenewal or suspension of this license to be true.
- 3. The Utilities and Licenses Committee recommends that the full Common Council exercise its discretion renew the Public Passenger Vehicle Driver's License held by Amjad Anwar with a fifteen (15) day suspension based upon the danger the activities of the licensee represents to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee by a vote of three (3) ayes and two (2) excused, recommends that the Public Passenger Vehicle Driver's License of A mjad Anwar be renewed with a fifteen (15) day suspension based upon the police report.

Said suspension is to be in effect between midnight, December 21, 2004 and midnight, January 5, 2005.

FINDINGS OF FACT

- 1. Fnu Bhupinder (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expired on October 31, 2004.
- 2. An untimely application to renew said license was filed with the Office of the City Clerk on September 9, 2004.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed an objection to renewal of this license dated October 13, 2004. That objection could form the basis of non-renewal or suspension of this license.

On October 27, the City Clerk's Office provided notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of police objections that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on November 9, 2004 at 8:15 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear nor was he represented by counsel. Mr. Bhupinder requested that the matter be rescheduled.

The matter was rescheduled for a second hearing on December 7, 2004 at 8:00 a.m. At that date and time the applicant again failed to appear.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. Notice was sent to Fnu Bhupinder at 4639 West Rice Street, Milwaukee, WI 53216 along with a copy of the police report on November 22, 2004 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, WI 53202. The address of 4639 West Rice Street, Milwaukee, WI 53216 was the address given by the applicant on his renewal application. The notice included a copy of the police report. The licensee failed to appear at the hearing and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.
 - B. On April 29, 2004, the Wisconsin Department of Transportation suspended the applicant's driver's license for a period of two months as a result of the accumulation of points on his driver's record.

The applicant's convictions are as follows (by conviction date):

May 12, 2000 violation of restriction	3 point violation
August 7, 2003 imprudent speed	8 point violation
April 14, 2004 imprudent speed	4 point violation
June 3, 2004 defective speedometer	2 point violation

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and make Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Fnu Bhupinder, has not met the criteria of Wis. Stat. Sec. 349.24 or Chapter 100 of the Milwaukee Code of Ordinances to allow renewal of the Public Passenger Vehicle Driver's License held by the licensee. The Committee finds the police report that could form the basis of nonrenewal or suspension of this license to be true.
- 3. The Utilities and Licenses Committee recommends that the full Common Council exercise its discretion to not renew the Public Passenger Vehicle Driver's License held by Fnu Phupinder based upon the danger the activities of the licensee represents to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and two (2) excused, recommends that the Public Passenger Vehicle Driver license of Fnu Bhupinder not be renewed based on nonappearance and the police objection.

FINDINGS OF FACT

1. James Trotter (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, October 31, 2004.

- 2. An application to renew said license was untimely filed with the Office of the City Clerk on November 5, 2004.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and Sec. 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On November 10, 2004, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
- 4. On November 22, 2004, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on December 7, 2004, commencing at 8:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee failed to appear.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

- A. Notice of the hearing as well as a copy of the police report was sent to James Trotter at 105 West Mitchell Street, Milwaukee, Wisconsin 53204 on November 22, 2004 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 105 West Mitchell Street, Milwaukee, Wisconsin 53204 is the address given by the applicant on his application. The envelope was not returned to the License Division by the United States Postal Service. The licensee failed to appear at the hearing on December 7, 2004.
- B. The licensee was convicted of operating a taxi cab without a taxi cab permit on March 5, 2002. The applicant has not appeared in court to address that citation issued for November 8, 2001.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Sec. 349.24 of the Wisconsin Statutes and Chapter 100 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the license of James Trotter has not met the criteria of Wis. Stat. Sec. 349.24 or Chapter 100 of the Milwaukee Code of Ordinances to allow renewal of the Public Passenger Vehicle Driver's Licens e held by the licensee. The Committee finds the police report that could form the basis of nonrenewal or suspension of this license to be true, and also notes the licensee failed to appear for his hearing on the police report.
- 3. The Utilities and Licenses Committee recommends that the full Common Council exercise its discretion not renew the Public Passenger Vehicle Driver's License held by James Trotter based upon the danger the activities of the licensee represents to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and two (2) excused, recommends that the Public Passenger Vehicle Driver's License not be renewed based on non-appearance and the police report.

The matter was scheduled for a hearing on the Police Department report on December 7, 2004, commencing at 8:30 a.m. in Room 301B of City Hall. At said date, time and place, the licensee failed to appear.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. Notice of the hearing as well as a copy of the police report was sent to Jessica J. Polski at 2672 C North Pierce Street, Milwaukee, Wisconsin

53212 on November 29, 2004 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 2672 C North Pierce Street, Milwaukee, Wisconsin 53212 is the address given by the applicant on her application. The envelope was not returned to the License Division by the United States Postal Service. The licensee failed to appear at the hearing on December 7, 2004.

B. On June 8, 2004 the licensee was convicted of sales to an underage person for an incident occurring on October 29, 2003. On August 23,2004 a bench warrant was issued for the applicant.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- Based upon the above facts found, the Committee concludes that the licensee, Jessica J. Polski, has not met the criteria of Chapter 125, Wis. Stats. or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of her Class "D" Bartender's license, re commends that the full Common Council of the City of Milwaukee exercise its discretion to deny renewal of the Class "D" Bartender's license held by Jessica J. Polski based upon her non-appearance and the danger that she represents to the health safety and welfare of the citizens of the City of Milwaukee by her conduct as evidenced in the police report. The Committee finds the police report to be true.
- The Committee recommends that the full Common Council of the City of Milwaukee exercise its discretion to deny renewal of the Class "D" Bartender's license held by Jessica J. Polski based upon her non-appearance and the danger that she represents to the health safety and welfare of the citizens of the City of Milwaukee by her conduct as evidenced in the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) excused recommends that the Class "D" Bartender Li cense not be renewed based on nonappearance and the police report.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Robert P. Richardson, has not met the criteria of Wis. Stat. Chapter 125 or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender License held by the licensee bec ause of the police report and nonappearance. The Committee finds the police report to be true.
- 3. The Committee recommends that the full Common Council exercise its discretion to not renew the Class "D" Bartender license held by Robert P. Richardson based upon nonappearance and the danger that his activities, as set forth in the police report, represent to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) excused recommends that the Class "D" Bartender Li cense not be renewed based on non-appearance and the police report.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. Notice of the hearing as well as a copy of the police report was sent to Scott K. Birkholz at 4058 County Trunk Q, Richfield, Wisconsin 53017 on

November 22, 2004 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 4058 County Trunk Q, Richfield, Wisconsin 53017 is the address given by the applicant on his application. The envelope was not returned to the License Division by the United States Postal Service. The licensee failed to appear at the hearing on December 7, 2004.

- B. On December 12, 2001 the applicant was stopped and arrested for operating an auto while intoxicated. On October 20, 2003 he was found guilty of this charge in Washington County Circuit Court and fined \$936.00, sentenced to 25 days in jail and had his driver's license revoked for six months.
- C. On December 27, 2001 the applicant was stopped and arrested for operating an auto while intoxicated. On March 31, 2003 he was found guilty of this charge in Milwaukee County Circuit Court and fined \$642.00 and had his driver's license revoked for six months.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee recommends that the licensee, Scott K. Birkholz, has not met the criteria of Chapter 125, Wis. Stats. Or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Class "D" Bartender license because of the police report that could form the basis of nonrenewal or suspension of this license and nonappearance. The Committee finds the police report to be true.
- 3. The Committee recommends that the full Common Council exercise its discretion to not renew the Class "D" Bartender license held by S cott K. Birkholz based upon nonappearance and the danger that his activities represent to the health, safety and welfare of the citizens of the City of Milwaukee.

The applicant was represented by Attorney Joseph Schubert, 788 North Jefferson, Suite 700, Milwaukee, WI 53202. On November 9, 2004 the matter was held to the call of the chair for details as to ownership interests.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On December 11, 2003 at 4:30 p.m., officers of the Milwaukee Police Department made a lawful inspection of the licensed premises at 2901 North 23rd Street in the City and County of Milwaukee, Wisconsin. Officers arrested Mr. Heath Wasserman who was in the bar for carrying a concealed weapon. An incident report was filed.
 - B. On March 28, 2004 at 2:46 a.m. officers of the Milwaukee Police Department responded to the licensed premises at 2901 North 23rd Street in the City and County of Milwaukee, Wisconsin ("Big V's Sports Lounge") regarding a shooting. The investigation revealed that a shooting occurred at the rear of the licensed premises. The shooting involved three patrons of the tavern. The applicant stated that no fight occurred inside the tavern nor was there a shooting inside the tavern, only that the actors had been in the tavern for a party. At hearing, the police department indicated that the tavern did not appear to be involved in the shooting
 - On June 6, 2004 at about 1:37 a.m. unknown person(s) fired several shots C. into the licensed premises at 2901 North 23rd Street in the City and County of Milwaukee, Wisconsin ("Big V's Sports Lounge") striking a patron in the lower leg. The criminal investigation revealed that at 10:45 on June 5, 2004 two patrons began fighting, left the tavern, and began arguing with each other across the street from the tavern. The security person observing this did not call the police because he believed it was no longer the tavern's responsibility. About an hour later one of the patrons that had been involved in the argument returned to the front of the tavern yelling that he was looking [for the person he had argued with earlier]. This individual was heard to threaten to shoot at the tavern. At approximately 1:35 a.m. the son of the first participant in the fight, and an accomplice, approached the tavern armed with a handgun and shotgun and fired shots into the tavern. A passing squad observed the shooting and arrested one of the suspects.
 - D. On July 8, 2004, officers of the Milwaukee Police Department investigated a battery complaint occurring at the licensed premises at 2901 North 23rd Street in the City and County of Milwaukee, Wisconsin "Big V's Sports Lounge"). The investigation revealed that at approximately 1:30 a.m. on July 9, 2004, the victim refused a man's advances. The man struck her in the mouth with a bottle cutting her upper lip. The applicant stated that the man whose name was "Mackie", had struck the woman but the applicant did not call the police.
 - E. On September 6, 204 at approximately 1:28 a.m. officers of the Milwaukee Police Department were dispatched to a shooting at the licensed premises at 2901 North 23rd Street in the City and County of Milwaukee, Wisconsin ("Big V's Sports Lounge"). The criminal investigation revealed that at approximately 1:00 a.m. the subject was

- denied entry into the bar because he refused to be searched. About 30 minutes later the subject was observed by a neighbor discharging a handgun at the premises. Two patrons suffered non-life threatening injuries. No arrest has been made regarding this matter.
- F. On November 26, 2004 at approximately 1:50 a.m., an individual had just left the licensed premises at 2901 North 23rd Street in the City and County of Milwaukee, Wisconsin ("Big V's Sports Lounge"). That individual was shot in the head as he entered his vehicle parked across the street. No further information is available. Regarding this matter, at hearing, the Committee was advised that the license for this premises expired on October 13, 2004. At hearing the Committee was advised that the Milwaukee Police Department had issued a citation to the applicant minutes before his hearing on December 7, 2004 regarding operating without a license on November 26, 2004.
- G. Regarding the incident of November 26, 2004, the applicant maintains that he was not open, but that rather he had a few family members present in the premises. However, the applicant did indicate that certain members the party whom the police department was able to identify were not, in fact, family members.
- H. An affidavit was filed in this proceeding from Lyle McDowell indicating that he is the sole and only owner of the location, and that testimony received on November 9, 2004 from his "partner" indicates that that individual is merely an employee and has no financial stake or ownership interest in the license premises.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Lyle A. McDowell, for the licensed premises at 2901 North 23rd Street ("Big V's Sports Lounge") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "B" Tavern license without undergoing a fifteen (15) day suspension of said license. The Committee finds the police report to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its discretion to renew the Class "B" Tavern license of Lyle A. McDowell for the premises at 2901 North 23rd Street in the City and County of Milwaukee, Wisconsin ("Big V's Sports Lounge") with a fifteen (15) day suspension.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes recommends that the Class "B" Tavern license held by Lyle A. McDowell for the premises at 2901 North 23rd Street in the City and County of Milwaukee, Wisconsin ("Big V's Sports Lounge") be renewed with a fifteen (15) day suspension.

Said suspension is to be in effect from midnight, December 21, 2004 through midnight, January 5, 2005.

Re: Report of the Renewal Application of Alfredo Garcia, Agent for Almar Enterprises, Inc. 5471 South Honey Creek Drive, Greenfield, Wisconsin for a Class "B" Tavern license and Tavern Dance renewal application for the premises located at 2239 S. 13th Street, in the City and County of Milwaukee, Wisconsin ("Club Galaxia").

FINDINGS OF FACT

- 1. Alfredo Garcia (hereinafter the "Licensee") doing business at 2239 S. 13th Street in the City and County of Milwaukee, Wisconsin ("Club Galaxia"). Said license expires at midnight, December 17, 2004.
- 2. An application to renew said license was filed with the Office of the City Clerk on October 27, 2004.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was a Milwaukee Police Department report dated October 28, 2004, which could form the basis for non-renewal or suspension of the license. There were also neighborhood objections to loitering, littering, disturbing the peace, loud music, noise, cars screeching in the parking lot, traffic and parking problems, criminal activity and violence caused by patrons, vandalism, car break-ins, damage to private property (including bullet holes in residential properties), public urination, gun and knife related incidents, shootings, fights, allowing patrons to take open intoxicants off the license premises and conduct which is detrimental to the health, safety, and welfare of the neighborhood.
 - 4. On November 3, 2004, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of police objections that could form the basis for suspension or non-renewal of the license of the Licensee along with the

neighborhood objections. A copy of the police report was included. The matter was scheduled for a hearing on the police objections on November 9, 2004 at 3:30 p.m. in Room 301B of the third floor of City Hall. At said date, time and place, the licensee did not appear and was not represented by counsel. Based on the testimony of the neighbors and the police report and nonappearance, the Utilities and Licenses Committee recommended nonrenewal of the license. The matter was considered by the Milwaukee Common Council on November 23, 2004. At that time the licensee appeared and was represented by Attorney Narcisco L. Aleman, 925 East Wells Street, Suite 617, Milwaukee, WI 53202. Before the Common Council the license applicant requested an opportunity to actually appear and have the matter reheard by the Utilities and Licenses Committee. The licensee indicated he was in Mexico and for that reason did not appear. On November 23, 2004, by vote of fifteen (15) ayes and zero (0) noes the Common Council returned this matter to the Utilities and Licenses Committee for further proceedings.

- 5. On December 1, 2004, the City Clerk's Office again provided notice to the licensee of the report of the Milwaukee Police Department as well as the neighborhood objections, and also provided a copy of the transcript of the proceedings of November 9, 2004 and requested proof that the applicant was actually in Mexico between November 3, 2004 and November 11, 2004.
- 6. The matter was set for a hearing on the police department objections as well as the neighborhood objections for December 7, 2004 at 3:30 p.m. The licensee appeared and was represented by Attorney Narcisco L. Aleman.
 - A. Corporate officer Mari Garcia, on November 18, 1997, was warned for the possession of a Gambling Machine.
 - B. On Monday, March 9, 1998 at about 8:45 PM vice squad officers of the Milwaukee Police department found an illegal Cherry Master slot machine at the license premises of 1921 W. Mitchell Street, in the City and County of Milwaukee, Wisconsin ("El Presidente"). The husband of the licensee, Alfredo Garcia, was on the scene. He stated that one Heath Wassermann told him that every 20 points of credit on the machine was worth \$1.00. He was advised that this is he how he was to pay off the customers. The machine was confiscated and both subjects were ordered into the district attorney's office. On March 13, 1998 the district attorney decided not to issue charges.
 - C. On Friday, November 27, 1998 at approximately 3:00 AM officers of the Milwaukee police department investigated a battery complaint at St. Francis Hospital. There were three victims who were involved in a fight at the licensed premises at 2201 W. Grant Street in the City and County of Milwaukee, Wisconsin ("Club Vaquero"). Two of the victims were hospitalized in serious condition with head injuries and one victim was treated and released with minor injuries. According to the bartender, Alfredo Garcia, the three injured people became violent with club security when they were

- denied entrance to the tavern. A fight ensued, resulting in injuries to the three men. A criminal complaint was filed.
- D. On Saturday, December 26, 1998 at 1:43 AM officers of the Milwaukee police department were dispatched to a fight at the licensed premises at 2201 W. Grant Street in the City and County of Milwaukee, Wisconsin ("Club Vaquero"). The fight claim was found to be baseless. However, the officers were informed by three patrons that they were missing some property. Alfredo Garcia was on the scene. Criminal complaints were filed.
- E. On Sunday, January 31, 1999 at approximately 2:15 AM officers of the Milwaukee police department conducted a tavern check at the licensed premises of 2201 W. Grant Street in the City and County of Milwaukee, Wisconsin ("Club Vaquero"). On entering the tavern the officers found four underage persons, three of whom were consuming alcoholic beverages. One of the persons was a reported missing juvenile. The posted capacity was 120 persons and 142 persons were inside the premises. The licensee was not on the scene and the bar was being tended by her husband, Alfredo Garcia. The licensee was cited for Presence of Underage persons and Posting of Occupancy/Over Capacity. She was found guilty of both citations and fined \$345.00 on the Presence of Underage Persons and \$650.00 on the Posting of Occupancy/Over Capacity. Both guilty determinations and the fines were imposed on May 20, 1999.
- F. On Thursday, April 15, 1999 Alfredo Garcia went to 1135 S. 16th Street in the City and County of Milwaukee, Wisconsin and punched an individual in the face, accusing him of having an affair with his wife. Alfredo Garcia was cited for Assault and Battery on July 12, 1999, was found guilty and was fined \$330.00.
- G. On Tuesday, December 7, 1999 Alfredo Garcia filed a Renewal Alcohol Beverage license application on which he answered "No" to question #5(a) which asks, in part, if since filing the last application he has been convicted of any municipal ordinance violations. Because of item F, above, Alfredo Garcia was cited for Truth of Statements and Affidavits-Falsifying. On February 23, 2000 he was found guilty and fined \$350.00.
- H. On Sunday, March 19, 2000 at 12:21 AM officers of the Milwaukee Police Department were dispatched the licensed premises at 2239 S. 13th Street, in the City and County of Milwaukee, Wisconsin ("Club Galaxia") to check for minors. No violations were found but the officers observed the tavern to be quite crowded and no occupancy sign was posted. The officers issued a citation to Alfredo Garcia for Posting of Occupancy. The City Attorney's Office refused to issue the citation.

- I. On Saturday, August 19, 2000 at 1:35 AM officers of the Milwaukee police department conducted a tavern check at the license premises of 2239 S. 13th Street in the City and County of Milwaukee, Wisconsin ("Club Galaxia"). Two patrons were found to be underage and cited. The licensee, Alfredo Garcia, was on the premises and was also cited for Presence of Minor Prohibited. On October 10, 2000 he was found guilty and fined \$692.00.
- J. On Saturday, August 26, 2000 at 1:55 AM officers from the Milwaukee police department conducted a tavern check of the licensed premises at 1921 W. Mitchell Street of the City and County of Milwaukee, Wisconsin ("El Presidente"). They observed two patrons who were under the legal drinking age. Both were cited. The officers talked to Mr. Garcia, the husband of the licensee, who stated that the employee who was hired to check ID's did not show up for work. Mr. Alfredo Garcia was also cited for Underage Upon a Class "B" Premises, Licensee Responsibility. On October 19, 2000 he was found guilty and fined \$336.00.
- K. On Sunday, April 28, 2002 officers were dispatched to the licensed premises of 2239 S. 13th Street in the City and County of Milwaukee, Wisconsin ("Club Galaxia") regarding a shooting. The investigation revealed that a security guard had been shot after refusing to allow a patron to enter the bar who did not meet the dress code. The doorman was treated for a gun shot would to the abdomen. The actor was charged with first degree recklessly endangering safety and an incident report was filed.
- L. On Sunday, November 23, 2003 officers of the Milwaukee police department conducted a premises check at the licensed premise of 2239 S. 13th Street in the City and County of Milwaukee, Wisconsin ("Club Galaxia"). The officers observed three females that appeared to be underage. The officers requested to see their ID's and none could produce any ID. All three stated that they were told by the bouncer that they were of legal age. The girls, in fact, were determined to be 16, 20 and 14 years of age. The licensee, Alfredo Garcia, was on the scene and was cited for Underaged Persons upon a Class "B" premises. He was found guilty and fined \$1,062.00. A bench warrant was issued regarding this matter.
- M. On Tuesday, December 16, 2003 officers of the Milwaukee Police Department were dispatched to the license premises of 1921 W. Mitchell Street in the City and County of Milwaukee, Wisconsin ("El Presidente"). They were dispatched to the tavern regarding a "suspect down" which was later upgraded to a "substantial battery." The victim had had her hair grabbed, and was punched in the face. A suspect threw a glass and struck the victim in the head causing a laceration which required stitches. The victim and suspect were acquaintances. The victim was with her sister, both of them were underage, and unaccompanied by an adult or guardian. The owner was contacted by the bartender and called to the scene. Alfredo Garcia arrived on

- the scene, and his wife is the licensee. He was advised of the violations, and issued citations for Presence of Minor Prohibited (2 counts). He was found guilty and fined \$254.00 on February 4, 2004. Two bench warrants have been issued regarding those citations.
- N. On Saturday, July 24, 2004 officers of the Milwaukee Police department conducted a premises check at the license premises of 2239 S. 13th Street in the City and County of Milwaukee, Wisconsin ("Club Galaxia") regarding information received from an informant that gang members were allowed to enter and remain upon the premises and were also allowed to bring guns into the tavern. Upon entering the premises the officers observed 2 underage female and 1 male patron who were issued citations. The officers also arrested a male for Possession of Cocaine with intent to deliver. individual ran into the men's restroom after observing the uniformed police officers. While checking the premises, officers recovered a .22 caliber Ruger model 1022, with a 25 round banana magazine, on the counter of the main bar. The Ruger was loaded. Also recovered were nine 9mm cartridges which were next to the security monitor and which were placed on inventory. The officers spoke to the "manager", one Eduardo Garcia, and asked if he knew anyone in the bar that had guns. He related that there were two guns that had been confiscated from patrons and that they were located in the safe in the security room. He said he did not have a key or combination to the room. He said he would call his brother, the licensee. While waiting for the licensee, three other underage patrons were discovered and cited. Other patrons were cited for Disorderly Conduct, Obstructing and arrested on open warrants. Officers also recovered a Crown Royal felt bag next to the DJ booth, which contained \$400.00 in cash and two clear sandwich bags containing Cocaine. Total weight of the Cocaine was 13.12 grams. The Cocaine was packaged in several corner cut baggies. Ownership was not determined and the material was placed on inventory. When the licensee arrived, he was questioned regarding the safe and whether he had confiscated any guns. He stated he did not have any guns in the safe and does not have the key or combination of the safe. The licensee advised the Committee that he stated to the officers that they could take the safe. As a result the safe was confiscated. After being inventoried it was opened. It contained one .22 caliber pistol, a pellet gun along with 9 mm cartridge magazines, jewelry and videotapes. The items were placed on inventory. The Manager, Eduardo T. Garcia, was cited for Presence of Minors Prohibited. On September 21, 2004 he was found guilty and fined \$1,770.00.
- O. On Monday, September 20, 2004 the applicant and his wife, Mari E. Garcia were both issued citations for fire prevention and enforcement for the premises 2239 S. 13th Street ("Club Galaxia"). Both matters were set for November 11, 2004.

- P. On Friday, October 8, 2004 two men entered the license premises of 2239 S. 13th Street in the City and County of Milwaukee, Wisconsin ("Club Galaxia") and fought with the individual who was checking their ID's. When the owner tried to remove the men from the premises, one of the men brandished a gun and shot the doorman in the pelvic region, leaving him in critical condition. Both suspects were arrested. At hearing, the licensee stated that he himself had a gun pointed at his face by one of the actors. The licensee also claimed that October 8, 2004 was a Wednesday and that most of the incidents occurring in the police report actually occurred on Wednesdays. In fact, October 8, 2004 was a Friday. The citations issued on October 20, 2004 were dismissed in Municipal Court.
- Q. On October 20, 2004 officers of the Milwaukee Police Department conducted a routine tavern check of the license premises of 2239 S. 13th Street in the City and County of Milwaukee, Wisconsin ("Club Galaxia") and found that the licenses were not properly displayed as required by ordinances, and that two pool tables were without the required permits. Citations were issued to the licensee for Display of License and Pool and Billiard Permit required.
- R. On Monday, November 1, 2004 at approximately 10:00 PM officers conducted a check of the premises as a follow up to the incident of October 20, 2004 and found the premises to be open for business. Two subjects were playing pool and another subject was behind the bar. The bartender stated that the owner opened the bar but left to attend a meeting and that no one was put in charge and they were primarily to do the cleaning. None of the individuals present had a valid bartender's license and the two individuals playing pool stated they were employees of the bar, but no employee records could be produced. The individual tending the bar was cited for Class "D" License Required and arrested on a warrant for Possession of a Controlled Substance-Cocaine and a municipal warrant for Harassing and Obscene Phone Calls. One of the other individuals was arrested for Traffic Warrants. Officers then conducted a search of the bar area and recovered the loaded 40 caliber pistol in an area near the bar accessible to the public and a loaded weapon magazine from an unlocked closet. Officers also observed the rear emergency exit to be obstructed and that the licenses were not properly posted. As the officers conducted their investigation, an individual entered the bar and told the officers he thought the bar was open for business. The licensee was issued citations for Safe Egress from Entrance Doors, Class "D" License Required (licensee responsibility) and Display of License. This matter is pending review in the City Attorney's Office on December 21, 2004. At hearing, the licensee advised the Committee that this occurred on a Monday and that he is not opened on Mondays, but that the individuals who were in the tavern at the time were, in fact, cleaning people.
- S. A check with the Milwaukee police department warrant files reveals open warrants for Alfredo Garcia for Presence of Minors on a Class "B" Premises,

- Fire Prevention Enforcement, and Violation; of Placard. A letter notifying the applicant of the open warrants was sent.
- T. The applicant testified that he could not appear at the Utilities and Licenses Committee meeting of November 9, 2004 because his wife's mother was ill in Mexico and as a result they had to travel to Mexico. Rather than flying, Mr. and Mrs. Garcia drove to Mexico, a trip that took 48 hours each way. There are no records of the trip as the entire trip, including restaurant and gasoline charges, were paid for in cash.
- U. Adjoining neighbors to these premises have witnessed on three to four occasions actual shootings of patrons of the licensed premises by other patrons.
- V. Adjoining neighbors have observed patrons at closing time occupy parking lots and throw after hour's parties from their cars which are noisy and disruptive.
- W. Adjoining neighbors have observed patrons leaving the premises with open bottles of beer which are then strewn about the neighborhood and about the parking lots.
- X. Adjoining neighbors have observed patrons on a regular basis, (every Saturday night) engage in racing around the parking lot and squealing tires with their cars. This has caused disruption of the neighbors.
- Y. Adjoining neighbors have observed fights occurring in the premises on a regular basis.
- Z. Adjoining neighbors have observed on one occasion, a gang taking baseball bats and beating on an SUV that was leaving one of the parking lots which then crashed into another vehicle.
- AA. Adjoining neighbors testified that on at least one occasion patrons from the premises fired shots into an adjoining home where the children of one of the witnesses were sleeping, and that the bullets were lodged into the ceiling of the room in which the witness's children were sleeping.
- BB. Adjoining neighbors noted that patrons of the premises illegally use and without authorization, parking lots of adjoining businesses for the parking of the vehicles of the patrons of this establishment.
- CC. Another neighbor complains that his garbage cart had been struck a few years ago by a patron driving recklessly from this premises. That same neighbor testified that he does not feel safe living within 150 feet of this premises to go to sleep before 2:30 a.m., when most of the patrons leave.

A former security agent for this location testified that not all of the reckless driving occurs from patrons of this premises, but occasionally involves patrons of Tres Hermanos and a package good store and grocery store located across the street. However, those stores (with the exception of Tres Hermanos) close at 9:00 p.m., and the incidents related by the neighbors are consistent with the hours of operation of Club Galaxia. The former security agent testified that he is a friend of the licensee.

CONCLUSIONS OF LAW

- The Committee has jurisdiction to hold hearings and provided Findings of Fact 1. and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- Based upon the above facts found, the Committee concludes that the licensee, 2. Alfred Garcia Agent for Almar Enterprises, Inc. for the licensed premises at 2239 S. 13th Street ("Club Galaxia") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "B" Tavern and Tavern Dance license. The Committee finds the police report and neighborhood objections to be true.
- In order to protect the health, safety and welfare of the citizens of the City of 3. Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its discretion to not renew the Class "B" Tavern and Tavern Dance license for the premises at 2239 S. 13th Street in the City and County of Milwaukee, Wisconsin ("Club Galaxia").

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes recommends that the Class "B" Tavern and Tavern Dance license held by Alfred Garcia for the premises at 2239 S. 13th Street in the City and County of Milwaukee, Wisconsin ("Club Galaxia") not be renewed.
