Your Class B Tavern and Public Entertainment Premises License Applications Requesting Disc Jockey, Patrons Dancing, Jukebox, Karaoke, and 2 Pool Tables for "Rookies Lounge" at 2579 N Teutonia Av.

There is a possibility that your application may be denied for one or more of the following reasons: The recommendation committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Kristyn Kukowski, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 05/03/2009 at 1:14 am, Milwaukee police were dispatched to Teutonia and Clark for a Reckless Auto complaint. Officers observed patrons who were exiting the tavern Club Passion yelling and walking in the middle of the roads causing traffic congestion and disturbing the neighborhood. Police also observed patrons who once inside their vehicles, would drive down the block, stop and purposely back up traffic. Fours squads were on scene and took about an hour to clear the area of patrons and traffic congestion. Police spoke to Douglas Gray who was the bar manager regarding the patrons and traffic. Gray stated he does have about 10 security guards who help control patron behavior both in and outside of the tavern. Gray further stated that he closes the club before regular closing tavern hours and that he did raise the age of his patrons allowed in to 25.
- 2. On 05/13/09 at 12:54 pm, Milwaukee police monitored Club Passion due to a high volume of patrons. Security was observed on scene and no incidents were observed.
- 3. On 05/30/09 at 11:50 pm, Milwaukee police observed large amount of cars parked in the area near Club Passion and a large amount of foot traffic in the immediate area of the club. Officers conducted a license premise check of Club Passion and observed the bar to have least 300 patrons inside. Upon checking the taverns license and occupancy, it was found that the bars capacity was 160 and a head count was performed with 388 patrons found inside the club, 228 over posted capacity. The bar manager, Doug Gray, was ordered into District 5 to meet with Captain Mitchell regarding this matter and the licensee Kanisha King was issued a citation for Posting Occupancy Capacity Required.

4. On 10/30/09 at 12:05 am, Milwaukee police were dispatched to 2579 N Teutonia Avenue for Large Fight/Shots Fired complaint. As officers arrived, they observed several patrons scattered outside the club as well as several autos leaving the area. Once inside the club, there was a strong odor of OC in the air with subjects coughing. Officers spoke to Douglas Gray, the licensee's husband, who stated a fight broke between two patrons with other patrons joining in the fight. Security attempted to intervene but the patrons began to fight with security. Gray stated no shots were fired. Gray further stated he didn't know who sprayed the OC and that maybe a female "snuck" it in. Attempts to speak with the bartenders were made but Gray stated that they had all left for the night. Officers also attempted to speak with the security guards but only one was left on scene. Officers spoke to Draylon Oliver who stated he was working at the entrance of the tavern and did not see what happened but did observe security guards pushing several patrons out the door. Oliver stated he know the house security to carry OC on their person and believed it was a female security guard name "Cory" who had used her OC. Police again spoke to Gray who stated he does not allow security to possess or use OC spray. Police eventually did speak with security guard Cacorey Edwards regarding this incident that confirmed a fight did occur in the tavern but denied using OC. Gray stated the tavern does not allow them to use or possess it. Police did observed security cameras but were told by Gray that the system does not work. The licensee was issued citations for Disorderly Premises and Responsible Person Upon Licensed Premise.

5. On 12/18/09 at 1:09 am, Milwaukee police were dispatched to N Teutonia and W Clarke to investigate a Shots Fired complaint that occurred outside of Club Passion. Upon arrival, officers observed an auto that had a bullet on the drivers' side front door. Officers spoke to Douglas Gray who stated he was the owner of Club Passions and that it was his auto that was damaged. Gray stated he did not witness this happen and that he would not be able to access video surveillance equipment at this time. Officers then spoke to security officer Terry Atwater who stated he was working inside the club during the incident and not witness anything. Officers spoke with a witness who stated he heard a few gunshots and then observed several females run from the area and into Club Passion. Police located eight 9 mm casings that were placed on inventory. Unsuccessful attempts were made to contact Kanisha King-Gray.

6. On 12/27/09 at 12:55 am, Milwaukee police monitor the closing of Club Passion due to the large crowds the club attracts. A check for capacity was conducted and the club was found to have 227 patrons with the capacity listed as 160. The club was over capacity by 67 patrons and this count did not include employees of the club. The capacity license was found to be behind the bar covered by two bottles of liquor. While the count was being conducted, officers observed two patrons holding one full sized bottle of Absolut Vodka and another holding a full size bottle of champagne or wine. The licensee Kanisha King-Grav was not on scene and attempts to contact her were unsuccessful. The number that was listed as well as King-Gray cell phone number on the MINT system were found to be disconnected. On 12/28/09 at 9:27 pm, officers returned to Club Passion and spoke with Douglas Gray regarding obtaining valid phone numbers to Kanisha. Gray advised police that he didn't have any updated/valid numbers to provide. An attempted to contact King-Gray at her residence (4422 N 85<sup>th</sup> Street) was also unsuccessful. On 01/01/10 at 10:05 pm, officers attempted to make contact once again with King-Gray at her residence and spoke to Douglas Gray's sister, Martha Walker, who stated she just moved into this residence and doesn't speak with Kanisha or have any information about her. King-Gray was cited for Over Capacity regarding the 12/27/09 incident. Police attempted to serve the citation to Gray but he refused to accept them telling officers to talk to her attorney. Police are unable to list the proper information for this citation and future citations since they are unable to locate and or obtain personal information on the licensee. King-Gray.

7. On 01/16/10 at 1:14 am, a subject who had a gunshot wound to his left shoulder flagged Milwaukee police down. The victim stated the incident happened at Club Passion at closing time. Investigation revealed the subject and his friends left the club at closing time and had walked to his parked auto at 1347 W Clarke when they heard an argument in the street to the west of their location. They got into the auto when they heard three gunshots and he realized he was shot. At 1:18, officers arrived on scene and found the tavern to be closed and locked up with no employees' on scene. Officers located evidence of the incident in the street. directly next to the tavern. Officers attempted to contact Douglas Gray on his cell phone but received no answer. Police contact King-Gray who stated to contact her husband. A second attempt was made and officers spoke to Gray. Gray was told he needed to return to the tavern and speak with police and provide officers with video surveillance. Gray stated that the video surveillance was currently not operating and that he had no idea that the shooting occurred. Gray stated he closed the tavern approximately at 1:50 am to 2:00 am and that there were no incidents. Officers spoke to two witnesses who gave the same accounts of what happened regarding the shooting but refused to identify themselves because they feared retaliation from the bar owner. One witness stated these problems are not uncommon and that it's getting worse. This witness stated they no longer have issues sleeping because of being so used to gunshots coming from the area of the tavern at closing time. The witness further stated they have no faith in the alderman anymore because of monthly meetings with neighbors expressing their concern to the owner and nothing is ever done.

On 01/14/10 at 3:00 pm, Gray attended a meeting at District three regarding the operations of the tavern. Gray stated to police that at any time officers needed to view the taverns video surveillance, all they had to do was contact him and he would fully cooperate. At no time did Gray state that the video surveillance system had not been operational for the past month and a half. Police spoke with two witnesses who wished to remain anonymous.

- 8. On 03/09/10 at 1:42 am, Milwaukee police were dispatched to Mt Siani for a Shooting complaint. Officers spoke to the victim who stated he left Club Passion at closing time with some of his friends and got into an auto driven by his girlfriend. The victim stated there was heavy traffic from the large crowd that was leaving the club when he observed a male firing a silver handgun "in every direction". The victim stated he heard three gunshots and "ducked" to avoid being shot. It was shortly after he realized he was shot in the left leg and right wrist. Police locate many casings throughout the block and placed them on inventory. Police also located the auto the victim was in and found a pool of blood on the floor where the victim stated he was seated. Police attempted to obtain video surveillance but found Club Passion to be closed. On 03/09/10 at 7:13 pm, officers contacted King-Gray regarding the shooting who advised police she was unaware of this incident.
- 9. On 04/26/10 at 10:45 pm, Milwaukee police conducted a License Premise Check at 2579 N Teutonia due to receiving a complaint that the club had topless dancers on Monday nights. Officers entered the tavern and spoke with Douglas Gray and requested to see the taverns liquor license. Officers observed a box of Black and Mild cigars, wine flavored, on the back bar. A check of the license found the tavern did not a tobacco license. Police also found the tavern to be charging a \$15 dollar cover charge with no sign posted at the entrance information such. When questioned by police, Gray stated he rented the bar out and that he has no control over what they charge. Police found the licensee information through the MINT system to show that she had not provided the new address and phone number of her contact information. The licensee was cited with several citations.

10. On 05/21/10 at 1:40 am, Milwaukee police were monitoring the closing at Club Passion when they observed a patron leave the tavern and walk to the side of the business and urinate on the building and sidewalk. The subject was cited and police spoke with Douglas Gray regarding this matter. Unsuccessful attempts to contact the licensee Kanisha King-Gray were made regarding this matter.

- 11. On 06/26/10 at 2:30 am, Milwaukee police investigated a walk-in Battery complaint at District Five. The victim stated she was at Club Passion and that she has a temporary harassment injunction against a known subject who was in the club. The subject approached her and she told him to go away when he slapped her. Security broke up the fight and kicked the subject out of the club. Once the club closed, the victim stated she went to district 5 to report the incident. Officers notified the bar manager regarding this incident.
- 12. On 08/08/10 at 1:30 am, Milwaukee police were dispatched to Teutonia and Clarke for a Shooting complaint. Investigation revealed a patron was shot while inside the club. Officers found the victim lying on the bathroom floor with two gunshot wounds to his hip and thigh. Witnesses stated that there had been a fight near the dance floor and bathrooms with security attempting to break it up. The witness stated shots were fired and believed two shots were fired inside and the rest were fired from outside of the tavern. Police spoke with Douglas Gray who stated a large fight broke out on the dance floor around 1:00 am and that security went to break up when he heard two shots. Gray stated he then observed a subject fall to the ground. Gray further stated he did not observe who fired the gun. Requests to view surveillance video were made and Gray stated it was not operating at the time of incident. Gray stated he did have an operating ID card reader that takes digitial photos of the person and was able to confirm to police that the victim was a patron at the tavern that night. A possible suspect ID was also recovered. Casings were recovered inside and outside of the tavern. A total of ten squads were needed for the scene and to interview 35 possible witnesses. Milwaukee Fire Department was also on scene. Attempts were made to contact Kanisha King-Gray via telephone regarding this shooting with no one answering. A battery complaint was also filed in addition to the shooting incident that also occurred inside the tavern shortly before the shooting occurred.
- 13. On 10/17/10 at 1:45 am, Milwaukee police observed a large fight outside of Club Passion located at 2579 N Teutonia. Officers observed a security guard physically restraining a subject while escorting him out from inside the establishment. This patron was yelling profanities, which was causing a large crowd to gather and view the incident. This patron then walked up to another subject and punched him in the face, which caused a fight to break out. Officers requested more squads to the area to assist in breaking up this large fight. The patron who punched another subject was arrested and when questioned, stated the fight began in the club and moved outside when security removed him. This subject further stated that security used OC in attempts to break up the fight inside the club. The subject was cited for disorderly conduct. Officers entered the club and found a strong odor of OC in the air. Police spoke with Douglas Gray who has stated to police in the past that he does not allow his interior security personnel to carry any weapons, which include OC. Officers made several attempts to contact Kanisha King-Gray via phone and in person, but were unsuccessful. A total of six squads were needed to clear the area and restore order.

Gray was advised that the bar should not being operating without a license and Gray stated that Alderman Hines personally told him that he could be open until December 21<sup>st</sup>, 2010. Gray stated he paid for the new license. The bar was left open until police could verify the information. On 12/20/10 at 4:05 pm, an officer spoke with Chris Lee from the License Division at City Hall. Lee stated the renewal of the license was being processed which meant it had not been issued yet and that they should not be open for business. The licensee Kanisha King-Gray was cited for operating without a license.

16. On 12/21/10 at 12:48 am, Milwaukee police responded to 2579 N Teutonia to investigate Tavern Violations. Police found the bar to open and operating without a Class B Tavern License. Officers spoke with Douglas Gray who was on scene. Gray became argumentative and insisted that police were wrong. Gray stated he was advised by Alderman Hines personally that he could remain open. The bar manager, John Moore, along with other employees became very loud and boisterous, stating that the city and police were wrong and harassing them. Gray was advised to close immediately to which he did. On 01/03/11, the licensee Kanisha King-Gray was personally served a citation for the violation.

Police contacted the License Division to see if a change was made with city hall to which it was not. Photos of the new sign on the bar were taken and the flyers were placed on inventory. The licensee, Kanisha King-Gray spoke with police regarding this matter stating that the proper paperwork was done by her accountant and that it should be on file. King-Gray was cited.

18. On 12/18/11 at 2:02 am, Milwaukee police were patrolling the area of 2577 N Teutonia when officers observed a fight in progress occurring outside of the Club 30 bar. Officers, along with bar security, broke up the fight, however some subjects continued to verbally argue across the street. Investigation revealed the fight started inside the bar between two patrons and continued outside. Officers spoke with Reginald Butler who stated he observed the altercation. but denied any knowledge of whether the participants were bar patrons. 

- 19. On 09/24/12 at 11:30 pm, Milwaukee police were dispatched to 2579 N Teutonia for an Armed Robbery complaint. The victim stated to police that he was exiting his auto at Club 30 when two males who were armed with guns approached him. They demanded and obtained the victim's property as one suspect punched the victim in his head. Officers spoke to a bar employee who believed that cameras did not capture the incident because it was out of camera range. Police attempted to notify Kanisha King-Gray regarding the incident, however no one answered any of the numbers called.
- 20. On 01/01/13 at 1:53 am, Milwaukee police were dispatched to St. Joseph's Hospital for a Battery complaint. The victim stated to police that she was at the Club 30 when she accidentally bumped into an unknown female inside the bar. The victim stated she apologized and assumed everything was fine. The victim stated shortly after, she went outside for a cigarette when the female she bumped into, along with two of her friends, jumped her, hitting her several times. Once the females stopped hitting her, she located her boyfriend who was in the bar and they left. The victim told police that she did not see any security guards outside the bar when the incident occurred. The victim complained of pain to her neck and jaw area and had several scratches and bruises. On 01/14/13, police left a message regarding this incident to the agent, Kanisha King-Gray.
- 21. On 01/06/13 at 1:32 am, Milwaukee police were dispatched to a Fight complaint at 2577 N Teutonia. While en-route, police received an update that the "Shotspotter" detected 4 shots fired at 1335 W Clarke Street, which is directly across the street from Club 30's front door. Upon police arrival, no one could be found fighting outside, or any injured parties that appeared to have been in an altercation of any kind. Officers entered the bar and spoke with Douglas Gray. Gray explained it was "alternative night" and believed an unknown male who was dressed as a female, slapped another female patron in the face. Security escorted the unknown male from the premise to avoid any further altercations, and that he proceeded to shut down the bar for the night and was unaware of what happened outside after the ejection. Gray further stated his security only escorted the male actor and his party off the premises at the time of the fight and was unsure how the fight escalated outside. Gray stated he did not hear any shots fired in the area during the incident. Officers then spoke with a security quard. Andrew Werner, who explained he was working the front door when a fight began outside the tavern. Werner stated he did not know what lead to the fight, but thought the people involved were patrons of the bar. Werner stated the fight consisted of 20 unknown female subjects and that the fight was brief and quickly broke up when shots were fired from the 1300 block of W Clarke Street. Werner stated when he heard the shots; he quickly took cover behind a nearbyparked car so he was unsure of who fired the shots.

- 22. On 01/14/13 at 10:53 pm, Milwaukee police were dispatched to 2579 N Teutonia to investigate a complaint of illegal strippers, drug use and soliciting at the bar. The caller stated that women were soliciting in the apartments above the tavern and that one girl was 17 years old. Police entered the bar and proceeded to the dance floor area where strippers are known to perform. Officers did not observe any strippers however, when police checked the "dressing room", observed 35 women, who were naked. Police spoke with Douglas Gray and advised Gray of the complaint police received, at which time he assured officers that there was no illegally activity occurring at his bar. Gray escorted police to a door on the east wall of the tavern, which when opened, had a leading staircase and viewed a portion of the upper level. Police observed that the area did not have any heat and didn't appear to be in use because it was very dirty and dusty. An officer believed that the area might be used as possibly storage. Officers did not locate any underage persons on the premise. On 01/31/13, officers attempted to notify Kanisha King-Gray regarding the investigation at both numbers listed on LIRA, however the home phone was not functioning and the other number was incorrect according to the person who picked up the call.
- 23. On 02/25/13, Milwaukee police, based upon information and belief which has been obtained through various resources regarding the "Butt Naked Monday" events being held at the Club 30 Grill & Lounge, was involved in crimes against sexual morality, specifically "Lewd and Lascivious Behavior, which is described as "committing an indecent act of sexual gratification with another with knowledge that they are in the presence of others and/or indecently exposes genitals or pubic area" that in support of the assertions as described above that allegedly are occurring at the Club 30 Grill & Lounge. An undercover investigation was commenced on Monday, February 25<sup>th</sup>, 2013, along with assistance of HIDTA detectives and several confidential informants who proceeded to patronize the Club 30 on Monday evenings during the "Butt Naked Monday" events; that these two confidential informants entered into Club 30 and independently and not knowing that one or the other was acting as an agent for the Milwaukee Police Department.

On 02/25/13, members of the HIDTA, Milwaukee police Detectives and two confidential informants who were equipped with a video recording device, entered Club 30 to monitor the activities that are occurring inside this tavern. The confidential informant did enter the bar at approximately 10:00 pm and remained inside the club until approximately 12:15 am. The CI described the activities as being normal up until about 11:30 pm, when the females started to dance and strip; that the female strippers check in with a subject known only as "Bear" and that the strippers need to sign a book and subsequently pay somewhere between \$20-\$40 dollars to strip. That at or about 11:30 pm, The CI stated that the dancers began their show and that they came out onto the dance floor two at a time: that the CI stated the strippers start out with an outfit consisting of some type of bra and panties, but that eventually the dancers expose themselves completely. The CI stated that the dancers breasts and full pubic region were being exposed fully to the patrons observing the dance show. The CI also observed female dancers were touching each other's breasts and buttocks area through out the performance; and that in one instance, two female performers preformed oral sex on each other in front of the patrons. The CI further stated that it was very common to see male patrons placing their fingers on the dancer's vagina along with money as well as penetrating the female dancer's vagina with their fingers. The CI further relayed that after the girls finish their dancing, the walk around the club soliciting tips and setting up lap dances and/or

other services in a back VIP area where sexual acts take place. The CI volunteered information that when the CI informant patronized the Club 30 in the past, that the CI had engaged in sexual acts with these female dancers in exchange for money. The CI stated that security for Club 30 is selective regarding their door searches and checking identifications of patrons entering the club. The CI stated he observed one patron armed with either a .22 caliber or a .25 caliber semi-automatic pistol. The CI also relayed that at one point in the evening while inside the club, a patron was put on the ground by security and that one of the friend's of this patron voiced their concerns about what the security guard had done and that this friend was starting to make phone calls following which the CI heard rumblings about some shooting that was going on outside the club. Detectives that were in the area at about 12:15 am, did hear shots being fired somewhere in the vicinity of the Club 30 Grill & Lounge. Also included in the PA-33 were the findings of the 2<sup>nd</sup> CI, which included patrons putting money and their fingers in the dancers vaginas, and that male patrons were receiving oral sex from the dancers on the main dance floor for exchange of money. Detectives assigned to HIDTA that were involved in the investigation, stated that at some point in the early morning hours of February 25<sup>th</sup>, 2013, a fight occurred inside the club causing a large rush of people to exit the club onto North Avenue causing an estimated 25 to 30 cars being stopped on N. Teutonia Avenue. Both CI stated that narcotics are sold "freely" in the bar, which includes "Molly" (Ecstacy) cocaine, and marijuana.

- 24. On 03/04/13 at 1:49 am, Milwaukee police were dispatched to 2579 N Teutonia for a Trouble With Subject complaint. The caller stated that someone is currently threatening to shoot outside of Club 30 and that there was a large crowd in the street and traffic cannot move. Upon police arrival, traffic was backed up in both north and southbound lanes. Many cars were at a stand still. Investigation revealed that a gun was implied, but not seen, and that the caller, who wanted to remain anonymous, left the area. Police observed subjects hanging out of car windows as well as people exiting their autos to loiter. Many were loitering in a gas parking lot located at 1341 W Center that does have an extended hours license, but appeared to be closed because all lighting inside and out of the premises was shut off. Squads cleared the area and made attempts to contact Kanisha King-Gray, but do to incorrect numbers provided by King-Gray, attempts were unsuccessful.
- 25. On 03/04/13, an undercover investigation continued with officers from the Milwaukee Police Department, members of the HIDTA and confidential informants in regards to "Butt Naked Monday" promotion at Club 30 Grill & Lounge. A Cl entered the bar at approximately 11:00 pm and remained inside of the Club 30 Grill & Lounge until approximately 12:45 am. The Cl went to the back area where the strippers dance which was already packed when the CI arrived. The CI heard the DJ to announce that if the patrons did not have money that they should move to the back and away from the dancers. The CI observed the dancers to be touching each other's breasts and buttocks area that the CI observed men and women placing US currency into the strippers vagina area. The CI stated that the managers of the bar were announcing that they were going to start doing a "Butt Naked Tuesday" for the first time and was also informed of a "lock-in" on Sundays where patrons are at liberty to engage in sex acts with strippers for money. UC detectives that were outside the bar during the under cover investigation, describe the roadways surrounding Club 30 as "gridlock". A detective stated that there was cruising and at one point, there were vehicles going into opposing traffic on N. Teutonia Avenue and that the vehicles were swerving in and out of traffic and honking horns and people were hanging out of the car windows. The detective could also smell the odor of burning marijuana as they monitored the exodus of individuals from Club 30. A detective did ultimately review audio/video recording from the CI and did observe a woman naked from the waist down at approximately the 38 minute mark of said video as well as at the 48 minute

mark, the DJ stating that the show would start in approximately 5 minutes following which he observed women in various states of undress walking past the Cl. Also observed were dancers vaginas being exposed and dollar bills being dropped down on the dancers as well as observing a dancer to have her hand on her vagina and possibly inserting her finger into her vagina. Other detectives' observations and their Cl statements/observations were also included in this PA-33. As a result of this investigation, Kanisha King-Gray was issued citations for costume regulations and the citations were served upon Attorney Scott Phillips on October 9<sup>th</sup>, 2013, who represents the Club 30 Grill & Lounge.

26. On 03/11/13, an undercover investigation continued with officers from the Milwaukee Police Department, members of the HIDTA and confidential informants in regards to "Butt Naked Monday" promotion at Club 30 Grill & Lounge. At approximately 10:30 pm, a Cl entered Club 30 and remained inside until approximately 12:50 am. The Cl stated that all of the strippers that were in the club on this particular evening were exposing their full breasts, buttocks and vaginal area to the patrons. The Cl also stated he observed patrons placing money into the vaginal areas of the strippers. The Cl further stated he observed one stripper performing oral sex on another female. The Cl stated that one of the strippers asked him if he wanted a sample, which the Cl understood to mean that she would perform fellatio to see if the Cl would like to pay for sexual acts. The Cl also reported seeing strippers placing their own fingers into their vagina in an effort to get more tips. The Cl stated that he spoke with a male security guard named "George" who informed the Cl that he was trying to sell a .357 caliber handgun for the price of \$375. Also included in the PA-33 are other detectives observations and their Cl statements/observations.

- 26. On 03/12/13 at 2:20 am, Milwaukee police at the Third District took a Theft complaint that occurred at 2579 N Teutonia. The victim stated she was at Club 30 at 12:30 am for "Buck Naked Monday". She had placed her purse on a table in the dance area and her back to the table as she was watching strippers and when she later turned around, found her purse gone. She stated she looked all over the bar for it and then asked security and the bartenders if anyone turned in a purse, however no one did. Police were unsuccessful in contacting Kanisha King-Gray and a report was filed.
- 27. On 03/26/13 at 1:40 am, Milwaukee police were monitoring Club 30 at 2579 N Teutonia Avenue due to traffic congestion as well as cruising type issues that occur at closing time. At 1:57 am, police observed traffic start to back up in the area surrounding the club. Two cars were observed driving on the grass of a vacant lot located at 2602 N Teutonia and then driving off the curb to get onto N Teutonia. Patrons of the club have been known to park their autos on this lot and have been cited in the past. When Club 30 closes for the night, the traffic issues that involve patrons of the club have been known to drive and park on the lot of Center Petro Mart (1341 W Center) and 15 autos were found to have parked at this lot in every direction on the lot. It had appeared to police that many of the subjects this night were not actual patrons of the bar. Police could hear people yelling and talking boisterously and using profane language as they walked to their autos. Police believed this could cause a disturbance due to the fact

that the club is in residential area. Two squads recorded the closing process of Club 30 and placed the copy on police inventory.

28. On 03/31/13 at 1:18 am, Milwaukee police were dispatched to 2579 N Teutonia for a Fight complaint. Police were on scene when they heard several gunshots being fired in the area. Police observed approximately 50 subjects in the intersection of Teutonia and Clarke Streets physically fighting and screaming. Due to the amount of subjects fighting and gunshots, all available squads from District Three responded to the location. Officers had to use their OC to several subjects who refused police orders to cease their actions. Police spoke with Douglas Grav who stated that the club had hosted a get together for a family who lost a loved one. An unwanted subject attempted to enter the club to join the family, but was not allowed in. Shortly after, two women from the get together exited the club and according to Douglas Gray, the unwanted subject began to physically fight with these women, prompting several people from the club to exit and get involved. Shots were then fired. Police recovered casings at 2554 N Teutonia, where an auto was parked and in plain view, officers observed an empty magazine cartridge lying on the passenger side floor. Police located the owner of the auto and the woman admitted to firing shots from her gun because it was her cousin that was being beaten up. The woman stated that a fight occurred inside the bar because one of the owners of the club wanted to "talk" to her cousin, who had expressed that she was not interested in the subject. The woman further stated that her cousin then threw a drink in that subject's face. which prompted a fight between the two. Security broke up the fight and escorted her cousin out of the club, but refused to let out any of the other family members. The woman stated that when she and other members were finally let out, she saw her cousin being beaten up in the middle of the street by 10-15 men, one of them whom she identified as the owner. The woman stated she then went to her car and retrieved her gun and fired it multiply times into the air. Police arrested the suspect and charged her with ESBUODW. Police recovered a 9 mm handgun, along with two magazines, 12 cartridges and a total of 8 spent casings. Due to the totality of the circumstances, and the fact the incident stemmed from patrons at Club 30, Kanshia King-Gray was cited for disorderly premises. Several subjects were also cited for disorderly conduct.

- 29. On 05/01/13, an investigation continued with officers from the Milwaukee Police Department, in regards to "Butt Naked Monday" promotion at Club 30 Grill & Lounge. An officer from the Milwaukee Police Department drafted a search warrant on May 1<sup>st</sup>, 2013 and that was served on May 3<sup>rd</sup>, 2013 upon Facebook that consisted of a request for a warrant for communications or other information held by a provider of electronic communication services and remote computing services. Facebook did respond with the requested documentation in the form of two CD's consisting of a total of 2,564 pages: that a portion of this documentation provided by Facebook resulted in multiple photo albums for Club 30 Grill & Lounge and that the photos incorporated herein are specifically dated December 5, 2012, December 12, 2012 and December 19, 2012. An officer examined the documentation provided by Facebook, which also included the same or similar photo albums, which were previously downloaded by an officer from Facebook. These photos clearly indicate that Club 30 is non-compliant with the costume requirements of MCO relating to PEP license.
- 30. On 05/07/13 at 2:10 am, Milwaukee police were patrolling the area around Club 30 when the tavern's security guards flagged them down for a woman who had been cut in the 1300 W Clarke Street. Police found the victim and observed a small ½ inch laceration/puncture to the back of her left arm. The victim stated to officers that she was with her male friend and that they were inside Club 30 when he started talking to other women, which she didn't appreciate, so she started talking to other guys. At closing time, the victim left the bar and asked her male friend for her coat, which was inside his car and that he, became angry and "swung off" on her, which officers took to mean as an attempt to strike her. The female that her male friend was talking to started yelling at her and she felt like the woman was going to fight her. The victim stated she then observed this female to have something in her hand and that she attempted to run away when she suddenly felt a "poke" on the back of her arm. Police spoke with agent's husband, Douglas Gray, regarding the incident. Gray stated the victim had been inside the bar, but that he did not witness her in an altercation of any kind. Gray further stated he believed the victim left at 12:00 am and was not aware that she had returned to the bar.
- 31. On 05/21/13 at 2:37 am, Milwaukee police were dispatched to St Joseph's Hospital for an Armed Robbery complaint. Police met with the victim who stated he was at Club 30 with his brother and as they left and walked to their car, noticed that the front driver's side window smashed out. As the two began to clean up the glass, an unknown male approached them behind and stated, "Give it to me". The victim stated he didn't know what the suspect meant by it and was then struck in the face with a handgun. The victim stated the attack stopped after a security guard from Club 30 chased the attacker away. The victim sustained three large lacerations. Casing is pending.
- 32. On 06/04/13 at 1:00 am, members of HIDTA were conducting an operation in the 2500 block of N Teutonia when they observed a patron from Club 30 discharge a single shot from a handgun in front of 2551 N Teutonia. Police stated they observed a male and female exit the club and walked to a parked car. The female began directing the male who was driving a car, out of their parking space when an officer observed the woman reach into the passenger side window, which was open. The officer then observed the female reach in her waistband and run towards a fence, firing one shot. The woman returned to the car, which sped off. Police conducted a traffic stop and arrested the woman for ESBUODW. The woman admitted to firing the gun and stated the she was trying to hit an opossum which was sitting on a chain link fence just west of where the vehicle was. It was later found that the fired round struck a residence at 2552 N 14<sup>th</sup> Street, and upon checking, all occupants that were inside at the time were not

injured by the discharged round. The woman denied to police that she had the gun while they were inside the club. The driver was found to be in possession of THC and became belligerent with police when he was placed under arrested. An officer spoke with Kanisha King-Gray who stated she was not at the business the night of the incident and was not aware that it had occurred.

- 33. On 06/11/13 at 12:49 am, Milwaukee police were patrolling in the 2600 block of N Teutonia when they conducted an investigation involving a patron from Club 30 who had an unregistered auto, which was parked at 2641 N Teutonia. Officers advised the subject that she could not drive the car because it was being towed, to which she protested. The woman was argumentative and was allowed into the car to retrieve her belongings when she closed the door and started the car up. She was ordered to shut off the car and step out, but refused and put the car in gear and struck an officer in his leg with the vehicle. The woman was eventually taken into custody and charged with OWI and issued several traffic citations. Officers spoke with Kanisha King-Gray who stated she was unaware of the incident.
- 34. On 06/24/13, an undercover investigation continued with officers from the Milwaukee Police Department, members of the HIDTA and confidential informants in regards to "Butt Naked Monday" promotion at Club 30 Grill & Lounge. A CI entered Club 30 Grill & Lounge at approximately 10:30 pm, and remained inside until approximately 1:30 am. The CI stated that he observed female dancers that were initially wearing outfits that covered their breasts and vaginal area, but were being totally removed by other dancers, exposing their breasts and pubic area. The CI stated the patrons would place money into the female dancers vaginal areas and that the female dancers could be observed placing their fingers into their own vagina. Video and audio recordings were obtained by the CI and later given to members of the HIDTA who downloaded the video and audio portions of the recording device to a CD. The recordings clearly indicate that Club 30 is non-compliant with the costume requirements of MCO relating to PEP. As a result of this investigation on this date, Kanisha King-Gray was issued two citations for Costume Regulations.

35. On 07/01/13, an undercover investigation continued with officers from the Milwaukee Police Department, members of the HIDTA and confidential informants in regards to "Butt Naked Monday" promotion at Club 30 Grill & Lounge. A Cl entered the club at approximately 10:55 pm and remained inside the club until 2:00 am. Video and audio recordings were obtained from the CI that revealed dancers beings announced with patrons gathering on the dance floor in large circle around a dance pole. The dancers are then seen entering into this circle, which also shows multiple security guards with some carrying laundry baskets as the dancers begin to entertain the patrons. The dancers are seen wearing an assortment of scantily clad outfits consisting of mostly a top and usually a G-string for a bottom garment. Music is playing and the dancers begin to dance. During the performance, the dancers ultimately remove their Gstring revealing their vaginal areas in full view and/or pull up their bras to reveal their breasts in plain view and not covered with pasties. UC officers who were outside and monitoring Club 30 heard two gunshots being fired at or near Club 30 and observed a male run in front of the UC officers auto being chased by another male who was armed with a gun. It was later found the subject with the gun was a security officer for Club 30, identified as Dwayne Hardwick. Police investigation revealed that an armed robbery had occurred at 1:46 am that involved a patron who had previously been inside the club. A unknown male who was armed with a gun approached the victim; pistol-whipped, shot and robbed the victim before fleeing the scene. Police then entered Club 30 and spoke with Douglas Gray regarding the armed robbery/shooting incident. Gray was asked if he knew the victim of the shooting to which Gray responded that the victim was never in the club. An officer asked to speak with Kanisha King-Gray and Douglas responded that the officer had to deal with him and not his wife. Police were shown where Gray keeps his DVR system for his cameras in and outside of the club. Officers, along with information provided by the CI, clearly indicated that female entertainers of the club were in violation of the costumes regulations. Citations were issued to Kanisha King-Gray for costume regulations.

On 07/15/13, an undercover investigation continued with officers from the Milwaukee Police Department, members of the HIDTA and confidential informants in regards to "Butt Naked Monday" promotion at Club 30 Grill & Lounge. A CI entered approximately 11:00 pm and remained inside until 2:00 am. Video and Audio recordings were obtained from the CI, which showed dancers wearing an assortment of scantily clad outfits consisting of mostly a top and usually a G-string for a bottom garment. During the performance, the dancers ultimately remove their G-string revealing their vaginal areas in full view and/or pull up their bras to reveal their breasts in plain view and not covered with pasties. A dancer is also seen lifting her costume garment up above her waist exposing her vaginal area and then becoming fully naked and dancing at the stripper pole. Also observed is a security guard shining a light on a dancer who is lying on the dance floor and who is spreading her legs and exposing her vaginal area, which is not covered with any type of costume. As a result of this investigation on this date, citations were issued to Kanisha King-Gray for Costume Regulations.

- 37. On 07/24/13 at 9:00 pm. Members from the Wisconsin Department of Revenue, Alcohol and Tobacco Enforcement conducted a License Premise Check. Agents spoke with Douglas Gray and Charles Burgess, who were the only two occupants in the club. Investigation found several bottles of alcohol to be old and not documented on any invoices for the establishment. Also found were plastic containers of an unidentified alcohol mixture that Douglas Gray stated was "punch made with alcohol." Gray was advised that he could make a punch mixture but that he needed to label the container with what was in the mix and that he could not keep the contents for longer than one business day. When asked by agents how many employees Gray had, Gray responded that he does not have any employees and that everyone helps him for free. Gray later stated that he had one security guard who receives a "1099" form. Agents issued a warning letter to Gray specifying illegal activity relating to the selling of alcohol purchased from an unauthorized source and for failure to maintain invoices on a licensed premise.
- 38. On 07/26/13, a License Premise Check was conducted by Agents from the Department of Revenue Alcohol and Tobacco and Milwaukee police. While waiting, an unknown male stated, "Break yourself." The victim stated he then came face to face with the suspect and that he began to run when he heard one shot fired immediately knew that he had been shot because he felt pain to his leg. The second victim was shot to his mid-section of the right side of her upper body. Further investigation found Webb had a loaded Rossi .38 revolver in his center console of his auto that he said he needed because he feared for his safety when he had to ask some people to leave the club and that those people have been threatening him. Webb is a convicted felon prohibited from possessing a firearm due to a Felony charge of First Degree Reckless Homicide. Webb was charged with Felon in Possession of Firearm. Case is currently pending with a plea/sentencing hearing on 01/16/14. (13CF004391)
- 40. On 10/07/13, Kanisha KING-GRAY applied to renew the liquor license for Club 30 located at 2579 N Teutonia Avenue at the City Hall License Division located at 200 E Wells Street. On the renewal application, question 6. a. reads: Since filing of the last application, has the named licensee, any member of a partnership licensee, or any member, officer, director, manager or agent for either a limited liability company licensee, or non profit organization licensee been convicted of any offenses (excluding traffic offenses not related to alcohol) for violation of any federal laws, any Wisconsin laws, any laws of any other states, ordinances of any municipality? If yes, complete the reverse side. The applicant, Kanisha KING-GRAY marked the No box. A background investigation revealed that KING-GRAY has a municipal court conviction of Disorderly Premises Prohibited on 05/29/13, which she paid a \$379.00 fine. A citation was issued to KING-GRAY for truth of statements & affidavits- falsifying.

41. On 11/26/2013 Milwaukee police learned that an underage event was being held at 2579 North Teutonia Avenue. Investigation revealed that several patrons inside the business were under the age of 21 and that the proper permit to hold an underage event had not been obtained. The applicant was cited.




