- 9. On 09/21/07 at 9:40pm, officers observed a large group of male subjects loitering at the A S Gas N Go at 1909 W. Hopkins St. The subjects were in front of the northeast corner of the building. The officers observed two of the subjects begin to fight, punching each other in the head. The officers had to use OC spray to stop them from fighting. The subjects involved in the fight were cited.

The officers spoke with three customers whose cars stopped running after putting fuel in their vehicles. The employee stated the fuel cap to the tank was loose and the tank had water in it. Officers waited for a state inspector to arrive. The inspector Jim G. Zorn, found that the tank had at least six inches of water in it. Mr. Zorn placed a red tag seal on the main storage tank and all pump nozzles, and advised the owner no gas was to be sold until the problem was fixed.

Officers interviewed the security guard who stated that four black male juveniles entered the store and two of them began taking items.
