The above claim was sent to my attention, alleging damages to property as a result of an adjacent city owned property at 2022 W Keefe Av.

The claim was sent to the Department of Neighborhood Services (DNS) to conduct a review of the damages. Attached to the claim was an estimate of cost for repairs to a concrete walk. The claimant does not state how the city would be liable nor does the claimant offer any proof of city liability.

Additionally, if there is a claim for damages against the city such claim shall be referred to the Real Estate Division, 809 N Broadway, attention Rocky Marcoux. The claimant must provide evidence of city liability.

I find no cause or justification for claim against the city at this time.
