Dear Mr. Wanzo:

We have received your claim in the amount of \$655.77, relating to damage sustained to your vehicle on July 20, 2005 when you allege it was scratched by a garbage cart while exiting your garage, located behind 7513 West Florist Avenue.

Our investigation reveals that the Sanitation Division report completed as a result of this alleged incident notes that you have a clear view of the area the cart was located in as you exited your garage. The liability for this accident is upon you. As such, the City cannot accept liability for your damages. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
