- l. Loretta Graham is an adult and resides at 3631 N.  $14^{\rm th}$  Street, Milwaukee, Wisconsin 53206.
- 2. Loretta Graham was injured on July 31, 2003, due to the acts, omissions, and negligent conduct of the City of Milwaukee.
- 3. The circumstances of the injuries are as follows: On July 31, 2003, in the City of Milwaukee, Milwaukee County, Wisconsin, Loretta Graham was exiting City Hall near Market Street. City Hall's address is 200 East Wells Street, Milwaukee, Wisconsin 53202. While walking on the sidewalk, which had scaffolding erected above, Ms. Graham tripped on a raised area in the walkway.
- 4. At all times material, the aforesaid sidewalk in the City and County of Milwaukee, State of Wisconsin, was a public walkway and the aforesaid deviation and protrusion had existed for a long period of time.

- 7. As a direct and proximate result of the negligence of the City of Milwaukee, Lorette Graham suffered a fractured ankle, mental anxiety and distress, and other personal injuries. Ms. Graham also sustained past and future medical expenses.
