Attached you will find the most current inventory of existing and proposed community living arrangements, adult family homes and shelter care facilities in the City of Milwaukee. Facilities are listed in street order by aldermanic district, with existing facilities and proposed facilities listed separately. The legend on the following page explains the abbreviations for client types and facility types used in the lists.

Also attached is a table showing the 2000 population of each aldermanic district broken down by racial category, as well as the median household income of each district.
