N. Servite Dr. – W. Dean Rd. to a point 860 feet m/l south of W. Brown Deer Rd. (Including W. Dean Rd., W. Wabash Ct., and W. Donna Ct.) (ST211130106):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding (5-foot width of tree border area), grading, and tree removal where necessary.

10th Aldermanic District

W. Trenton Pl. – N. Hawley Rd. to W. Valley Forge Dr. (ST211140143):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (7-foot width of tree border area), and grading.

W. Walker St. – S. 2nd St. to S. 3rd St. (ST211150184):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, narrow street from 46 feet to 36 feet, sodding (10 – 12-foot width of tree border area), and grading.
