

The Milwaukee Police Department's investigation regarding this application revealed the following:

Dear Alderman Murphy,

which is an easy walk to Fat

Valdys -- just south to the corner and west on Bluemound Road -- in all about two blocks. We dined and drank beer and wine at the location when it was Fiesta Garibaldi, and we now have had dinner at Fat Valdys a few times. As for the menu and overall dining experience, we can see that the new ownership has made good improvements, no doubt many expensive ones. The food and service is good; the owner or manager, whom we've had friendly conversations with, shows that he cares about his business and

customers; and one night a two-trumpet, Mariachi band was in fine form, and everyone was having a great time. So we hope the business does well and continues.

We do not agree, however, with the proposal to close daily at 2 a.m. We're fine with the live band music, but not until 2 in the morning, if that's also what is proposed. We weren't able to attend Monday's neighborhood meeting at Hawley Avenue school to explain the following:

Fat Valdys' location, unlike the other licensed locations on Bluemound, edges right next the densest portion of Story Hill's residential neighborhoods, to the east of the location on the north and south sides of Bluemound. With the reopening of that tavern/restaurant location (with new name and ownership) and the opening of Story Hill BKC, we have personally witnessed a major increase in vehicle parking on both sides of 50th and on Bluemound, along with customer walking traffic to and from them. While that may detract somewhat from the formerly quiet feel of 50th Street, we also appreciate having responsibly-run restaurants and taverns nearby. But based on past unpleasant experiences in a few of the many Milwaukee neighborhoods where we've lived (and moved out because of noise issues), we think it would be a bad idea to allow restaurant/bar/entertainment, with the resulting increase in sidewalk traffic and parking activity, to continue into the wee hours of each night.

Fat Valdys owners knew that their location abutted some quiet neighborhoods, unlike those establishments to the west, where the business look and presence on Bluemound is more prominent. We applaud their decision to do business here. But their interests at the cash register should take second place to their neighbors' being able to enjoy quiet nights of relaxation and sleep.
