If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Donald Krenzien, assigned District One, Late Power Shift.

On the evening of Thursday, February 26, 2015 through the morning of Friday, February 27, 2015 District One personnel performed an underage tavern enforcement initiative. The officers who participated in the operation were Police Officer Christopher Martin, assigned to District One, Police Officer Dorian Andress assigned to District 3, and myself. For the underage persons in this initiative we used one MPD police aide who work in the Police Administration Building. Police Aid Teresa Westfahl assigned to the Police Academy.

Prior to attempting any checks of licensed class B tavern establishments the police aide and plainclothesed police officer were given instructions. Westphal and Andress were told that they were not allowed to consume any intoxicating beverages. They could not lie if asked if they were underage, or show any form of documentation, which could be construed as identification. It was explained that they had to order a Miller Lite Beer, directly from a bartender behind a bar, then meet the plainclothes officer observing them with the alcoholic beverage for a photo in the tavern and then leave together. It was explained that at all times the plainclothes officer shadowing them would be in visual sight and observe the financial transaction for alcoholic beverages.

After this briefing Martin and I escorted P.O. Andress who was in plainclothes and P.A. Westfahl to multiple taverns located throughout the District One boundaries.

Westfahl and Andress attempted to gained entry to the class "B" licensed tavern, Pub Club located at 1103 N Old World Third St. Andress was challenged at the point of entry and she showed her Wisconsin states identification card proving she was of age, Westfahl stated she could not find hers. Westfahl was waived into Pub Club by the bouncer (Arab male, 5'3 to 5'4, wearing a white t-shirt and jeans). Once in side of the tavern Westfahl purchased a can of Pabst Blue Ribbon at the bar for \$4.00.

Westfahl was served at the bar by a white female approximately 5'3, 130lbs wearing a grey shirt and black shorts.

A photograph on CDR with Westfahl holding the alcoholic beverage is placed on inventory 15008029\_1.

I informed Jacob Dehne that they failed. Dehne was also notified that citations are pending.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

We have occupied this building since July 2007 and used the loading zone located in front of Renaissance Book Shop at 834 N. Plankinton Avenue that extended, at least by signage, to cover our building, for our daily deliveries, service calls, employee and client arrivals and departures. Benihana Restaurant located at 850 N. Plankinton Avenue also makes extensive use of this loading zone for their daily deliveries. As the Renaissance Book Shop has been closed by the city, the loading zone expired. It is important for vehicular and pedestrian safety for Benihana and us to have a designated, legal loading zone to support our operations. (See the accompanying statement from Benihana's General Manager).

Because of the restaurants proximity to the corner of Plankinton Avenue and Kilbourn Street and the presence of the bus stop on the southeast corner of the intersection, delivery and service vehicles cannot park in front of the restaurant. If there is no loading zone in front of our building, delivery and service vehicles will be forced to double-park. This will block at least one lane of traffic forcing northbound vehicles turning east onto Kilbourn Avenue to go around the service and delivery vehicles. Double parked larger vehicles, such as semi-trucks that frequently deliver supplies to Benihana, will, based on my personal observations, actually block both lanes forcing north-bound traffic (including buses) into the southbound lanes. As if this were not bad enough, there is a cross walk across the turn lane just north of where vehicles would have to double park. The presence of doubled-parked delivery trucks would create a blind spot for pedestrians and vehicles forced to go around the double-parked delivery trucks resulting in an extremely dangerous situation.

Regarding the availability of parking in the block in which the loading zone is requested, only three parallel spots will be affected. Ample parking already exists on the street and in surface and building lots on Plankinton Avenue and 2<sup>nd</sup> Street. Moreover, since our application only seeks to have the

loading zone active between 7 am and 6 pm, event and overnight parking remains available for those three spots.

In view of the above-described concerns, it is our opinion that traffic and safety concerns would be better served if we, Boyle Fredrickson S.C., are permitted to maintain a loading zone in front of our building.

To Whom It May Concern:

I am Sabah Liddawyeh, the General Manager of Benihana located at 850 N. Plankinton Ave, next to Boyle Fredrickson, S.C., which is located at 840 N. Plankinton Ave.

During my time at Benihana, there has always been a loading zone located in front of the building where Boyle Fredrickson has its offices. That has been important because we receive numerous deliveries every day and the delivery vehicles use that space.

Our restaurant is situated right at the corner of Kilbourn Avenue and Plankinton Avenue. There is a dedicated turning lane directly in front of our building to turn right onto Kilbourn Avenue. If delivery vehicles parked directly in front of our building, that lane would be blocked. Similarly, there is an alley directly to the south of our building. If delivery vehicles blocked that alley, it would cause problems with the people that use that alley for parking, city work and other things. Stated another way, there is no way for a loading zone to be placed directly in front of our building for delivery without causing traffic and other problems.

If there is no loading zone in front of Boyle Fredrickson's building, delivery vehicles delivering supplies to our restaurant will be forced to double park. This will block one lane of traffic forcing vehicles turning right onto Kilbourn Ave. to go around the delivery vehicles. Since there is a cross walk right where the turning lane begins, this will be very dangerous for our patrons and general pedestrians. This will also create additional traffic and pedestrian problems when both Boyle Fredrickson and Benihana are both receiving deliveries.

In view of these concerns, it is my opinion that it would be better for traffic, pedestrians and overall safety if Boyle Fredrickson is able to maintain a loading zone in front of its building.

On the evening of Saturday May 3rd, 2014 through the morning of Sunday May 4th, 2014 District One personnel performed an underage tavern enforcement initiative. The officers who participated in the operation were officers Robert FERRELL, District One, Power Shift, Jennifer RAMOS, District One, Late Shift, Anthony KRUEGER, District One, Early Shift, and myself. For the underage persons in this initiative we used two MPD police aides who work in the Police Administration Building. They were P.A. Paige CARLONI, W/F 12-15-93, Sensitive Crimes Day Shift, and P.A. Kourtney HARTL, W/F 06-18-94, Central Booking Day Shift.

Prior to attempting any checks of licensed class B tavern establishments the police aides were given instructions. CARLONI and HARTL were told that they were not allowed to consume any intoxicating beverages. They could not lie if asked if they were underage, or show any form of documentation, which could be construed as identification. It was explained that they had to order a Miller Lite Beer, directly from a bartender behind a bar, then meet the plainclothes officer observing them with the alcoholic beverage for a photo in the tavern and then leave together. It was explained that at all times the plainclothes officer shadowing them would be in visual sight and observe the financial transaction for alcoholic beverages.

After this briefing I escorted P.O. Anthony Krueger who was in plainclothes and P.A. HARTL. While P.O. FERRELL escorted P.O. RAMOS in plainclothes, and P.A. CARLONI to multiple taverns located throughout the District One boundaries.

P.A. HARTL attempted to gained entry to the class "B" licensed tavern, Old German Beer Hall located at 1009 N. Old World Third St. P.A. HARTL was challenged at the point of entry and turned away when she couldn't prove she was of age.

Since there was no violation this tavern was not notified that this PA-33 was filed.

8. On 04/03/10 at 1:45 am, Milwaukee police were dispatched to a Battery complaint that occurred at 1033 N OWT Street. Police were advised by security that a fight occurred inside the bar near the bathrooms with a female being injured. Investigation revealed a large fight did take place with a woman sustaining lacerations to her arm and back, which required 70 stitches to close. Police spoke with security officer Clarence Williams who stated he didn't know what started the fight and that it all happened so fast. Williams stated that he and other security personnel were trying to escort everyone out of the bar when he noticed an injured patron with a large laceration to her arm that was bleeding. He then took the patron to the back hallway, away from the people and called police. As police entered the club to check for the scene, they noticed there was no blood in the club area due to security cleaning it up. Officers observed no signs of a fight taking place inside the club. Police spoke with a friend of the victim who witnessed what occurred and took her statement about what occurred. She stated that her friend was kicked and punched by several females who were wearing high heels and stomping on her friend after she attempted to talk to someone she knew on the floor. Officers asked to view video surveillance of the fight but found that the cameras did not capture what occurred due to where the fight took place. After the fight, security made all patrons leave and closed the bar.

9. On 11/28/2013 Milwaukee police were flagged down regarding a battery complaint at 1033 North Old World Third Street (Notte night club inside Tutto restaurant). Investigation revealed a fight had occurred inside the nightclub resulting in the female victim sustaining multiple injuries to her head. Milwaukee police incident report #133320011 filed.

- 10. On 05/17/2014 Milwaukee police observed a fight at the rear of 1033 North Old World Third Street. Officers dispersed the altercation and arrested the primary aggressors. Investigation revealed the involved parties had been at Tutto (1033 North Old World Third Street) and were escorted out of the business by security when they began to fight. Three of the parties were cited.
- 11. On 11/02/2014, Milwaukee police were flagged down by a bouncer for Notte (1033 North Old World Third Street). Officers discovered several altercations between two groups of patrons. Additional officers were requested and a total of 12 squads responded. One subject was arrested for resisting an officer.
- 12. On 01/03/2015, Milwaukee police officers were monitoring Notte Night Lounge (1033 North Old World Third Street). While monitoring, officers became aware of a large crowd in front of the business and observed a subject bleeding from the mouth with blood on his shirt. This subject took off his shirt and ran from officers. This subject, and another subject who refused to comply with officers orders, were cited for disorderly conduct and resisting an officer.

- 13. On 01/24/2015, a citizen, Andrew Wagner, told Milwaukee police he wished to turn over a cell phone and a USB drive that contained photos and video of incidents that occurred outside of Notte (1033 North Old World Third Street). The video shows a large crowd of people acting in a disorderly manner in front of Notte (1033 North Old World Third Street) prompting a substantial police response. The images were copied to a CD-R which was placed on inventory with the Milwaukee police department.
- 14. On 03/15/2015, Milwaukee police were observing bar closings in the 1000 block of North Old World Third Street. The occupants of a vehicle parked in front of the unmarked squad car began arguing with a group of people on the sidewalk. One of the occupants exited the vehicle and started fighting with one of the people on the sidewalk. When officers intervened, neither subject would stop fighting. Both subjects were subsequently sprayed by officers with Oleoresin Capsicum (OC spray) and cited for disorderly conduct and resisting an officer. Officers observed both subjects exit Notte Night Lounge (1033 North Old World Third Street) at bar close.
- 15. On 03/22/2015, Milwaukee police were monitoring bar close at Notte (1033 North Old World Third Street). Officers became aware of a large group leaving Notte, one of the subjects appeared intoxicated and began fighting with others in the same group. Officers approached this group and were told that they were simply trying to get their friend to a car so they could go home. The group became agitated with police and security from the business, making threats. One of the members of the group, Jose Ortiz, punched a security guard in the face. Ortiz resisted officer's attempts to place him into custody and was sprayed with Oleoresin Capsicum (OC spray). Another subject from this group, Alvin Ortiz, attempted to assist Jose Ortiz and was cited for obstructing arrest. During this incident, another subject, Marchello Vasquez, from this same group struck an officer in the back of the head. Vasquez was taken into custody for resisting arrest and battery to police officer.
- 16. On 03/28/2015, Milwaukee police were monitoring bar close at Notte (1033 North Old World Third Street). Officers became aware of an altercation inside the business and discovered that security removed several patrons earlier in the evening. These patrons remained on the sidewalk outside of the business and verbally harassed security. At bar close, several patrons became involved in altercations of varying degrees while other patrons were trying to leave. The crowds eventually dispersed and no additional reports were filed.

Officers discovered the subject in front of Notte, Stephen Roe who works as security for the business, had been shot in the right arm. The suspect in this shooting, Jamel Braylock, later told police he had been involved in a fight inside Notte earlier in the evening and security had escorted everyone outside. Braylock stated that once outside, the same group that he had been involved in the fight with approached him. Braylock retrieved a firearm from the glove-box of his car which he used to shoot Roe once in the arm. Additionally, on 04/04/2015 at 1:00am a shooting occurred at 2627 West Capital Drive. The victim's in the shooting, Lexus Evans and

Branden Crawley, were at Notte earlier in the evening with Jamel Braylock (the suspect in the earlier shooting) when they were all escorted from the business by security.

19. Regarding the initial battery complaint mentioned in item #18, officers discovered the victim in that offense, Andrew Smith, had left Notte Nite Lounge (1033 North Old World Third Street) after a large fight broke out inside the business. 3 subjects jumped Smith in the alley as he was walking to his vehicle. One of the subjects struck Smith in the face breaking his glasses and causing a laceration above his left eye. Smith received 1-4 stitches at Froedtert Hospital.  8. On 04/03/10 at 1:45 am, Milwaukee police were dispatched to a Battery complaint that occurred at 1033 N OWT Street. Police were advised by security that a fight occurred inside the bar near the bathrooms with a female being injured. Investigation revealed a large fight did take place with a woman sustaining lacerations to her arm and back, which required 70 stitches to close. Police spoke with security officer Clarence Williams who stated he didn't know what started the fight and that it all happened so fast. Williams stated that he and other security personnel were trying to escort everyone out of the bar when he noticed an injured patron with a large laceration to her arm that was bleeding. He then took the patron to the back hallway, away from the people and called police. As police entered the club to check for the scene, they noticed there was no blood in the club area due to security cleaning it up. Officers observed no signs of a fight taking place inside the club. Police spoke with a friend of the victim who witnessed what occurred and took her statement about what occurred. She stated that her friend was kicked and punched by several females who were wearing high heels and stomping on her friend after she attempted to talk to someone she knew on the floor. Officers asked to view video surveillance of the fight but found that the cameras did not capture what occurred due to where the fight took place. After the fight, security made all patrons leave and closed the bar.

9. On 11/28/2013 Milwaukee police were flagged down regarding a battery complaint at 1033 North Old World Third Street (Notte night club inside Tutto restaurant). Investigation revealed a fight had occurred inside the nightclub resulting in the female victim sustaining multiple injuries to her head. Milwaukee police incident report #133320011 filed.

- 10. On 05/17/2014 Milwaukee police observed a fight at the rear of 1033 North Old World Third Street. Officers dispersed the altercation and arrested the primary aggressors. Investigation revealed the involved parties had been at Tutto (1033 North Old World Third Street) and were escorted out of the business by security when they began to fight. Three of the parties were cited.
- 11. On 11/02/2014, Milwaukee police were flagged down by a bouncer for Notte (1033 North Old World Third Street). Officers discovered several altercations between two groups of patrons. Additional officers were requested and a total of 12 squads responded. One subject was arrested for resisting an officer.
- 12. On 01/03/2015, Milwaukee police officers were monitoring Notte Night Lounge (1033 North Old World Third Street). While monitoring, officers became aware of a large crowd in front of the business and observed a subject bleeding from the mouth with blood on his shirt. This subject took off his shirt and ran from officers. This subject, and another subject who refused to comply with officers orders, were cited for disorderly conduct and resisting an officer.

- 13. On 01/24/2015, a citizen, Andrew Wagner, told Milwaukee police he wished to turn over a cell phone and a USB drive that contained photos and video of incidents that occurred outside of Notte (1033 North Old World Third Street). The video shows a large crowd of people acting in a disorderly manner in front of Notte (1033 North Old World Third Street) prompting a substantial police response. The images were copied to a CD-R which was placed on inventory with the Milwaukee police department.
- 14. On 03/15/2015, Milwaukee police were observing bar closings in the 1000 block of North Old World Third Street. The occupants of a vehicle parked in front of the unmarked squad car began arguing with a group of people on the sidewalk. One of the occupants exited the vehicle and started fighting with one of the people on the sidewalk. When officers intervened, neither subject would stop fighting. Both subjects were subsequently sprayed by officers with Oleoresin Capsicum (OC spray) and cited for disorderly conduct and resisting an officer. Officers observed both subjects exit Notte Night Lounge (1033 North Old World Third Street) at bar close.
- 15. On 03/22/2015, Milwaukee police were monitoring bar close at Notte (1033 North Old World Third Street). Officers became aware of a large group leaving Notte, one of the subjects appeared intoxicated and began fighting with others in the same group. Officers approached this group and were told that they were simply trying to get their friend to a car so they could go home. The group became agitated with police and security from the business, making threats. One of the members of the group, Jose Ortiz, punched a security guard in the face. Ortiz resisted officer's attempts to place him into custody and was sprayed with Oleoresin Capsicum (OC spray). Another subject from this group, Alvin Ortiz, attempted to assist Jose Ortiz and was cited for obstructing arrest. During this incident, another subject, Marchello Vasquez, from this same group struck an officer in the back of the head. Vasquez was taken into custody for resisting arrest and battery to police officer.
- 16. On 03/28/2015, Milwaukee police were monitoring bar close at Notte (1033 North Old World Third Street). Officers became aware of an altercation inside the business and discovered that security removed several patrons earlier in the evening. These patrons remained on the sidewalk outside of the business and verbally harassed security. At bar close, several patrons became involved in altercations of varying degrees while other patrons were trying to leave. The crowds eventually dispersed and no additional reports were filed.
- 17. On 04/02/2015, Milwaukee police responded to a property damage complaint 1033 North Old World Third Street (Notte Nite Lounge). Investigation revealed a subject threw a piece of asphalt through a window of the business. The business was closed at the time of this incident and no patrons or employees were present. Milwaukee police incident report #150920008 filed.
- 18. On 04/04/2015, at approximately 12:35am Milwaukee police were flagged down for a battery complaint at 1007 North Old World Third Street. While investigating, officers heard someone screaming in front of 1033 North Old World Third Street (Notte Nite Lounge). Officers discovered the subject in front of Notte, Stephen Roe who works as security for the business, had been shot in the right arm. The suspect in this shooting, Jamel Braylock, later told police he had been involved in a fight inside Notte earlier in the evening and security had escorted everyone outside. Braylock stated that once outside, the same group that he had been involved in the fight with approached him. Braylock retrieved a firearm from the glove-box of his car which he used to shoot Roe once in the arm. Additionally, on 04/04/2015 at 1:00am a shooting occurred at 2627 West Capital Drive. The victim's in the shooting, Lexus Evans and

Branden Crawley, were at Notte earlier in the evening with Jamel Braylock (the suspect in the earlier shooting) when they were all escorted from the business by security.

19. Regarding the initial battery complaint mentioned in item #18, officers discovered the victim in that offense, Andrew Smith, had left Notte Nite Lounge (1033 North Old World Third Street) after a large fight broke out inside the business. 3 subjects jumped Smith in the alley as he was walking to his vehicle. One of the subjects struck Smith in the face breaking his glasses and causing a laceration above his left eye. Smith received 1-4 stitches at Froedtert Hospital. On 05-17-14 at around 1:22 am, Squad 1440, P.O.'s COURT and Joshua POST, along with Squad 1441, P.O.'s Jeremy GREENE and Jeremy LIMBERG, observed a fight behind 1033 N. Old World Third Street. Officers quickly dispersed the altercation, took the primary aggressors into custody and interviewed the security of "Tutto" who were helping break-up the altercation because the actors were inside their tavern earlier in the evening.

He stated that he was working at the back door when the incident occurred. He relayed that a group of females were escorted out of the tavern for arguing and starting to fight inside the club. He radioed the bar manager about the females arguing in the parking lot and the bar manager (TAGLIAVIA) exited the rear door of the club and approached the females trying to get them to leave. The females then began fighting. EASLEY said a female and male were in a parked car and started fighting with several other females. Everyone fighting in the lot were the people kicked out of the club earlier. He stated that he got between the females that were fighting and they started attacking him. EASLEY was unable to get them to stop fighting and leave until officers arrived and arrested several of the females.

#### Bar Manager

Donato TAGLIAVIA m/w 03-10-1973 2420 Napa TRL, Waukesha, WI 53188. 517-0024. He said the back door security called him over a hand held radio telling him about a group of females were arguing in the parking lot behind the club. On Saturday, January 3, 2015 at 2:05A, Sq 1420 (myself and PO Christopher MARTIN) were on a park and walk in the 1000 block of N. Old World Third St. We started to monitor Notte Night Lounge let out, which is located at 1033 N Old World Third St.

While monitoring the let out, we were attempting to disperse the large crowd that was gathering in front of Notte, when we observed a B/M later identified as David T. CALDWELL (B/M 06-02-1989) wearing a white tank top bleeding from his mouth and blood on the front of his tank top. I observed that CALDWELL was visibly upset and he stated someone inside Notte punched him in the mouth. I observed CALDWELL walk N/B on N Old World Third St., take off his shirt, and run W/B through 1041 N. Old World Third St. Mader's Restaurant parking lot. I observed CALDWELL jump MADERS' fence and run S/B through the alley behind Mader's in the 1000BLK between N. Old World Third St and N. 4Th St. PO MARTIN and I ran around the block going W/B on Highland Ave then S/B through the alley chasing after CALDWELL, CALDWELL then ran E/B between two buildings at 1033 N. Old World Third St. I continued S/B through the alley and then E/B through the alley in the direction CALDWELL ran. When I returned to the front of 1033 N. Old World Third, I observed a group of people confronting other officers (PO Paul BJORKQUIST and PO Joseph SERIO) and yelling "Why is he getting arrested!?" PO MARTIN, PO SERIO and I attempted to keep the crowd away from PO BJORKQUIST who was escorting CALDWELL to a squad car. While keeping the crowd away a B/F fell to the ground at which time PO Jeffrey PIERSON joined us. We continued to give lawful commands to individuals to "stay back". The B/F then got back to her feet and I saw PO MARTIN order another individual to stay back while placing his right hand on him pushing back to create distance. This individual was later identified as Delon L WILLIAMS (B/M 12-26-1989, 1711 W Grant St #4, (414) 232-8751) WILLIAMS approached officers again, failing to comply with PO MARTIN'S lawful order to stay back. PO MARTIN again ordered him to stay back while using his right hand to push WILLIAMS back to create distance. WILLIAMS again approached the group of officers and PO MARTIN again gave WILLIAMS a lawful order to stay back while using his right hand to push him back to create distance. At which time WILLIAMS took up a boxer's stance (clinching his fists and squaring his shoulders up) towards officers. PO MARTIN immediately conducted a pull - in - push - down decentralization and stabilized his right hand behind WILLIAMS back, at which time I stabilized his left hand behind his back. This report was written by PO John Majerle, assigned to the Office of Community Outreach and Education, early power shift.

On March 15, 2015, at 2:22 am, Squad 1447 (PO Erik Nordstrum and I) were monitoring bar dismissal on N Old World Third St. We were in an unmarked squad car facing northbound in the 1000 block of N Old World Third St. I observed a red vehicle park about 30 feet in front of us facing northbound as well. The occupants of the vehicle were arguing with another group that was on the sidewalk on the east side of the street.

There were about 4 or 5 passengers in the vehicle. One of the passengers (Toledo), on the passenger's side, exited the vehicle and started a physical fight with one of the subjects (Davis) on the sidewalk. PO Nordstrum and I then pulled our squad car up to the altercation (1030 N Old World Third St).

PO Nordstrum was attempting to pull Davis away from the fight, but both Davis and Toledo were on the ground. Both Davis and Toledo had a tight grasp on the other's hair.

I then told each party to let each other go and neither party would let each other go. PO Nordstrum continued to attempt to get Davis away, with no success. I then informed PO Nordstrum that I was going to spray the subjects. I also yelled at Davis and Toledo that if they did not stop fighting, I would spray them. The two continued to fight. I sprayed Toledo for about 2 seconds, then sprayed Davis for about 2 seconds.

We were able to get the two subjects away from each other and call for additional squads to help disperse the crowd.

It should be noted that both PO Nordstrum and I observed both subjects coming out of Notte Night Lounge at bar close. Both subjects' friends stated that they were having verbal arguments inside Notte before they had left at Bar close.

Both subjects were given citations for Disorderly Conduct and Resisting an Officer.

On Sunday, March 22, 2015 at approximately 2:19am Police Officer Christopher Martin and I (Squad 1420) were monitoring bar close at Notte located 1033 N Old World 3<sup>rd</sup> Street when a disturbance started.

While monitoring the closing of Notte, a large group of Hispanic males started to leave Notte when one of the Hispanic males who was heavily intoxicated started to fight his friends. We approached them and the Hispanic males stated that they were just trying to get their friend to the car, so they could go home. We allowed the group to go through the private alley located next to 1031 N Old World 3rd Street which is monitored by Notte's security staff so they could get to the parking lot on the corner of Fourth Street and State Street. Once the group approached the parking lot I observed the highly intoxicated Hispanic male start to push his friends again, while I was standing in front of 1031 Old World 3<sup>rd</sup> Street P.O Martin and I along with several security members from Notte went to the alley near the parking lot in attempt to get the group to leave the area and go home. The group stated that they had to got to the parking lot near Old World Third Street and State Street at which time we told them to walk to their vehicle. They started to walk through the private driveway, when they became very agitated towards us (police) and towards the Notte security. Several people in the group stated words to the affect of if we didn't have our badges we would not act like how we were acting. They also stated that they we are going to whoop our (police) ass and the bouncers' ass. While walking one of the subjects later identified as Jose L Ortiz (W/M 05/18/88 1106A S. 34th St) all of sudden struck Notte security member later identified as Cecil Miller (B/M 02/11/81) with a closed right first. After striking Miller, Ortiz ran at which time another Notte security member identified as Deron D Choamicki (B/M 02/11/70) tripped him. I attempted to place Ortiz into custody with Choamicki assisting. I placed a handcuff on Ortiz's right hand, I then attempted to take control his left hand and place it into the handcuff, at this time Ortiz pulled his left arm away from me and then placed it under his body. I attempted to remove his arm from under his body at this time he tensed up, P.O. Martin administered a short burst of Oleoresin Capsicum (OC Spray) to Ortiz allowing me to place his left hand into the handcuff.

I had Ortiz in custody and ground stabilized while waiting for a squad car to report to my location, a subject later identified as Alvin J Ortiz (W/M 03/23/1989) approached Ortiz and I. Alvin came to his knees and grabbed Ortiz's left shoulder attempting to get Ortiz away from my control. Alvin turned and faced away from me as he was confronted by Notte's security at that time I took control of Alvin's belt with my left hand and pulled him to where I could maintain my ground stabilization of Ortiz and place handcuffs on Alvin, P.O. Jutiki X arrived on scene and assisted me in placing Alvin into custody. Alvin was cited for obstructing arrest and the citation number is 48909311139. Alvin was cited and released.

While administering OC spray Marchello J Vasquez (W/M 7/12/82) who was a member of the Hispanics leaving Notte struck PO Martin in the back of the head. PO Martin called 10-17 for additional squads. Vasquez was taken into custody at approximately 103 E State Street for battery to PO and resisting arrest.

This report is written by Donald Krenzien, assigned to District 1, late power shift part of Code Red on Old World 3rd Street.

On Saturday, March 28, 2015 at approximately 2:00am Police Officer Daniel Boeck and I (Squad 1420) were monitoring the bar close at Notte located 1033 N Old World 3rd Street when a disturbance started inside of the club.

Notte Security staff that was monitoring the door was called to assist security staff in the upstairs portion of the club for an altercation. Approximately four or five patrons were physically removed from the club by Notte security staff; after the patrons were removed they stayed on the sidewalk in front of 1033 N Old World 3rd Street and continued to threaten Notte's security staff while attempting to gain access back into Notte. While trying to manage the situation Notte's security staff flooded the entrance area with security guards in order to disperse the group. In the process tension between the Notte security staff and the crowd quickly escalated.

These actions caused verbal and physical disturbance at bar close while other patrons were trying to leave Notte. A crowd of approximately thirty to forty people engaged in the disturbance in various ways. I called for additional squads for back up at 1033 N Old World 3rd street.

A black male approximately 5'5 to 5'6 160 pounds that was removed from the club made complaints that a Notte bouncer choked him unconscious and let him lay on the floor of the club for five minutes until he regained consciousness. A black male approximately 6'1 to 6'2 200 pounds claimed he was pepper sprayed by Notte's security staff while inside the establishment during the incident while inside of the club however; both patrons were not interviewed because they left the scene before a police officer could interview them.

After the crowd dispersed I conducted follow up with Notte on the second floor of Notte. My investigation revealed that the group was removed because of a fight. In the process of removing the two previously stated black males a black female approximately 5'5 210 pounds struck a bouncer in the head with a glass at the top of the stair case leading from the main entrance to the upstairs club. While doing a quick canvass inside the club I observed the broken glass cup at the top of the staircase. There was no evidence of pepper spray being used and no other complaints of patrons coming into contact with pepper spray.

In total, 15 Police Officers and 2 Police Sergeants responded to this incident.

### Property Damage 4/2/15 IR#150920008

On Thursday, April 02, 2015 at approximately 1:14am, my partner PO Corstan COURT and I, PO Jeremy Greene, Squad 1440 were flagged down for a property damage complaint at 1033 N. Old World 3rd St "NOTTE NITE LOUNGE". I spoke with the complainant who was identified as Nicole M. ENEA, F/W, 01/21/82. ENEA stated that she was notified that the front window of the tavern had an object thrown through it, which caused the window to shatter. ENEA lives above the tavern and is also an employee of the tavern. The tavern was not open and there were no patrons or employees present at the time of the incident.

The window that was shattered faces east towards N. Old World 3rd St. Upon investigation, I observed the damaged window. The window appeared to be approximately 10ft x 10ft. The window had a significantly large hole in the center of it. Around the hole the rest of the glass was spider cracked. Upon entering the tavern I observed 1 piece of concrete and 1 piece of asphalt lying on the floor.

PO COURT and I spoke with the owner of the business who was identified as Salvatore G. SAFINA, M/W, 07/27/73. SAFINA arrived on-scene and immediately proceeded to review his surveillance video. Upon observing the video, PO COURT and I observed a light skinned b/m wearing a dark sweatshirt or jacket, and black pants walking south on the sidewalk in front of the tavern at approximately 1:09am. The subject stopped in front of the window to the tavern, at which time he threw an object through the window. On video, it appeared that the subject was recording his actions as he had a cell phone in his hand with the light illuminating the scene. The subject fled west down the alleyway after damaging the property.

SAFINA stated that the window was specially made and shipped from Colorado and cost approximately \$5,000. SAFINA stated that he would make a copy of the video. I took 9 photos of the scene and evidence at 1:24am. I filed a report regarding the incident IR#150920008.

## April 4, 2015 Shooting IR#150940012

On Saturday, April 04, 2015 at approximately 12:35am, my partner PO Donald KRENZIEN and I, along with SGT. HONZELKA, were flagged down for a battery complaint in front of 1007 N. Old World 3<sup>rd</sup> St. Upon attempting to speak with the victim, we heard a subject screaming. We looked north up the sidewalk to where we heard the screaming and observed a b/m subject on the ground screaming, the subject appeared to be in front of the Notte Nite Lounge, located at 1033 N. Old World 3<sup>rd</sup> St. I also observed citizens on the sidewalk to be scattering away from the area.

PO KRENZIEN and I made our way towards the subject at which time we observed him to be screaming in pain and holding his right arm. The subject stated he had been shot. The subject was later identified as Stephen J. ROE, m/b, 01/26/71 who I recognized as a Notte security guard. We were then informed by another security guard, who was later identified as Deron D. CHOAMICKI, m/b, 02/11/70 that the suspect just fled East through the alley and entered the Journal Sentinel parking lot. PO KRENZIEN and I cleared the alley and then observed a B/M subject running south through the parking lot. PO KRENZIEN and I pursued the subject on foot and notified dispatch of the fleeing subject and his direction. PO Todd BOHLEN and PO KRENZIEN took the subject into custody at 1001 N. Old World 3<sup>rd</sup> St. The subject was identified as Jamel L. BRAYLOCK, M/B, 02/28/92. BRAYLOCK was in possession of a firearm.

On Saturday April 04, 2015, Detective Nathan BUTZ conducted a mirandized interview of BRAYLOCK. During the interview BRAYLOCK stated that he was a patron inside Notte Nite Lounge on the night of the incident. BRAYLOCK stated that he was in the tavern with his brother Jihad S. Williamson, M/B, 03/24/94, and his brother's friend "Brandon". BRAYLOCK stated that the tavern was very busy and while inside he bumped into another subject, who punched him in the face and a fight started. BRAYLOCK stated that security surrounded them and escorted everyone outside. BRAYLOCK stated that once outside the tavern he observed the group of subjects that he was involved in the fight with. BRAYLOCK stated that the subjects started coming towards him so he went to his vehicle and retrieved a firearm from the glove box, which he subsequently used to shoot Stephen J. ROE, m/b, 01/26/71, once in the right tricep.

ROE was conveyed to Froedtert hospital by Bell 417 and admitted at 1:32am with DR. Jacob Peterson as the admitting physician.

## April 4, 2015 Shooting (IR# 150940015)

On Saturday, April 4, 2015 at approximately 1:00am a shooting occurred at 2627 West Capitol Drive. The victim's in the shooting were identified as Lexus D Evans (B/M 7/10/92) and Branden C Crawley (B/M 11-5-92). Evans stated that he was at Notte Nite Lounge with Crawley and Jamel L Braylock (B/M 2/28/92). Braylock and Jihad Williamson (B/M 3/24/94) who was the suspect in the shooting of Notte Nite Lounge security officer Steven J Roe (B/M 1/26/71)

Evans stated that there was a bar fight between Braylock and several other patrons at Notte. Evans stated that they all got involved in the fight because several people were jumping on Braylock. Evans stated that they were all removed from the establishment.

Crawley stated that they were at Notte Nite Lounge, prior to them going to the gas station located on W Capitol Drive and N 27<sup>th</sup> Street

Williamson is Braylock's brother.

## Statement from Notte's General Manager Donny Safina:

On Saturday, April 5, 2015 at approximately 1:15am PO Donald KRENZIEN spoke to Donny Safina who is the General Manager of Notte and Tutto, Safina told me that Notte staff has decided to close Notte on Fridays and just operate as the restaurant until further notice. Safina also stated that they are going to look into changes for Saturday nights. Safina stated that when the club reopens on Friday nights they will look into changing music played and other changes marketed towards a different cliental. Safina also stated that he was looking into expanding Tutto's restaurant into the second floor.

On Saturday, April 04, 2015 my partner PO Donald KRENZIEN and I were on a code red "Responsible Entertainment District Deployment" on N. Old World 3<sup>rd</sup> St to monitor taverns and crowds.

At approximately 12:35am, PO KRENZIEN, SGT. HONZELKA, and I were flagged down for a battery complaint in front of 1007 N. Old World 3rd St. The victim was later identified as Andrew C. SMITH, M/B, 12/08/88. SMITH had laceration above his left eye that was bleeding profusely. PO Austin LLANAS, squad 1340 took over the investigation.

On April 4, 2015 Detective Eric DRAGER spoke with SMITH regarding the substantial battery, due to the incident occurring in the same area and around the same time that a shooting occurred IR#150940012. SMITH stated that he was a patron inside Notte Nite Lounge on the night of the incident. SMITH stated that he left the tavern after a large fight broke out inside the tavern. SMITH stated that after he exited the tavern he was walking back to his vehicle when he was approached by 3 B/M subjects who jumped him in the alley between N. Old World 3<sup>rd</sup> St and N. 4<sup>th</sup> St. SMITH stated that he was struck in the face by one of the suspects, which caused his glasses to break and the laceration above his left eye. SMITH stated that the suspects then chased him east up the private alley, which is adjacent to Notte Nite Lounge and located on the south side of the tavern. SMITH stated that he flagged down a security guard that works for the tavern and pointed out the subjects that were chasing him. SMITH stated that the security guard started walking down the alley towards the suspects. SMITH stated that he then flagged down MPD officer's who in regards to the incident, at which time he heard a single gunshot come from the alley. SMITH was taken to Froedtert hospital where he was admitted at 1:26am and treated by DR. Matt TEWS. SMITH received 3-4 stitches to close his laceration.

Prior to the shooting Sgt Honzelka, PO KRENZIEN and I assisted Notte security disperse several subjects that were removed from Notte. One group of the subjects left northbound on Old World 3<sup>rd</sup> St, while the other group dispersed southbound on Old World 3<sup>rd</sup> Street.

On Saturday, January 3, 2015 at 2:05A, Sq 1420 (myself and PO Christopher MARTIN) were on a park and walk in the 1000 block of N. Old World Third St. We started to monitor Notte Night Lounge let out, which is located at 1033 N Old World Third St.

While monitoring the let out, we were attempting to disperse the large crowd that was gathering in front of Notte, when we observed a B/M later identified as David T. CALDWELL (B/M 06-02-1989) wearing a white tank top bleeding from his mouth and blood on the front of his tank top. I observed that CALDWELL was visibly upset and he stated someone inside Notte punched him in the mouth. I observed CALDWELL walk N/B on N Old World Third St., take off his shirt, and run W/B through 1041 N. Old World Third St. Mader's Restaurant parking lot. I observed CALDWELL jump MADERS' fence and run S/B through the alley behind Mader's in the 1000BLK between N. Old World Third St and N. 4Th St. PO MARTIN and I ran around the block going W/B on Highland Ave then S/B through the alley chasing after CALDWELL. CALDWELL then ran E/B between two buildings at 1033 N. Old World Third St. I continued S/B through the alley and then E/B through the alley in the direction CALDWELL ran. When I returned to the front of 1033 N. Old World Third, I observed a group of people confronting other officers (PO Paul BJORKQUIST and PO Joseph SERIO) and yelling "Why is he getting arrested!?" PO MARTIN, PO SERIO and I attempted to keep the crowd away from PO BJORKQUIST who was escorting CALDWELL to a squad car. While keeping the crowd away a B/F fell to the ground at which time PO Jeffrey PIERSON joined us. We continued to give lawful commands to individuals to "stay back". The B/F then got back to her feet and I saw PO MARTIN order another individual to stay back while placing his right hand on him pushing back to create distance. This individual was later identified as Delon L WILLIAMS (B/M 12-26-1989, 1711 W Grant St #4, (414) 232-8751) WILLIAMS approached officers again, failing to comply with PO MARTIN'S lawful order to stay back. PO MARTIN again ordered him to stay back while using his right hand to push WILLIAMS back to create distance. WILLIAMS again approached the group of officers and PO MARTIN again gave WILLIAMS a lawful order to stay back while using his right hand to push him back to create distance. At which time WILLIAMS took up a boxer's stance (clinching his fists and squaring his shoulders up) towards officers. PO MARTIN immediately conducted a pull - in - push - down decentralization and stabilized his right hand behind WILLIAMS back, at which time I stabilized his left hand behind his back. On March 15, 2015, at 2:22 am, Squad 1447 (PO Erik Nordstrum and I) were monitoring bar dismissal on N Old World Third St. We were in an unmarked squad car facing northbound in the 1000 block of N Old World Third St. I observed a red vehicle park about 30 feet in front of us facing northbound as well. The occupants of the vehicle were arguing with another group that was on the sidewalk on the east side of the street.

There were about 4 or 5 passengers in the vehicle. One of the passengers (Toledo), on the passenger's side, exited the vehicle and started a physical fight with one of the subjects (Davis) on the sidewalk. PO Nordstrum and I then pulled our squad car up to the altercation (1030 N Old World Third St).

PO Nordstrum was attempting to pull Davis away from the fight, but both Davis and Toledo were on the ground. Both Davis and Toledo had a tight grasp on the other's hair.

I then told each party to let each other go and neither party would let each other go. PO Nordstrum continued to attempt to get Davis away, with no success. I then informed PO Nordstrum that I was going to spray the subjects. I also yelled at Davis and Toledo that if they did not stop fighting, I would spray them. The two continued to fight. I sprayed Toledo for about 2 seconds, then sprayed Davis for about 2 seconds.

We were able to get the two subjects away from each other and call for additional squads to help disperse the crowd.

It should be noted that both PO Nordstrum and I observed both subjects coming out of Notte Night Lounge at bar close. Both subjects' friends stated that they were having verbal arguments inside Notte before they had left at Bar close.

Both subjects were given citations for Disorderly Conduct and Resisting an Officer.

On Sunday, March 22, 2015 at approximately 2:19am Police Officer Christopher Martin and I (Squad 1420) were monitoring bar close at Notte located 1033 N Old World 3<sup>rd</sup> Street when a disturbance started.

While monitoring the closing of Notte, a large group of Hispanic males started to leave Notte when one of the Hispanic males who was heavily intoxicated started to fight his friends. We approached them and the Hispanic males stated that they were just trying to get their friend to the car, so they could go home. We allowed the group to go through the private alley located next to 1031 N Old World 3<sup>rd</sup> Street which is monitored by Notte's security staff so they could get to the parking lot on the corner of Fourth Street and State Street. Once the group approached the parking lot I observed the highly intoxicated Hispanic male start to push his friends again, while I was standing in front of 1031 Old World 3<sup>rd</sup> Street P.O Martin and I along with several security members from Notte went to the alley near the parking lot in attempt to get the group to leave the area and go home. The group stated that they had to got to the parking lot near Old World Third Street and State Street at which time we told them to walk to their vehicle. They started to walk through the private driveway, when they became very agitated towards us (police) and towards the Notte security. Several people in the group stated words to the affect of if we didn't have our badges we would not act like how we were acting. They also stated that they we are going to whoop our (police) ass and the bouncers' ass. While walking one of the subjects later identified as Jose L Ortiz (W/M 05/18/88 1106A S. 34th St) all of sudden struck Notte security member later identified as Cecil Miller (B/M 02/11/81) with a closed right first. After striking Miller, Ortiz ran at which time another Notte security member identified as Deron D Choamicki (B/M 02/11/70) tripped him. I attempted to place Ortiz into custody with Choamicki assisting. I placed a handcuff on Ortiz's right hand, I then attempted to take control his left hand and place it into the handcuff, at this time Ortiz pulled his left arm away from me and then placed it under his body. I attempted to remove his arm from under his body at this time he tensed up, P.O. Martin administered a short burst of Oleoresin Capsicum (OC Spray) to Ortiz allowing me to place his left hand into the handcuff.

I had Ortiz in custody and ground stabilized while waiting for a squad car to report to my location, a subject later identified as Alvin J Ortiz (W/M 03/23/1989) approached Ortiz and I. Alvin came to his knees and grabbed Ortiz's left shoulder attempting to get Ortiz away from my control. Alvin turned and faced away from me as he was confronted by Notte's security at that time I took control of Alvin's belt with my left hand and pulled him to where I could maintain my ground stabilization of Ortiz and place handcuffs on Alvin, P.O. Jutiki X arrived on scene and assisted me in placing Alvin into custody. Alvin was cited for obstructing arrest and the citation number is 48909311139. Alvin was cited and released.

While administering OC spray Marchello J Vasquez (W/M 7/12/82) who was a member of the Hispanics leaving Notte struck PO Martin in the back of the head. PO Martin called 10-17 for additional squads. Vasquez was taken into custody at approximately 103 E State Street for battery to PO and resisting arrest.

This report is written by Donald Krenzien, assigned to District 1, late power shift part of Code Red on Old World 3rd Street.

On Saturday, March 28, 2015 at approximately 2:00am Police Officer Daniel Boeck and I (Squad 1420) were monitoring the bar close at Notte located 1033 N Old World 3rd Street when a disturbance started inside of the club.

Notte Security staff that was monitoring the door was called to assist security staff in the upstairs portion of the club for an altercation. Approximately four or five patrons were physically removed from the club by Notte security staff; after the patrons were removed they stayed on the sidewalk in front of 1033 N Old World 3rd Street and continued to threaten Notte's security staff while attempting to gain access back into Notte. While trying to manage the situation Notte's security staff flooded the entrance area with security guards in order to disperse the group. In the process tension between the Notte security staff and the crowd quickly escalated.

These actions caused verbal and physical disturbance at bar close while other patrons were trying to leave Notte. A crowd of approximately thirty to forty people engaged in the disturbance in various ways. I called for additional squads for back up at 1033 N Old World 3rd street.

A black male approximately 5'5 to 5'6 160 pounds that was removed from the club made complaints that a Notte bouncer choked him unconscious and let him lay on the floor of the club for five minutes until he regained consciousness. A black male approximately 6'1 to 6'2 200 pounds claimed he was pepper sprayed by Notte's security staff while inside the establishment during the incident while inside of the club however; both patrons were not interviewed because they left the scene before a police officer could interview them.

After the crowd dispersed I conducted follow up with Notte on the second floor of Notte. My investigation revealed that the group was removed because of a fight. In the process of removing the two previously stated black males a black female approximately 5'5 210 pounds struck a bouncer in the head with a glass at the top of the stair case leading from the main entrance to the upstairs club. While doing a quick canvass inside the club I observed the broken glass cup at the top of the staircase. There was no evidence of pepper spray being used and no other complaints of patrons coming into contact with pepper spray.

In total, 15 Police Officers and 2 Police Sergeants responded to this incident.

On Thursday, April 02, 2015 at approximately 1:14am, my partner PO Corstan COURT and I, PO Jeremy Greene, Squad 1440 were flagged down for a property damage complaint at 1033 N. Old World 3rd St "NOTTE NITE LOUNGE". I spoke with the complainant who was identified as Nicole M. ENEA, F/W, 01/21/82. ENEA stated that she was notified that the front window of the tavern had an object thrown through it, which caused the window to shatter. ENEA lives above the tavern and is also an employee of the tavern. The tavern was not open and there were no patrons or employees present at the time of the incident.

The window that was shattered faces east towards N. Old World 3rd St. Upon investigation, I observed the damaged window. The window appeared to be approximately 10ft x 10ft. The window had a significantly large hole in the center of it. Around the hole the rest of the glass was spider cracked. Upon entering the tavern I observed 1 piece of concrete and 1 piece of asphalt lying on the floor.

PO COURT and I spoke with the owner of the business who was identified as Salvatore G. SAFINA, M/W, 07/27/73. SAFINA arrived on-scene and immediately proceeded to review his surveillance video. Upon observing the video, PO COURT and I observed a light skinned b/m wearing a dark sweatshirt or jacket, and black pants walking south on the sidewalk in front of the tavern at approximately 1:09am. The subject stopped in front of the window to the tavern, at which time he threw an object through the window. On video, it appeared that the subject was recording his actions as he had a cell phone in his hand with the light illuminating the scene. The subject fled west down the alleyway after damaging the property.

SAFINA stated that the window was specially made and shipped from Colorado and cost approximately \$5,000. SAFINA stated that he would make a copy of the video. I took 9 photos of the scene and evidence at 1:24am. I filed a report regarding the incident IR#150920008.

## April 4, 2015 Shooting IR#150940012

On Saturday, April 04, 2015 at approximately 12:35am, my partner PO Donald KRENZIEN and I, along with SGT. HONZELKA, were flagged down for a battery complaint in front of 1007 N. Old World 3<sup>rd</sup> St. Upon attempting to speak with the victim, we heard a subject screaming. We looked north up the sidewalk to where we heard the screaming and observed a b/m subject on the ground screaming, the subject appeared to be in front of the Notte Nite Lounge, located at 1033 N. Old World 3<sup>rd</sup> St. I also observed citizens on the sidewalk to be scattering away from the area.

PO KRENZIEN and I made our way towards the subject at which time we observed him to be screaming in pain and holding his right arm. The subject stated he had been shot. The subject was later identified as Stephen J. ROE, m/b, 01/26/71 who I recognized as a Notte security guard. We were then informed by another security guard, who was later identified as Deron D. CHOAMICKI, m/b, 02/11/70 that the suspect just fled East through the alley and entered the Journal Sentinel parking lot. PO KRENZIEN and I cleared the alley and then observed a B/M subject running south through the parking lot. PO KRENZIEN and I pursued the subject on foot and notified dispatch of the fleeing subject and his direction. PO Todd BOHLEN and PO KRENZIEN took the subject into custody at 1001 N. Old World 3<sup>rd</sup> St. The subject was identified as Jamel L. BRAYLOCK, M/B, 02/28/92. BRAYLOCK was in possession of a firearm.

On Saturday April 04, 2015, Detective Nathan BUTZ conducted a mirandized interview of BRAYLOCK. During the interview BRAYLOCK stated that he was a patron inside Notte Nite Lounge on the night of the incident. BRAYLOCK stated that he was in the tavern with his brother Jihad S. Williamson, M/B, 03/24/94, and his brother's friend "Brandon". BRAYLOCK stated that the tavern was very busy and while inside he bumped into another subject, who punched him in the face and a fight started. BRAYLOCK stated that security surrounded them and escorted everyone outside. BRAYLOCK stated that once outside the tavern he observed the group of subjects that he was involved in the fight with. BRAYLOCK stated that the subjects started coming towards him so he went to his vehicle and retrieved a firearm from the glove box, which he subsequently used to shoot Stephen J. ROE, m/b, 01/26/71, once in the right tricep.

ROE was conveyed to Froedtert hospital by Bell 417 and admitted at 1:32am with DR. Jacob Peterson as the admitting physician.

# April 4, 2015 Shooting (IR# 150940015)

On Saturday, April 4, 2015 at approximately 1:00am a shooting occurred at 2627 West Capitol Drive. The victim's in the shooting were identified as Lexus D Evans (B/M 7/10/92) and Branden C Crawley (B/M 11-5-92). Evans stated that he was at Notte Nite Lounge with Crawley and Jamel L Braylock (B/M 2/28/92). Braylock and Jihad Williamson (B/M 3/24/94) who was the suspect in the shooting of Notte Nite Lounge security officer Steven J Roe (B/M 1/26/71)

Evans stated that there was a bar fight between Braylock and several other patrons at Notte. Evans stated that they all got involved in the fight because several people were jumping on Braylock. Evans stated that they were all removed from the establishment.

Crawley stated that they were at Notte Nite Lounge, prior to them going to the gas station located on W Capitol Drive and N 27<sup>th</sup> Street

Williamson is Braylock's brother.

On Saturday, April 5, 2015 at approximately 1:15am PO Donald KRENZIEN spoke to Donny Safina who is the General Manager of Notte and Tutto, Safina told me that Notte staff has decided to close Notte on Fridays and just operate as the restaurant until further notice. Safina also stated that they are going to look into changes for Saturday nights. Safina stated that when the club reopens on Friday nights they will look into changing music played and other changes marketed towards a different cliental. Safina also stated that he was looking into expanding Tutto's restaurant into the second floor.

## April 4, 2015 Substantial Battery IR#150940027

On Saturday, April 04, 2015 my partner PO Donald KRENZIEN and I were on a code red "Responsible Entertainment District Deployment" on N. Old World 3<sup>rd</sup> St to monitor taverns and crowds.

At approximately 12:35am, PO KRENZIEN, SGT. HONZELKA, and I were flagged down for a battery complaint in front of 1007 N. Old World 3rd St. The victim was later identified as Andrew C. SMITH, M/B, 12/08/88. SMITH had laceration above his left eye that was bleeding profusely. PO Austin LLANAS, squad 1340 took over the investigation.

On April 4, 2015 Detective Eric DRAGER spoke with SMITH regarding the substantial battery, due to the incident occurring in the same area and around the same time that a shooting occurred IR#150940012. SMITH stated that he was a patron inside Notte Nite Lounge on the night of the incident. SMITH stated that he left the tavern after a large fight broke out inside the tavern. SMITH stated that after he exited the tavern he was walking back to his vehicle when he was approached by 3 B/M subjects who jumped him in the alley between N. Old World 3<sup>rd</sup> St and N. 4<sup>th</sup> St. SMITH stated that he was struck in the face by one of the suspects, which caused his glasses to break and the laceration above his left eye. SMITH stated that the suspects then chased him east up the private alley, which is adjacent to Notte Nite Lounge and located on the south side of the tavern. SMITH stated that he flagged down a security guard that works for the tavern and pointed out the subjects that were chasing him. SMITH stated that the security guard started walking down the alley towards the suspects. SMITH stated that he then flagged down MPD officer's who in regards to the incident, at which time he heard a single gunshot come from the alley. SMITH was taken to Froedtert hospital where he was admitted at 1:26am and treated by DR. Matt TEWS. SMITH received 3-4 stitches to close his laceration.

Prior to the shooting Sgt Honzelka, PO KRENZIEN and I assisted Notte security disperse several subjects that were removed from Notte. One group of the subjects left northbound on Old World 3<sup>rd</sup> St, while the other group dispersed southbound on Old World 3<sup>rd</sup> Street.

As I have long suspected would happen, there was a shooting last night directly outside my home and directly related to Tutto Restrumnt/Nette Nite Lounge, 1633 N. Old World 3rd Supet. Numerous neighborhood meetings, sit-down conversations with "interested" parties and other attempts at unicable resolution of appeared complaints have proven to be finite efforts.

Please consider this a formal complaint against the business and a request for a hearing when the license for this address is next up for renown).

Inst night. I have provided video of other incidents following the shooting to the IMilwankee Police Department and will be posting them, along with videos documenting the activities of preceding weeks, later this weekend.

This business has been given ample opportunity to rectify its behavior but has failed on all accounts. Further, a cursory glance of Tutto's business plan, included in their license application, includes a number of glaring omissions:

1) There is no mention anywhere in the plan of a nightchib being included in the premises

2) The hours of operation listed in the application do not represent the actual hours of operation (an argument which was used to close another establishment on the block)

3) The license clearly states that no promoters will be used as part of the operation, and a simple internet search reveals that there are several "promoters" who put on events at the nightclub.

Under the "Grounds for non-renewal" or "grounds for suspension or revocation" headings on the city of Milwankee's treern license website, this establishment is in blatant violation of the following parameters:

#### Grounds for Non-Renewal

· Failuré of the licenset to apparais the premise in accordance with the floor plan and stan of operation submitted to the Gity as part of his of Developes application.
