- 1. Your complainant is Manager of the License Division and in the capacity of Manager of the License Division has access to records and files of the City Clerk kept in the routine and ordinary course of business regarding the issuance of Class "A" Malt licenses in and for the City of Milwaukee. Unless otherwise stated, your complainant makes this compliant on personal knowledge and information or personal information kept in the ordinary conduct of business of the City of Milwaukee and records thereof, which are under your complainant's care, custody and control.
- 2. On January 20, 2006, Lackwinder Singh as agent for "Sandeep, Inc." made application for a transfer of a Class "A" Malt license for "Valentine Foods" 2101 West Auer Avenue to 2301 West Hopkins Street in the City and County of Milwaukee, Wisconsin. On January 30, 2006, Lackwinder Singh, as agent for "Sandeep, Inc." amended the

aforementioned application to transfer the license from 2101 West Auer Street to 2303 West Hopkins Street in the City and County of Milwaukee, Wisconsin. Annexed hereto and incorporated herein by reference as **Exhibit 1**, is a true and correct copy of the transfer application dated January 17, 2006 and filed January 20, 2006. Annexed hereto and incorporated herein by reference as **Exhibit 2** is at true and correct copy of the January 30, 2006 amendment.

- 3. On May 3, 2005, the Milwaukee Common Council denied a Class "A" Malt license for the location of 2301 West Hopkins Street in the City and County of Milwaukee, Wisconsin for concentration. Annexed hereto and incorporated herein by reference as Exhibit 3, is a true and correct copy of the records of the License Division memorializing the May 3, 2005 denial.
- 4. Complainant is informed and verily believes that the address of 2301 West Hopkins Street and 2303 West Hopkins Street in the City and County of Milwaukee, Wisconsin is in a single building is being extensively remodeled and as a practical matter constitutes a single premises, the address of one entrance of which has been declared to be concentrated.
- 5. Under the provisions of § 90-11-3 of the Milwaukee Code of Ordinances (MCO) no new application can be granted by the Milwaukee Common Council at 2301 West Hopkins Street in the City and County of Milwaukee, Wisconsin without the demonstration of a changed of circumstances until May 3, 2008.
- 6. On February 28, 2006, the Milwaukee Common Council approved the transfer of the Class "A" Malt license of Lackwinder Singh as agent for "Sandeep, Inc." for the premises at 2303 West Hopkins Street in the City and County of Milwaukee, Wisconsin
